We have performed audits of the financial statements of MPC Enterprises, Inc. Employee 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1 – Description of Plan**

The following description of the MPC Enterprises, Inc. Employee 401(k) Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of MPC Enterprises, Inc. and Crossroads Express, Inc. (Company) who are age eighteen. Employees must work one year and 1,000 hours to be eligible for the plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to the maximum percentage allowable under the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes a 3% safe harbor profit sharing contribution to all eligible employees in the Plan. Additional profit share amounts may be contributed at the discretion of the Company's Board of Directors and allocated to participants based on eligible compensation. For the year ended December 31, 2024, the discretionary profit-sharing contribution was zero. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's safe harbor contributions and allocations of (a) the Company's profit share contributions and (b) Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows each participant to choose his or her own investment mix for Company and participant contributions. Participants can change their investment elections at any time.

Vesting

Participants are immediately vested in their voluntary contributions and Company safe harbor contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service.

Payments of Benefits

Upon retirement, participants receive the amount credited to their accounts. A similar benefit is paid upon disability or death. In the event of termination of employment, the participant will receive the vested balance of his or her account. Benefits are paid to participants or their beneficiaries in a lump sum or in installments.

Notes Receivable from Participants

The Plan allows a participant or his/her beneficiary to borrow up to 50% of the vested account balance, with the minimum loan allowed being \$1,000. Principal residence loans must be repaid within fifteen years with an interest rate equal to Wall Street Journal prime rate plus 2%, while loans for any other purpose are due within five years with the same interest rate. The loans are secured by the balances in the participants' accounts and bear interest at rates ranging from 5.25% to 10.50%. Principal and interest is paid ratably through scheduled payroll deductions.

Forfeited Accounts

As of December 31, 2024, and 2023, the forfeited nonvested account total was zero. This account is used to pay administrative fees and reduce employer contributions. For the year ended December 31, 2024, the forfeited nonvested account paid administrative expenses of \$1,264.

**Note 2 – Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction. See Note 6 for discussion on fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. The Plan administrator monitors delinquent loans in order to estimate the allowance for credit loss. As of December 31, 2024, and 2023, the allowance for credit loss is zero. If a participant ceases to make loan repayments and the Plan administrator deems the participant loans to be in default, the participant loan balance is reduced and a benefit payment is recorded. As of December 31, 2024, the Plan did not have any delinquent notes receivable from participants.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment and Plan administration fees are allocated to participants' accounts or offset against the unallocated forfeiture account.

Subsequent Events

The Plan Administrator performed an evaluation of subsequent events through October 2, 2025 which is the date the financial statements were available to be issued. There are no subsequent events that require disclosure or recognition in the financial statements as of year end.

**Note 4 – Investment Contract with Insurance Company**

The Plan maintains an investment contract with Principal Life Insurance Company (PLIC), an affiliate of Principal. The PLIC Annuity Contract is a segregated investment account maintained by PLIC with respect to a portion of its assets in connection with this contract and certain other group annuity contracts.

Assets of this variable account equivalent to the reserve for this contract will be invested in shares of the specific funds elected in the contract application. The assets of the variable account will be held for the sole benefit of all contracts. All income, gains, losses, and expenses, whether or not realized from assets held in the variable account for each series, shall be credited to or charged against the variable account series without regard to the other income, gains, or losses of PLIC. Assets of the variable account may not be used by PLIC to satisfy the liabilities of its general account.

**Note 5 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**Note 6 – Fair Value Measurements**

Professional Standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Professional Standards are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets
- quoted prices for identical or similar assets and liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts and Collective Investment Trust pooled funds:* The values are based on the net asset value (NAV) of the separate account, trust or fund, where the unit value is the result of the accumulated fair values of the underlying investments. The NAV, as provided by the fund manager, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the NAV. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of December 31, 2024 and 2023, the Plan did not have any unfunded commitments with any of the above pooled funds. Furthermore, the above pooled funds' redemption frequency is daily without any redemption notice period.

**Note 7 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in Company contributions.

**Note 8 – Tax Status and Plan Amendments**

The Plan is a non-standardized defined contribution prototype plan sponsored by Principal Trust Company. The prototype plan has received a letter from the Internal Revenue Service as to its qualified status. The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

The Plan has been amended since receiving the opinion letter. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Professional standards require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it has open tax years for the three years prior to December 31, 2024.

**Note 9 – Related Party Transactions and Party-in-Interest**

Certain Plan investments include separate accounts of PLIC and CIT managed by an affiliate to Principal, the trustee, as defined by the Plan; therefore, these transactions qualify as party-in-interest. Fees totaling \$51,845 were paid by the Plan to PLIC for plan administration and investment trustee services for the year ended December 31, 2024.
