We have performed an audit of the financial statements of Tax Sheltered Annuity Plan for Employees of Northern Maine Medical Center to include Forest Hill and Valley Medical Association (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of Plan

The following description of the Tax Sheltered Annuity Plan for Employees of Northern Maine Medical Center to Include Forest Hill and Valley Medical Association (the Plan) provides only general information. Participants should refer to the Plan provisions for more information.

General

The Plan is a tax-exempt, defined contribution plan sponsored by Northern Maine Medical Center (NMMC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers all employees of NMMC (including Forest Hill Manor) and its subsidiary, Valley Medical Association.

Eligibility

The Plan is available to all employees. There is no minimum age or service requirement to participate in the employee elective deferral contribution portion of the Plan.

Full-time employees become eligible to receive discretionary contributions upon the attainment of age 21 and after completion of the earlier of their probationary period or 1,000 hours of service. Casual and part-time employees become eligible to receive employer discretionary contributions upon the attainment of age 21 and completion of one year of service. Per diem and temporary employees are not eligible to receive employer discretionary contributions.

Vesting

Employees immediately vest on their deferrals; employer contributions and earnings thereon vest based on a six-year graded schedule.

Contributions

Participants may elect to defer up to the maximum percentage of compensation and dollar amount permissible under the Internal Revenue Code (the Code).

NMMC may make a discretionary matching contribution of 50% of employee deferrals up to 6% of eligible compensation with a maximum match of 3%.

Forfeited Accounts

There were no forfeited non-vested accounts at December 31, 2024 or 2023. Forfeited balances of terminated participants will be used to reduce future employer contributions and Plan expenses. During the year ended December 31, 2024, \$44,418 of forfeitures were used to fund employer contributions and pay Plan expenses.

Participant Accounts

Upon enrollment in the Plan, a participant may direct his or her account balance among the various investments offered by the Plan. The Plan currently offers investments in shares of mutual funds, variable annuities, and fixed income contracts.

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's and employer's contributions and an allocation of investment income, and charged with an allocation of the investment losses, certain administrative expenses and any distributions. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Payments of Benefits

Participants shall become eligible to receive their vested account balances upon retirement (normal retirement age is 65), death, disability, or termination. Participants may withdraw their account balances upon attaining age 59½. Participants may receive their benefit payments in a single lump-sum payment or a monthly annuity. In addition, participants may withdraw their pretax contributions upon demonstration to the plan administrator that they are suffering a hardship, as defined in the Code.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participant loans range from one to five years or up to fifteen years for the purchase of a primary residence. The notes receivable are secured by the balance in the participant's account and bear interest at rates commensurate with current market interest rates.

Administrative Expenses

NMMC is responsible for certain administrative costs of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Plan investments are recorded at their fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements.

The investment contracts are reported at contract value because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes both realized and unrealized gains and losses on investments purchased and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

For purposes of the preparation of these financial statements in conformity with U.S. GAAP, management has considered transactions or events occurring through October 10, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Benefit-Responsive Investment Contracts

The Plan has entered into benefit-responsive investment contracts with Lincoln Financial Group (Lincoln). Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Lincoln fixed annuity investment options guarantee participant's principal and a minimum interest rate. The crediting interest rate is based on a formula agreed-upon with the issuer. Lincoln, however, may credit the account with a higher rate of interest that is not guaranteed. Interest rates are set annually and guaranteed for one year. Funds in the Lincoln annuity account are maintained in a general account. The crediting interest rate is based on a formula agreed-upon with the issuer and guarantees a rate of no less than 4.5% which is guaranteed for five years.

The Lincoln stable value account funds are maintained in a separate account. The account is credited with participant contributions plus earnings and charges for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Such interest rates are reviewed and may be reset on a quarterly basis, rates were 2.2% during the first half of 2024 and increased to 2.3% during the second half of 2024.

Certain events limit the ability of the Plan to transact at contract value with the insurance company and the financial institution issuer under the group annuity contract and the stable value account. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures, or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value is probable.

4. Income Tax Status

The Plan utilizes a volume submitter plan document. The Internal Revenue Service has determined and informed Lincoln Retirement Services Company LLC by letter dated March 31, 2017, that its volume submitter plan document is designed in accordance with Section 403(b) of the Code and the regulations issued thereunder. The plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

5. Information Prepared and Certified by Custodians

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants, interest on notes receivable from participants and interest and dividends were obtained by management and agreed to or derived from the information certified by Lincoln Financial Group Trust Company, Inc. and Lincoln National Life Insurance Company (collectively Lincoln), the custodians, as complete and accurate. This information is included in the following:

6. Parties-In-Interest Transactions

Certain Plan investments are in insurance contracts and shares of mutual funds and variable annuities managed by Lincoln, the custodians of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid to Lincoln were \$66,298 for the year ended December 31, 2024. Additional fees of \$23,250 were paid to investment advisors. Notes receivable from participants are also considered parties-in-interest transactions.

7. Plan Termination

Although it has not expressed any intent to do so, NMMC has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balance and the amounts reported in the statements of net assets available for benefits.

9. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

Mutual funds: Valued at the quoted net asset value of units of underlying funds held by the Plan at year-end which are traded in an active market.
