Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

The supplemental schedule, Schedule of Assets Held at End of Year, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the

financial statements. The information included in the supplemental schedule, other than the agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 –Summary of Significant Accounting Policies

The significant accounting policies followed by the Plan are summarized below.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The Plan administrator uses estimates and assumptions in preparing financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosures of contingent assets and liabilities, and the reported additions to and deductions from net assets. Actual results could vary from the estimates that were assumed in preparing the financial statements.

Investments Valuation and Income Recognition

Mutual Funds are valued at fair value based on the net asset values as provided by Nationwide utilizing quoted market prices of the underlying funds on the last business day of the Plan year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Investments in insurance contracts are stated at contract value.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan's management has evaluated the financial statements for subsequent events occurring through September 24, 2025, the date the financial statements were available to be issued.

Note 2 – Description of Plan

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a profit-sharing plan and trust covering all eligible employees of Repucare, Inc. (the Company). The Plan was established on January 1, 2009, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan was restated September 27, 2021. The Plan is a profit-sharing plan and trust, which qualifies under Section 401(k) of the Internal Revenue Code of 1986. The Plan provides for retirement, disability, and death benefits for eligible, participating employees.

Administration

The Plan is sponsored by the Company and is administered by Nationwide's Group Retirement Series. The Plan entered a contract with Nationwide, the custodian of the Plan, during 2018 to hold the Plan's investment assets and execute investment transactions.

Eligibility

Employees who have attained the age of 21 and have completed two months of service are eligible to participate with regard to elective deferral and Roth contributions, and six months of service for employer matching contributions, and profit-sharing contributions.

Contributions

Employees may contribute a specified percentage or amount of pretax or Roth elective annual compensation subject to certain limitations and as allowed under Section 401(k) of the Internal Revenue Code. Additional "catch-up" contributions can be made by employees who are age 50 years or older subject to certain limitations and as allowed under Section 401(k) of the Internal Revenue Code. The Company may decide to make a matching contribution of employee salary deferrals, which is determined by the Company each year. Additionally, the Company may make annual discretionary profit-sharing contributions in an amount to be determined at the Plan's year-end.

Forfeited Accounts

Forfeitures will occur as of the earlier of (1) the last day of the plan year in which the former participant incurs five consecutive one year breaks in service or (2) the distribution of the entire

vested portion of the participant's account. Forfeited amounts may be used to pay any administrative expenses, allocated to reduce the Company's matching contribution, or allocated to the remaining participant accounts.

The balance in the forfeitures account as of December 31, 2024 and 2023 was \$14,103 and \$11,409, respectively. During the years ended December 31, 2024 and 2023, forfeitures of \$11,432 and \$0, respectively were used to reduce the Plan's expenses and employer's matching contributions.

Hardship Distributions

Participants may withdraw money on account of financial hardship if certain conditions are met. Hardship distributions are not allowed from qualified non-elective or qualified matching contribution accounts.

Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus two percent, as determined by the monthly payroll deductions. Participant loans are valued at their unpaid principal balance plus any accrued but unpaid interest.

Payment of Benefits

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Upon termination of employment, death, disability, or normal retirement (age 65), a participant (or designated beneficiary) can receive 100% lump sum, partial, or installment payments of the vested account balance. In-service withdrawals by participants that have attained age 59 ½ from the vested account balance are also permitted. A participant may also withdraw any amount from his/her rollover account once a year. Benefits are recorded when paid. Loans are permitted up to 50% of a participant's vested balance.

Investment Options

The Plan provides many investment options ranging from aggressive to conservative investments. Participants may elect to have their elective deferral contribution invested in any fund or combination of investment funds provided by the Plan. The employer matching contribution is allocated to the investment funds in the same ratio as the employee elective deferral contributions. Participants may change their investment options at any time.

Participant Accounts

Each participant's account is credited for his or her contributions on a cash basis when received. In addition, each participant's account is credited with an allocation of the Company's matching contribution and investment earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferral contribution and any safe harbor employer contributions. Participant vesting percentage for matching, non-elective employer contributions, and profit-sharing contributions are determined based on vesting years of service. To earn a year of service, employees must be credited with at least 1,000 hours of service during the plan year. Employer matching contributions and any earnings thereon, are vested in accordance with the following schedule. In addition, a participant is 100% vested upon the attainment of normal retirement age, total and permanent disability, or death.

Note 3 – Tax Status

The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 4 – Information Certified by the Plan’s Trustee (Unaudited)

Accordingly, as permitted under such election, the plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Nationwide Financial Services, the custodian of the plan, as of an for the years ended December 31, 2024 and 2023, except for comparing information certified by the trustee to information included in the Plan’s financial statements and supplemental Schedule H, line 4i-Schedule of Assets Held at End of Year.

Note 5 - Fair Value Measurements

The Plan has categorized its assets that are measured at fair value based on a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to valuation methodologies include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds – Valued at unit value (net asset value) of shares held by the Plan at year end. (Level 1)

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 – Investment Contracts with Insurance Company

The Plan invests in investment contracts through an insurance contract with Nationwide Life Insurance Company. The account is credited with the actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is fully-benefit responsive and is included in the financial statements at contract value, which approximates fair value.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts. These contracts are included in the financial statements at contract value, as reported to the Plan by Nationwide Life Insurance Company. The contract value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed fund at any time will be equal to the total of the deposits credited, amounts exchanged, plus interest and less withdrawals. For the year ended December 31, 2024 and 2023, 1.91% and 2.27% were the contract crediting rate, respectively.

Note 7 – Party-In-Interest Transactions

Certain plan investments were managed by Nationwide. Nationwide acted as the custodian as defined by the Plan and, therefore, these investments and investment transactions qualify as exempt party-in-interest transactions. Plan audit and accounting fees are paid by the Employer/Plan Sponsor. Certain administrative functions are performed by officers and employees of the Plan Sponsor. These employees are also Plan participants. No such officers or employees received compensation from the Plan.
