The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 2.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Emphasis of Matter—Plan Merger

As discussed in Note 7 to the financial statements, the Board of Directors of Hand Family Companies, LLC, the Plan's Sponsor, voted on August 16, 2024, to merge the Lakeshore Beverage 401(k) Plan into the Hand Family Companies, LLC 401(k) Retirement Plan effective December 1, 2024. All plan assets were transferred to the Hand Family Companies, LLC 401(k) Retirement Plan on or before December 3, 2024, although legal responsibility was transferred on December 1, 2024. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule (modified cash basis), Schedule H, line 4i—schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule (modified cash basis), other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule (modified cash basis) that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule (modified cash basis), we evaluated whether the supplemental schedule (modified cash basis), other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule (modified cash basis), other than the information in the supplemental schedule (modified cash basis) that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule (modified cash basis) related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

Note 1. Plan Description

The following description of Hand Family Companies, LLC 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established on April 1, 1977, and maintained for the benefit of eligible nonunion employees of Hand Family Companies, LLC and Affiliates. As of December 31, 2024, the Plan was most recently amended, restated and effective December 1, 2024, to include the eligible employees of CITY Beverage-Illinois, L.L.C., dba Lakeshore Beverage, a related party of Hand Family Companies, LLC through common ownership. Employees of BountyBev, LLC, a related party of Hand Family Companies, LLC through common ownership, were eligible for the Plan until February 29, 2024, when the Company sold BountyBev, LLC pursuant to an asset purchase agreement. Following the transaction, BountyBev, LLC participants are no longer eligible to participate in the Plan. Hand Family Companies, LLC, CITY Beverage-Illinois, L.L.C. and BountyBev, LLC are referred to collectively herein as the Sponsor or Company.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company is the custodian and trustee, for the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

Eligibility: Eligible employees for elective salary deferral, employer matching and nonelective employer contributions are all nonunion employees who are 21 years of age or older and have completed six months of service with the Company, and the Plan provides that these eligible employees enter the Plan on the first of every month, coincident with or next following satisfaction of the eligibility requirements.

The Plan's investments are 100% participant directed.

Contributions: The Plan provides for the following contributions which are to be maintained in separate accounts for each participant:

Elective salary deferral contributions: Elective salary deferral contributions are allowed up to the statutory limit provided by Section 402(g) of the Internal Revenue Code (IRC) as in effect at the beginning of the taxable year. Contributions cannot exceed statutory limits. The Plan allows for catch-up contributions for participants who are age 50 and older. The Plan also allows participants to make after-tax Roth 401(k) contributions.

Employer matching contributions: The amount to be contributed by the Sponsor is at the discretion of the Sponsor and for the year ended December 31, 2024, was 100% of an employee's deferral up to 3% of compensation.

Nonelective employer contributions: The Sponsor may, but is not required to, make contributions at the discretion of the Sponsor. No nonelective employer contributions have been made.

Rollover contributions: The Plan provides for rollover contributions to be made by the employee from amounts distributed or transferred from other qualified deferred compensation plans.

Note 1. Plan Description (Continued)

Participant accounts: Each participant's account is credited with the participant's contributions, and allocations of the Company's matching and nonelective contributions, if any, and allocations of plan earnings/losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant account balances or compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants' contributions are credited to their respective accounts, as directed, as soon as practicable, after receipt. Investment income is allocated daily.

Participant investment options: Upon enrollment in the Plan, a participant directs their account balances to be invested in selected funds as made available and determined by the Sponsor. Participants are allowed to change their investment options on a daily basis.

Vesting: Participants are immediately vested in their employee-directed salary deferral and rollover contributions and earnings thereon. Vesting of Company matching and nonelective contributions and related earnings and allocated forfeitures is based on years of service (with 20% vesting for each year of service).

Payment of benefits: If the participant terminates service due to death, disability or retirement, a participant may elect to receive the amount equal to the value of the participant's vested interest in their accounts in either a lump-sum cash distribution or in installment payments. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. For vested account balances exceeding \$5,000 the participant may elect to postpone their distribution until the required distribution age, or if the account balance is less than \$5,000 the benefit payment will be made regardless of whether the participant consents to receive it in the form of a lump sum. In addition, participants who have attained the age of 59½ have the right to an in-service withdrawal for all or a portion of the salary deferrals. Distributions of rollover contributions may be taken at any time. Upon the later of a participant's attainment of the age of 70½ or separation from service, minimum required distributions must be taken. As of December 31, 2024 and 2023, there were no amounts due to terminated participants who have requested distribution or rollover of their account balances.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, subject to other restrictions provided by the plan agreement. A participant may not have more than one note outstanding at any given time. Notes receivable from participants are made in accordance with the Plan's provisions and ERISA regulations whereby interest is calculated and allocated to the individual participant. Notes are repayable over a period ranging from one to five years through employee payroll deductions, unless it is for the purchase of a primary residence, for which the term will not exceed 25 years from the date of the loan. The Plan Administrator will treat a loan as in default if any scheduled payment remains unpaid beyond the last day of the calendar quarter following the calendar quarter in which the participant missed the scheduled payment. As of December 31, 2024 and 2023, there were not any loans in default. The notes are secured by the balance in the participant's account and bear interest at a rate of interest as determined by the Plan Administrator, based on the prevailing interest rates at the time the note was funded. The interest rate on the notes outstanding at December 31, 2024, ranges from 5.25% to 10.50%.

Note 2. Significant Accounting Policies

Forfeitures: Participants are automatically fully vested upon normal retirement, death or permanent disability. In the event of termination of employment before full vesting, the nonvested portion is immediately forfeited. The amount of the participant's account forfeited will be reinstated provided the participant resumes employment prior to incurring a break in service, as defined in the plan agreement. Amounts forfeited during the year will be used first to pay plan expenses and then used to reduce future employer contributions. At December 31, 2024 and 2023, forfeited nonvested amounts were approximately \$21,800 and \$12,200, respectively. During 2024, approximately \$21,800 was forfeited into the Plan, approximately \$5,000 of forfeitures were transferred in as part of the plan merger (see Note 7), and approximately \$17,200 of forfeitures were used to reduce employer matching contributions.

Basis of accounting: The financial statements of the Plan have been prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America (U.S. GAAP). That basis differs from U.S. GAAP in that investment income (other than changes in fair value of investments) and contributions are recognized when received rather than when earned and administrative expenses are recognized when paid rather than when the expense is incurred.

Accounting estimates: The preparation of financial statements in accordance with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of investments: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Income recognition: Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the modified cash basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance. Interest is recorded when received. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses have been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Subsequent events: The Plan Administrator has evaluated subsequent events for potential recognition and disclosure through October 9, 2025, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Interest in common/collective trust: Valued based on the net asset value (NAV) of units of the common/collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Shares of registered investment companies: Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the period.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 5. Related-Party Transactions

The Company pays certain administrative expenses of the Plan. In addition, certain administrative functions are performed by employees of the Sponsor for which no compensation is received from the Plan.

Administrative expenses paid by the Plan to Principal Life Insurance Company, affiliate of the trustee, party-in-interest and contract administrator, amounted to \$59,729 for the year ended December 31, 2024. Administrative expenses paid by the Plan to Stifel, Nicolaus & Company, Inc., investment advisor and party-in-interest, was \$47,948 for the year ended December 31, 2024.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. All assets remaining in the trust, after deducting all fees, taxes and other expenses, shall be distributed to the participants in accordance with the value of their accounts at the date of plan termination. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7. Plan Merger

On August 16, 2024, the Board of Directors of the Sponsor voted to merge the Lakeshore Beverage 401(k) Plan into the Plan effective December 1, 2024, which is the date the Plan assumed control and responsibility for the Lakeshore Beverage 401(k) Plan's assets and liabilities. As a result, net assets of \$30,957,141 were transferred to the Plan on or before December 3, 2024.

Note 8. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
