## **Independent Auditor's Report**

To the Participants and Plan Administrator

### ***Opinion***

We have audited the accompanying financial statements of Johnson Controls, Inc. Employment Transition Benefits Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise of the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Johnson Controls Employment Transition Benefits Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Johnson Controls, Inc. Employment Transition Benefits Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

## Notes to the Financial Statements

---

### **Note 1: Description of Plan**

Johnson Controls, Inc. (the Company) adopted the Johnson Controls Employment Transition Benefits Plan (the Plan) effective as of October 1, 2018. The Plan was adopted for the purpose of providing periodic unemployment benefits to eligible employees of Johnson Controls, Inc. and its subsidiaries, affiliates or divisions (collectively the Affiliates) who are involuntarily separated from service and who will experience a loss of future earnings. Johnson Controls, Inc. is the Plan sponsor. The Plan allows the payment of Plan benefits based on objective benefit formulas that vary between the Company and its adopting subsidiaries, affiliates, or divisions. The Plan is designed to supplement an employee's receipt of unemployment benefits and to operate as a supplemental unemployment benefits pay plan. Selected plan provisions are described below. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### **Benefit payments**

Benefit payments are recorded when paid.

### **Note 3: Funding and Operation of the Plan**

#### **Funding of the Plan**

Contributions are funded by the Affiliates, pursuant to the Plan and are held in the Johnson Controls Employment Transition Benefits Trust (the Trust). The Trust is funded on an as needed basis, through a zero balance checking account.

Transition benefits of the Plan are paid by the Trust. The Company may, in its discretion, decide to convert the Plan into an unfunded Plan. In that event, benefits would be funded and paid out of the Company's operating funds; provided, however, no benefits would be paid under the Plan if the operating funds made available by the Company for this purpose are exhausted or if the Company declines to make funds available for this purpose.

#### **Plan Expenses**

The Company bears all administrative costs of the Plan, except certain bank charges.

### Note 3: Funding and Operation of the Plan (Continued)

#### Administration

Johnson Controls Employee Benefit Policy Committee serves as plan administrator. The Investment Committee acts in the capacity of plan fiduciary.

#### Benefits Under the Plan

The Plan allows the payment of Plan benefits based on objective benefit formulas that vary between the Company and its adopting subsidiaries, affiliates, or divisions. The Plan provides for the payment of weekly, semi-monthly, or monthly supplemental unemployment benefits. The Company and its adopting subsidiaries, affiliates, or divisions may adopt any benefit formula that is deemed reasonable under objective standards, including payment of installment benefits in a manner other than weekly, semi-monthly or monthly benefits; provided, however, that any such payments must be made on regular and stated intervals. The benefits, when added to the participant's unemployment benefits received including compensation otherwise allowable under state laws, cannot exceed the participant's respective weekly, semi-monthly or monthly regular wages for the last full payroll period immediately preceding the participant's involuntary termination. The benefits payable are reduced by applicable federal and state income tax withholding and any other amounts required by law, as well as by any outstanding advances, loans, debts or other amounts owed to an employer or Company or for which an employer or Company could be liable, including payments made for vacation taken but not earned. The supplemental unemployment benefits may also be reduced by any pre-tax or after-tax payroll deductions to which the participant consents or otherwise directs the Johnson Controls Employee Benefit Policy Committee.

#### The Company's Obligations Under the Plan

The Company funds the Plan on an as needed basis by requiring the Affiliate to make contributions sufficient to fund benefits as they become payable.

### **Note 4: Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter that the Plan and related trust are designed in accordance with applicable requirements of the Internal Revenue Code of 1986, as amended (the IRC). The Plan has been amended since receiving the determination letter. Plan management and Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

### **Note 5: Termination of the Plan**

Under certain conditions, the Plan may be terminated. Upon termination, the assets then remaining should be subject to the applicable provisions of the Plan then in effect and should be used until exhausted to pay benefits to employees in the order of their entitlement.

### **Note 6: Risks and Uncertainties**

Due to uncertainties inherent in the assumption process, it is at least reasonably possible that changes to these assumptions in the near term could be material to the financial statements.

### **Note 7: Subsequent Events**

Management has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued.
