### NOTE 1: DESCRIPTION OF PLAN

The following description of Ring Therapeutics, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined-contribution plan established on January 1, 2018, to provide retirement and other related benefits to all employees of Ring Therapeutics, Inc. (the “Company”). Prior to September 3, 2024, an employee who is of age 21 or older becomes eligible to participate for purposes of salary reduction contributions after two months of service. Effective September 3, 2024, only one month of service is required. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions and Allocations:** Each year, participants may contribute an amount up to 90% of their pretax annual compensation, as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions as prescribed by Treasury regulations. Participants, with the consent of the Plan Administrator, may deposit amounts received from any other retirement plan which satisfy the tax rules for rollovers. Prior to September 3, 2024, unless instructed otherwise by the participant, upon becoming eligible to participate in the Plan, 4% (6% as of September 3, 2024) of the participant’s eligible compensation will be contributed to the Plan subject to annual limits set by the Internal Revenue Service (“IRS”).

Participants may designate a portion, or all, of their deferred contributions as Roth contributions, which are includable in the participant’s gross income.

Prior to September 3, 2024, the Company could make a discretionary matching contribution to the Plan each year. Beginning on September 3, 2024, the Plan does not allow for Company matching contributions. For the year ended December 31, 2024, the Company did not make a discretionary matching contribution. The Company may also make a discretionary non-elective contribution to the Plan. For the year ended December 31, 2024, the Company made non-elective contributions to the Plan totaling \$1,491.

**Participant Accounts:** Each participant’s account is credited with the participant’s contributions, Company matching contributions, and Plan earnings or losses and charged with an allocation of administrative expenses, if any. Allocations of participant earnings (losses) are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

**Investment Options:** Participants direct the investment of contributions into various investment options offered by the Plan.

**Vesting:** Participants are immediately vested in their voluntary contributions, employer contributions and any actual earnings thereon. Prior to September 3, 2024, Company contributions vested over a six-year period. Effective September 3, 2024, all employee and employer contributions are immediately 100% vested.

### NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

**Forfeited accounts:** At December 31, 2024 and 2023, forfeited non-vested account totaled \$1,467 and \$0, respectively. These accounts will be used to reduce future employer contributions.

**Notes Receivable from Participants:** Participants may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes receivable fund. Notes receivable terms cannot exceed five years unless for the purchase of a primary residence, which cannot exceed thirty years. Loans are secured by the balances in the participants' accounts and are supported by a promissory note. Prior to September 3, 2024, loans bore interest at rates based on the prevailing interest rates charged by persons in the business of lending money for loans that would be made under similar circumstances. Effective September 3, 2024, loans bear interest at 1% over the prime rate (8.50% during 2024). Principal and interest are paid ratably usually through semi-monthly payroll deductions. If the participant terminates employment or retires, the outstanding loan balance is due immediately unless the participant remains a party-in-interest. If the participant qualifies as a party-in-interest, the participant may continue to pay the loan after termination. Failure to repay will result in the loan being offset from the participant's account. The offset loan amount will be considered a taxable distribution to the participant. Participants can prepay an outstanding loan at any time without a penalty.

**Payment of Benefits:** On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or periodic installment distributions. If a participant terminates employment for any reason, his or her account becomes 100% distributable if below \$7,000.

A participant may also request a withdrawal upon attainment of age 59½, or upon demonstration by the participant to the Plan Administrator that the participant is suffering from a hardship, as defined in the Plan document. Hardship and partial withdrawals are subject to a minimum of \$500.

**Change in Trustees:** The Plan changed Trustees from Reliance Trust Company to Ascensus Trust Company and Newport Trust Company, LLC. The transfer of Plan assets was made on August 26, 2024, and received by the new Trustee on September 3, 2024. The conversion initiated a "Black Out" period which permitted the Trustee time to accurately complete the conversion. During this period, participants could not change their investment allocations, change deferral percentages, or withdraw any money from the Plan. The investments were transferred into similar funds within the participant's accounts.

### NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). The financial statements and supplementary schedule have been prepared to satisfy the reporting and disclosure requirements of ERISA.

#### NOTE 2: SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

**Use of Estimates:** The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Risks and Uncertainties:** The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

**Payment of Benefits:** Benefit payments to participants are recorded when paid.

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

**Administrative Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Uncertain Tax Positions:** GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

In 2024, the Company incurred a reduction in workforce and as a result, the Plan experienced a partial plan termination as defined by the internal revenue code (“IRC”) for the 2024 Plan year. Under the IRC, a partial plan termination may occur if at least 20% of eligible Plan participants are terminated by the Company within the applicable period. As a result of partial plan terminations, affected participants become 100% vested in their accounts. As participants were fully vested in all employer contributions, there was no impact to the affected participants.

**NOTE 4: TAX STATUS**

The IRS has determined in its opinion letter dated June 30, 2020, that the non-standardized prototype plan document of Automatic Data Processing, Inc, adopted by the Plan, constitutes a qualified trust under Section 401(a) of the IRC and is exempt from federal income taxes under provisions of Section 501(a). The Plan Administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

**NOTE 5: CERTIFICATION OF TRUSTEES**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, Ascensus Trust Company, and Newport Trust Company, LLC, the Trustees, certified that the following data included in the accompanying financial statements and supplemental schedule of assets (held at end of year) are complete and accurate.

#### NOTE 6: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

Level 2 - inputs other than quoted market prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs that are unobservable for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies used at December 31, 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust:* Valued at the net asset value of units of a collective trust. The net asset value, as provided by the fund manager, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
