We have performed audits of the financial statements of Fusion Medical Staffing LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### 1. Plan Description

---

The following brief description of the Fusion Medical Staffing LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Fusion Medical Staffing, LLC (the Company).

Employees are eligible to make pre-tax salary deferral contributions and after-tax Roth salary deferral contributions and to receive safe harbor matching contributions after attaining age 21 and completing one month of service. Eligible employees become participants on the first day following the date on which entry requirements are fulfilled.

#### ***Contributions***

Participants may make pre-tax and after-tax Roth salary deferral contributions up to 75% of eligible annual compensation. Participants may also contribute amounts representing distributions from other qualified plans. The Plan is a "Safe Harbor 401(k) Plan" whereby the Company is required to make safe harbor matching contributions equal to 100% of each participant's elective deferral, up to 3% of eligible compensation, plus 50% of the next 2% of eligible compensation. All participants who are eligible to make deferral contributions and who are projected to attain age 50 before the close of the calendar year are eligible to make catch-up contributions. Contributions are subject to certain limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and an allocation of a) the Company's safe harbor matching contributions, and b) Plan earnings and losses and is charged with an allocation of administrative expenses. The Company's safe harbor matching contributions are allocated among participants based upon each participant's elected salary deferral. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Effective September 1, 2024, investments are maintained in individual member accounts managed by Principal Trust Company (Principal) and Empower Annuity Insurance Company of America (Empower Insurance) (see Note 8). Prior to September 1, 2024, investments were maintained in individual member accounts managed by Empower Insurance and Empower Trust Company, LLC (Empower Trust).

#### ***Vesting***

Participants are vested immediately in their contributions and the Company's safe harbor matching contributions plus actual earnings thereon.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. The terms of the notes are limited to five years and all principal and interest payments must be made through payroll deductions.

### ***Payment of Benefits***

Upon retirement, termination, disability, or death, the participant or beneficiary may elect to receive either a lump sum or installment payments (only for those who are receiving required lifetime minimum distributions) equal to the value of the vested funds allocated to the participant's account. Participants are eligible to receive in-service distributions upon reaching the age of 59 1/2. Effective August 1, 2025, hardship withdrawals are allowed based on certain criteria. The Plan requires distribution payments between \$1,000 and \$7,000 (\$5,000, prior to April 1, 2024) to be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Benefit payments are recorded when paid.

## 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### ***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for further discussion of fair value measurements.

Fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transaction under the terms of the Plan. The Company invests in investment contracts through the Key Guaranteed Portfolio Accounts and the Principal Fixed Income Guaranteed Option.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of the Plan and other account activity are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### *Subsequent Events*

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 8, 2025. See the "Payment of Benefits" section of Note 1 for a description of a subsequent event.

### **3. Information Certified by Principal, Empower Insurance and Empower Trust**

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-5(c) of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Principal, Empower Insurance and Empower Trust, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies as of December 31, 2024 and 2023.

*Collective Trusts:* Collective trusts are valued at net asset value (NAV) based on the market value of their underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per share to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that these trusts meet those requirements. Participants can redeem the trusts at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024. The NAV is the basis for current transactions and the accounts can be redeemed at NAV as of the measurement date.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Investment Contract with Principal and Empower Insurance

The Plan has entered into an investment contract with Empower Insurance and, effective September 1, 2024, Principal, which maintain certain contributions in investment contracts. The contracts are credited with earnings on the underlying investments and charged for the Plan withdrawals and administrative expenses charged by Principal and Empower Insurance.

As the investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contracts. Contract value, as reported to the Plan by Principal and Empower Insurance, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due in accordance with fully benefit responsive contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic developments. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

### 6. Tax Status

---

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 7. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distributions to participants of the account balances would be made as soon as practicable after the termination date.

### 8. Related-Party Transactions

---

Certain Plan investments are investment contracts managed by Principal, Empower Insurance and Empower Trust. Principal, Empower Insurance and Empower Trust are the custodians of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

### 8. Change in Custodian to Principal

---

Effective September 1, 2024, the Plan named Principal the new custodian of the Plan. Plan assets transferred to Principal were transferred into funds comparable, where available, to those offered by Empower Trust. The conversion initiated a "blackout" period beginning August 22, 2024 and continued through September 15, 2024. During this period, funds could not be applied to the employee selected funds with Empower Trust or withdrawn from the Plan until Principal had time to accurately complete the conversion. During the period, employee contributions continued to be made through payroll deductions, and the contributions were wired to Principal and held in a trust account until the completion of the blackout period, at which time these funds were invested in funds comparable to those offered by Empower Trust.

As of December 31, 2024, Empower Insurance is still the custodian of assets totaling \$1,540,708 invested in the Key Guaranteed Portfolio Accounts.
