Note 1. Plan Description

Overview

The L.H. Carbide Profit Sharing & Salary Savings Plan (the "Plan") is a defined contribution plan covering employees of L.H. Carbide Corporation, L.H. Stamping Corporation, L.H. Industries, and L.H. Medical (collectively the "Company"). Employees who are 18 years of age and have completed 90 days of service are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The provisions of the Plan are included in the official Plan document which legally governs the operations of the Plan and are available for more detailed information.

Participant Contributions

Participants may make voluntary pre-tax or Roth contributions up to 100% of eligible compensation up to the statutory dollar limit established by the Internal Revenue Code. Participants are automatically enrolled at 3% of pre-tax annual compensation unless the participant elects not to participate or modifies the withholding percentage. The automatic deferral amount will be increased by 1% per year until a maximum of 8% is reached. This increase will occur on the first day of each calendar year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct their contributions into various investment options offered by the Plan. Participants may enter the Plan monthly and may change the amount of their contribution daily.

Company Contributions

The Company provided a matching contribution of 10% of each participant's elective deferrals for the year ended December 31, 2024. The Company may also make discretionary profit sharing contributions. The Company may make a discretionary matching contribution equal to a percentage of each participant's elective deferrals as determined each year by the Company. To be eligible for the Company profit sharing contributions, participants must be employed on the last day of the Plan year and must have completed 1,000 hours of service during the Plan year. The Company made no discretionary profit sharing contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution. Plan earnings are charged with an allocation of certain administrative expenses. Allocations of Plan earnings and administrative expenses are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants have the option of investing in a variety of investment options offered through Voya Institutional Trust Company ("Voya"). All amounts in participant accounts are participant-directed.

Note 1. Plan Description (Continued)

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and are limited to two outstanding loans at one time. The loans are secured by the balance in the participant's account and bear interest at a fixed rate commensurate with prevailing rates as determined by the Plan Administrator at time of origination (ranging from 3.25% to 8.50% at December 31, 2024). Loans outstanding at December 31, 2024 mature through 2051. Principal and interest are paid ratably through payroll deductions. The term of the loan cannot exceed five years unless the loan is for the purchase of a primary residence.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant becomes 20% vested after two years of credited service. Vesting percentages increase 20% each year thereafter with 100% vesting after six years of credited service.

Forfeitures

If a participant terminates employment before being fully vested, a portion of the Company contributions will be forfeited. Forfeitures are used to pay Plan expenses and reduce future Company contributions. At December 31, 2024 and 2023, there was \$1,463 and \$7,795, respectively, in the forfeiture account available to pay Plan expenses or reduce future Company contributions. Forfeitures of \$16,212 were used to pay plan expenses or reduce employer contributions for the year ended December 31, 2024.

Benefit Payments

Benefits under the Plan are payable when a participant retires, dies, or otherwise ceases to be an employee and are payable as a single lump-sum payment or direct rollover. In-service distributions from vested amounts may be made to a participant provided he or she has attained age 59 1/2. Hardship withdrawals are also allowed from the fully vested portion of a participant's account balance with certain restrictions, as outlined in the Plan document.

Termination of the Plan

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 2. Significant Accounting Policies

Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Note 2. Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales transactions are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and any adjustment for contract value.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Payments of benefits to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Management of the Plan has evaluated events and transactions for possible recognition or disclosure through October 8, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Plan's Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Voya Institutional Trust Company, the Trustee, and was not subjected to any auditing procedures performed by the independent public accountants.

- a. Total investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits.
- b. Investment earnings, as shown in the accompanying statement of changes in net assets available for benefits, including net realized and unrealized appreciation in fair value of investments, interest income from the guaranteed investment contract, other income and interest income on notes receivable from participants.
- c. Schedule of assets (held at end of year).

Note 4. Fair Value Measurements

The Plan utilizes the Fair Value Measurements framework which defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and establishes a hierarchy which prioritizes inputs to valuation techniques used to measure fair value into three broad levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts ("PSA"): Valued at net asset value ("NAV") at the end of the Plan year. PSA's are made up of a wide variety of underlying investments such as equities, preferred stock, bonds, real estate and mutual funds. The NAV is based on the value of the underlying assets owned by the PSA, minus any liabilities, and then divided by the number of shares outstanding. The NAV of a PSA is not a publicly quoted price in an active market, therefore, the NAV is used as a practical expedient to estimate fair value. The Plan's PSA investments have a daily redemption frequency, do not require a redemption notice period, and have no unfunded commitments as of December 31, 2024 and 2023, respectively.

Guaranteed investment contract: Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Investment Contracts with Insurance Company

The Plan holds a traditional investment contract with Voya Retirement Insurance and Annuity Company. The contract does not meet the fully benefit-responsive investment contract criteria and is therefore reported at fair value with an adjustment to contract value. Contract value is the relevant measure because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (1) premature termination of the contracts by the Plan, (2) plant closings, (3) layoffs, (4) Plan termination, (5) bankruptcy, and (6) early retirement incentives. Management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than the contract value.

Discontinuance of the contract would result in certain surrender charges as defined by the contract. Guaranteed crediting rates are based on a formula agreed upon with the insurance company. Such interest rates are reviewed quarterly for resetting. The crediting rate of the product will be established based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Principal and interest are guaranteed; however, there is no stated maturity date.

Note 6. Transactions with Parties-In-Interest

The Company provides certain accounting, recordkeeping, and administrative services to the Plan for which it receives no compensation. Administrative expenses for legal, accounting, and other services are rendered by parties-in-interest and are paid by the Company. The Plan invests in pooled separate accounts affiliated with and an investment contract sponsored by Voya. Investment related expenses are included in net appreciation of fair value of investments.

Note 7. Income Tax Status

The Plan, which is a prototype plan, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of Section 401(a) of the Internal Revenue Code ("IRC") and therefore not subject to tax. The Plan has been amended since receiving the opinion letter. The Plan Administrator and Plan Sponsor believe that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 8. Risks and Uncertainties

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
