Independent Auditor's Report

To the Plan Administrator
Global Technical Systems 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Global Technical Systems 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Global Technical Systems 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of the Global Technical Systems 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of Management Services Group, Inc. D/B/A Global Technical Systems and participating companies (“Company”). The Plan is subject to the provisions of ERISA. The Plan Administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

Contributions: Each year, participants may contribute up to the maximum allowed by law of their pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company makes a safe-harbor matching contribution equal to 100 percent of a participant’s elective deferrals up to four percent of the participant’s compensation. The Company may make additional matching contributions to eligible participants. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Participant accounts: Each participant's account is credited with the participant’s contributions and Company safe-harbor and additional matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative and investment expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are vested immediately in their contributions and Company safe-harbor contributions plus actual earnings thereon. Vesting in the additional matching contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

Payment of benefits: On termination of service, a participant may elect to receive a lump sum amount equal to the value of the participant’s vested interest in his or her account. Effective June 26, 2024, participants may additionally elect substantially equal installments over a period not to exceed life expectancy or partial payments no less than \$1,000. In-service withdrawals are permitted for participants who have attained age 59 1/2 or for a qualified financial hardship.

Forfeited accounts: As of December 31, 2024 and 2023, there were no forfeited nonvested accounts. If available, these accounts will be used to reduce future employer contributions or to pay administrative expenses of the Plan. No forfeited nonvested accounts were used in 2024.

2. Summary of Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment adviser, Empower Trust Company, LLC ("Empower Trust"), Empower Annuity Insurance Company of America ("EAICA") and Lincoln Financial Group Trust Company, Inc. ("Lincoln Trust"). See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Contributions from Plan participants and the Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to recordkeeping and benefits paid are charged directly to the participant's account and are included in administrative expenses. Fees paid directly by the Plan for investment advisory services are included in investment expenses. Investment related expenses paid indirectly through revenue sharing arrangements are included in net appreciation of fair value of investments.

Subsequent events: The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1)

and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. Fully Benefit-Responsive Investment Contract

The Plan holds traditional fully benefit-responsive guaranteed investment contracts totaling \$129,780 for 2024 and \$101,538 for 2023. Contributions to the contracts are maintained in a general account. Each account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than one percent. The crediting rate is reviewed semi-annually for resetting.

These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by each issuer, represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include:

1. Sponsor initiated transfer out of the contract before the 6th contract year
2. Termination of the Plan Contract
3. Participant termination due to plant shutdown or other programs instituted by the Plan sponsor, in excess of 20 percent
4. Re-enrollment programs resulting in withdrawals in excess of 20% of account

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include:

1. Unpaid charges outstanding more than 30 days
2. Plan no longer meets applicable Code provisions per the IRS
3. The Plan holds less than \$15,000 at any time after the 3rd Contract year
4. Following the 3rd contract year, there is no deposit activity for 24 consecutive months and the Account is less than \$50,000
5. Plan sponsor fails to provide requested information or other documentation
6. Plan sponsor material misrepresentation of information
7. Issuer elects to discontinue offering the contract
8. The risk profile of the Plan including other fund options alters the risk the issuer intends to assume

Effective June 26, 2024, the guaranteed contract sponsored by Massachusetts Mutual Life Insurance Company (“MassMutual”) terminated and the balance transferred to Lincoln National Life Insurance Company (“LNLIC”). The guaranteed investment contract with MassMutual was liquidated at less than contract value. LNLIC contracted with the Plan to reimburse the Plan up to \$12,701 of the exit charges assessed against the Plan under the MassMutual contract. To the extent the Plan maintains its guaranteed investment contract with LNLIC for 5 years the reimbursement amount due LNLIC upon cancellation of the contract will be zero.

5. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are sponsored by LNLIC and MassMutual. EAICA, an affiliate of Empower Retirement, LLC, holds power of attorney for MassMutual with respect to Empower’s role as the administrator of MassMutual’s retirement business. Empower Trust was the custodian of the Plan and EAICA was the recordkeeper for the Plan as of December 31, 2023, and for the period January 1, 2024 to June 25, 2024. Lincoln Trust is the trustee for the Plan and Lincoln Retirement Services Company, LLC (“LRSC”) is the recordkeeper for the Plan as of June 26, 2024. Lincoln Trust, LRSC and LNLIC are affiliates of Lincoln National Corporation. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity. These transactions qualify as exempt party in interest transactions.

LRSC provides an expense credit to the Plan based on fees received by LRSC from certain Plan investments. The Plan expense credit may be used to pay Plan expenses. The expense credit for the year ended December 31, 2024, was \$6,594. The credit is netted with investment expenses in the statement of changes in net assets available for benefits.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100 percent vested in their employer safe-harbor contributions and become 100 percent vested in their employer additional matching contributions.

7. Tax Status

The IRS has determined and informed the pre-approved plan sponsor by a letter dated June 30, 2020, that the pre-approved plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the pre-approved plan has been amended since receiving the opinion letter, the Plan administrator and the pre-approved plan sponsor believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however,

there are currently no audits for any tax periods in progress.

Annual testing required by the IRC to ensure compliance with IRS regulations was not completed for the year ended December 31, 2024. These tests are required for the Plan to maintain its tax-advantaged status. Management will accumulate the necessary information, complete the testing and make any corrections during 2025.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust, EAICA, and Lincoln Trust.

10. Nonexempt Transactions

Title I of ERISA requires that all employee contributions be remitted to the Plan as soon as administratively possible but no later than the 15th business day of the month following the month of being withheld from compensation. Failure to remit employee contributions to the Plan on a timely basis is considered a nonexempt prohibited transaction with a party in interest. Participant contributions of \$4,050 were withheld from participants' pay during 2024 but were not remitted to the Plan's trust within the time frame required by the Department of Labor. Lost earnings will be corrected through procedures prescribed by the Department of Labor.
