Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audits.

**Other Matter—Supplemental Schedule Required by ERISA**

The supplemental schedule, Schedule H, line 4(i)—schedule of assets (held at end of year), as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### Note 1. Plan Description

The following description of CTI Clinical Trial Services, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document and Plan amendments for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of CTI Clinical Trial Services, Inc. (the Company). Employees who are age 20 or older are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Participant contributions to the Plan are made by employees within limitations stipulated in Section 401(k) of the Internal Revenue Code (IRC) and provides for higher contribution limits for employees who are age 50 or older. Participants may contribute up to a maximum of 90% of annual compensation. Employees may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company provides a discretionary profit-sharing contribution to the Plan determined annually by the Company. The Plan uses a pro rata allocation method to allocate the profit-sharing contribution to eligible participants via the groups outlined in the Plan document. There was no discretionary profit-sharing contribution to the Plan for the year ended December 31, 2024. The Company also provides a discretionary employer matching contribution to the Plan, remitted each pay period. For the year ended December 31, 2024, the discretionary formula allowed for matching contributions equal to 100% of the first 5% of pay contributed by the participant.

**Participant accounts:** Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on each participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

**Vesting:** Participants are immediately 100% vested in their voluntary contributions. Vesting in the Company's discretionary non-elective profit sharing contributions plus actual earnings thereon is based on years of continuous service. Participants vest in contributions made by the Company, 20% after two years of service and another 20% per year thereafter until they become fully vested after six years of service. Effective December 1, 2023, vesting on profit sharing contributions was amended for active employees on that date to 20% after two years of service then 100% upon reaching three years of service. Vesting in the Company's discretionary matching contributions plus actual earnings thereon is based on years of continuous service. Participants become fully vested after three years of service.

**Forfeitures:** If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are liquidated, moved to the money market account and used to pay employer discretionary non-elective contributions, employer discretionary matching contributions or administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$163,650 and \$131,731, respectively. Forfeited amounts of \$212,817 were used to fund employer matching contributions during the year ended December 31, 2024.

#### Note 1. Plan Description (Continued)

**Notes receivable from participants:** Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the excess (if any) of the highest outstanding balance of notes during the one-year period ending on the day before the note is made, over the outstanding balance of notes from the Plan on the date the note is made or one-half of the present value of the vested portion of the participant's account balance. Loan terms range from one to five years, unless such loan is for the purchase of a participant's primary residence. The loans are collateralized by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest is repaid through payroll deductions. Interest rates ranged from 4.25% to 9.50% as of December 31, 2024 and 2023.

**Payment of benefits:** Distributions are payable upon reaching the age of 59½ or upon retirement, death, disability or termination of employment in the form of a lump-sum amount or direct rollover distribution of an amount equal to the vested balance of a participant's account. Account balances less than \$1,000 are paid in a single lump sum upon termination; account balances from \$1,000 to \$7,000 will be rolled over to an individual retirement plan designated by the Plan Administrator.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements are prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America (GAAP) in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification.

**Investment valuation and income recognition:** Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses in investments bought and sold as well as held during the year. Capital gain distributions are included in interest and dividend income.

**Contributions:** Participant contributions are recognized when earned. Company discretionary non-elective contributions are recognized annually, as applicable. Company matching contributions are recognized simultaneously with participant contributions, when earned.

**Notes receivable from participants:** Notes receivable from participants are recorded at their unpaid principal balances plus any accrued interest. Notes receivable from participants are written off when deemed uncollectible.

**Benefit payments:** Benefits are recorded when paid.

**Administrative expenses:** Various administrative costs are paid by the Company.

**Use of estimates:** The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect certain amounts and disclosures reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### **Note 3. Information Certified and Provided by Fidelity Management Trust Company (Trustee)**

The information related to investments and notes receivable from participants that is included throughout the Plan's financial statements and ERISA-required supplemental schedule as of December 31, 2024 and 2023 and for the year ended December 31, 2024 was prepared or derived from information provided by Fidelity Management Trust Company, the trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to these plan assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information in Note 4 and the ERISA-required supplemental schedule related to the Plan's assets.

Fidelity Management Trust Company also certified to the completeness and accuracy of \$7,777,553 of net appreciation in fair value of investments, \$3,967,457 of interest and dividends related to investments and \$47,834 of interest income from notes receivable from participants for the year ended December 31, 2024.

#### **Note 4. Fair Value Measurements**

The Plan has determined the fair value of certain assets through application of accounting guidance that establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

**Level 1:** Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### Note 4. Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

**Mutual funds:** Valued at the closing price reported on the active market on which the individual securities are traded.

**Common collective trust fund:** Valued based on the net asset value (NAV) of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Assets measured at fair value on a recurring basis:** The following tables summarize assets measured at fair value on a recurring basis as of December 31, 2024 and 2023, segregated by level of the valuation inputs within the fair value hierarchy utilized to measure fair value.

#### Note 5. Income Tax Status

The Plan adopted a standardized form of a volume submitter plan sponsored by Fidelity. The volume submitter plan has received a favorable opinion letter from the Internal Revenue Service as to the volume submitter plan's qualified status, dated June 30, 2020. This opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

The Plan Administrator evaluated the Plan's tax positions and concluded that there are no uncertain tax positions that require recognition or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by tax authorities for years before 2021.

#### Note 6. Plan Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan agreement and ERISA. Upon termination of the Plan, participants become 100% vested in their account balances.

#### Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### Note 8. Party-in-Interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Souders Financial Advisors, LLC served as advisors to the Plan in which the advisor fees also qualify as party-in-interest transactions. Fees paid by the Plan for investment management and advisory services totaled \$103,514 for the year ended December 31, 2024.

#### Note 9. Subsequent Events

Effective January 1, 2025, the Plan was amended to allow participants a self-directed brokerage option. Effective July 1, 2025, the Plan was amended to add an in-plan roth conversion feature. The Plan has evaluated subsequent events for potential recognition and/or disclosure through October 10, 2025, the date the financial statements were available to be issued.
