## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the  
Local 338 Health and Welfare Fund

### Opinion

We have audited the financial statements of the Local 338 Health and Welfare Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in its benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. The supplemental Schedule of Assets Held at End of Year, Schedule of Reportable Transactions, Schedules of Benefits Paid and Schedules of Administrative Expenses, together referred to as “supplemental information,” are presented for the purpose of additional analysis and are not a required part of the financial statements. The supplemental Schedule of Assets Held at End of Year and Schedule of Reportable Transactions represent supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Supplemental information is the responsibility of the Plan's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

### NOTE 1. DESCRIPTION OF THE PLAN

The following is a brief description of Local 338 Health and Welfare Fund (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

**General** - The Plan is a multi-employer health benefit plan established under the provisions of an Agreement and Declaration of Trust between the Retail Wholesale and Chain Store Food Employees Union, Local 338, RWDSU/UFCW (Union), and various supermarkets located in the greater New York area (Employers). The Plan covers all employees included in collective bargaining agreements with the Union. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees is responsible for the oversight of the Plan, including determining the appropriateness of the Plan's investments in coordination with its investment advisers.

**Benefits** - The Plan provides hospital, surgical, major medical, and prescription drug benefits in accordance with the provisions of the rules and regulations of the Plan. Retired employees are entitled to similar health benefits (in excess of Medicare coverage) provided they have attained at least age sixty and have thirty years of service or sixty-two and have fifteen years of service with participating employers before retirement.

The Plan also maintains a stop-loss insurance contract to protect the Plan from any unknown or potential large claims.

An active, full-time employee of a contributing employer for whom contributions are being made to the Welfare Fund will be eligible for coverage on the first of the month after receipt of co-contributions, if applicable, but not later than ninety days from when the employee became a full-time employee for the contributing employer. Contribution rates have been established under collective bargaining agreements entered into between the Union and the Employer.

### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The accompanying financial statements are prepared using the accrual basis of accounting.

## **NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

**Investments and Income Recognition** - The investments of the Plan are managed by independent investment managers. Investments are carried at fair value. The valuation for common stock is carried at fair value which generally represents quoted market prices or the net asset value of the fund as of the last business day of the year as provided by the custodian. The investments in 103-12 investment entities are valued at their market value on the last business day of the year as established by the trusts. The limited partnerships of funds are carried at estimated fair value as determined by the partnership. Short-term investments are carried at cost which approximates fair value.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Employer Contributions** - Employer contributions due and not paid prior to year end are recorded as contributions receivable.

**Benefit Obligations** - Plan liabilities for claims incurred but not reported, accumulated eligibility credits, and postretirement benefits are estimated by the Plan's actuary in accordance with accepted actuarial principles. The amounts reported as postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants.

**Payment of Benefits** - Benefit payments are recorded when paid.

**Property and Equipment** - Property and equipment are carried at cost. Major additions are capitalized while replacements, maintenance and repairs which do not improve or extend the lives of the respective assets are expensed currently. Depreciation and amortization are computed over the estimated useful lives for building and improvements of 20 to 39 years, and computer equipment, furniture and fixtures of 3 to 7 years by the straight-line method.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Reclassifications** - Certain prior year amounts have been reclassified to be in conformity with the current year presentation. These reclassifications did not change the total net assets or change in net assets from the totals previously reported.

### **NOTE 3. INVESTMENTS AND FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

#### Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

For the years ended December 31, 2024 and 2023 there were no transfers in or out of levels 1, 2 or 3.

### **NOTE 3. INVESTMENTS AND FAIR VALUE MEASUREMENTS (continued)**

(a) - Boyd Watterson Boyd Watterson GSA Fund, L. P and Subsidiary (the “Fund”), a Delaware limited partnership, was formed to operate as a perpetual life, open-end, commingled collective investment fund and intends to invest primarily in real estate primarily leased to the U.S. federal government either through the General Services Administration (“GSA”) or other federal government agencies. Redemption requests will be effective as of the last day of a calendar quarter if received at least sixty (60) days prior to the last day of a calendar quarter. Redemption requests received after such date will be effective as of the last day of the following calendar quarter. Unless waived by the General Partner, partial redemptions of Units shall only be permitted in increments of \$250,000 and shall not be permitted for amounts less than \$250,000. A Fund Partner’s ability to redeem Units is subject to certain restrictions, and in certain limited circumstances, a redemption charge as described herein. See Section VII. “Summary of Terms - Redemptions.” A Fund Partner may not assign, sell, pledge, encumber, exchange or transfer its Units without the prior written consent of the General Partner. Except in connection with a redemption request or otherwise with the consent of the General Partner, no Fund Partner will be permitted to withdraw from the Fund or to withdraw any portion of its Units.

(b) - Ullico Infrastructure Tax-Exempt Fund LP a common collective trust. In respect to Redemption Rights The General Partner will permit a limited partner to redeem all or a portion of its units after the expiration of a four year lock-up period beginning on the limited partner’s admission date to the Partnership. Upon 45 days notice to the General Partner, the limited partner will be placed in a redemption queue. A limited partner who is next up in the redemption queue will be able to have all or a portion of its requested units redeemed. There are two sources of liquidity available to satisfy redemption requests for limited partners who are in the redemption queue. The first source of liquidity is triggered when new limited partners are admitted to the Partnership to the extent of the new limited partner commitments. If the new limited partner commitments are less than the requested redemption amount, only the portion of the requested redemption amount equal to the amount of new limited partner commitments will be redeemed and the balance of the requested redemption amount will remain in the redemption queue. The General Partner will call capital from existing limited partners up to the amount that is permitted to be redeemed, which will be used for the redemption payment. The second source of liquidity for limited partners in the redemption queue is triggered when the Master Fund generates available proceeds from a sale, exchange, refinancing or other disposition of investments in the ordinary course of the Master Fund’s business. To the extent there are available proceeds from the sale, exchange, refinancing or other disposition, less amounts set aside for the Master Fund’s reserves or other working capital purposes as the General Partner shall determine, then that portion will be used to redeem the portion of the units which correspond to the limited partner’s pro rata share of the amount of available proceeds generated from the sale of the investment and any balance of the requested redemption amount will remain in the redemption queue. All proceeds available to satisfy redemption requests will be used to redeem the permitted portion of the requested units effective on the last business day of the fiscal quarter in which such proceeds become available based on the unit value as of the withdrawal day. In addition, the General Partner may redeem all of a portion of a limited partner’s units at any time where the General Partner determines, in good faith, that the continued participation of such limited partner in the Partnership would cause the Partnership to violate any applicable law, rule or regulation.

### **NOTE 3. INVESTMENTS AND FAIR VALUE MEASUREMENTS (continued)**

(c) - Neuberger Berman (PF) Strategic Income Fund LLC, a Delaware limited liability company, was formed on January 8, 2020 and commenced operations on September 1, 2020. On July 28, 2021, Neuberger Berman (PF) Strategic Income Fund LLC changed its name to Neuberger Berman (PF) Strategic Multi-Sector Fixed Income Fund LLC (the "Fund"). Limited liability company interests in the Fund (the "Interests" ) will be offered to eligible investors through Neuberger Berman BD LLC ( "NB BD LLC") or another affiliate of the Manager (as applicable, the "Placement Agent"), subject to prior subscription and certain other conditions. The Fund will offer Interests to two categories of investors, referred to herein as Associated Members and General Members, depending on the relationship of the investors with the Manager. Redemptions may generally be effected on a monthly basis as of the last calendar day of each month. Subject to maintaining the minimum investment amount, Members may make partial redemptions in amounts of not less than \$100,000, subject to waiver of such minimums by the Manager, in its sole discretion. Interests generally will be offered for sale as of the first calendar day of each month (and such other dates as may be designated by the Manager) (each, an "Admission Date") and generally may be redeemed as of the last calendar day of each month (and as of each Special Mid-Month Redemption Date, as well as such other dates as may be designated by the Manager) (each, a "Redemption Date"). The last Business Day of each month (and such other dates as may be designated by the Manager, including the Special Mid-Month Redemption Date if elected, or if such Special Mid-Month Redemption Date is not a Business Day, the immediately preceding Business Day) such Special Mid-Month Redemption Date is not a Business Day, the immediately preceding Business Day) will be the day on which the net asset value of the Fund (" Net Asset Value") is calculated (each, a "Valuation Date"). "Business Day" means any day other than Saturday, Sunday, holiday, or day on which banks in the U.S. or the New York Stock Exchange are generally authorized or obliged to close, or such other days as the Manager may determine.

### **NOTE 4. RELATED PARTY TRANSACTIONS**

#### **Identification of Related Organizations**

The Plan has the following related entities with which it has transactions:

- Retail Wholesale and Chain Store Food Employees Union, Local 338
- Local 338 Benefits Fund
- Local 338 Retirement
- Local 338 Annuity Fund
- Local 305 CIO Pension Fund

#### **Administrative Expenses**

All of the above entities qualify as tax-exempt organizations. The entities above share common Trustees or Officers with the Plan.

**NOTE 4. RELATED PARTY TRANSACTIONS (continued)**

The Plan shares office space and certain administrative expenses with the Union, the Local 338 Retirement Fund (Retirement Fund), the Local 338 Benefits Fund (Benefits Fund), the Local 305 CIO's Pension Fund (Pension Fund), and the Local 338 Annuity Fund (Annuity Fund) (collectively, Local 338 Funds). Certain expenses that are common among the Union and the Local 338 Funds are generally paid by the Union and/or the Plan and allocated based primarily upon payroll-based ratios. The Plan's allocable share of expenses paid by the Union amounted to \$2,169,220 and \$2,039,956 for the years ended December 31, 2024 and 2023, respectively.

The Plan allocated \$1,310,255 and \$1,339,400 of expenses to the Union and the other Local 338 Funds for the years ended December 31, 2024 and 2023, respectively.

The Plan leases office space from the Union. The lease is considered an operating lease and is paid on a month-to-month basis. Rental expenses paid to the Union amounted to \$360,000 for each of the years ended December 31, 2024 and 2023. The Plan then allocates a share of this rent paid to the Union based primarily upon payroll-based ratios to the related parties as follows: the Plan's allocable share of rent paid by the Retirement Fund amounted to \$45,920 and \$45,458, respectively. The Plan's allocable share of rent paid by the Benefits Fund for the year ended December 31, 2024 and 2023 amounted to \$49,241 and \$47,997, respectively. The Plan's allocable share of rent paid by the 305 Retirement Fund for the year ended December 31, 2024 and 2023 amounted to \$1,002 and \$1,132, respectively. The Plan's allocable share of rent paid by the Annuity Fund for the year ended December 31, 2024 and 2023 amounted to \$27,105 and \$26,723, respectively.

As of December 31, 2024 and 2023, the Plan owed the Union \$327,009 and \$313,498, respectively, for rent and shared expenses.

As of December 31, 2024 and 2023, the Plan was owed by the Retirement Fund \$120,532 and \$90,908, respectively, for shared expenses.

As of December 31, 2024 and 2023, the Plan was owed by the Annuity Fund \$76,287 and \$71,164, respectively, for shared expenses.

As of December 31, 2024 and 2023, the Plan owed the 305 Retirement Fund \$18,412 and \$19,522, respectively, for shared expenses.

As of December 31, 2024 and 2023, the Plan was owed by the Benefits Fund \$227,796 and \$217,901, respectively, for shared expenses.

**NOTE 6. TAX STATUS**

The Plan obtained its determination letter dated November 1978, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of Section 501(c)(9) of the Internal Revenue Code, and was, therefore, exempt from Federal income taxes. The Plan has been amended since receiving the determination letter.

The Plan's Administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

## **NOTE 7. PLAN TERMINATION**

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

## **NOTE 8. POSTRETIREMENT BENEFIT OBLIGATIONS**

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to participants' service rendered to December 31, 2024 and 2023, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Postretirement benefits include future benefits expected to be paid to or for: (1) currently retired or terminated employees and their beneficiaries and dependents, and (2) active employees and their beneficiaries and dependents after retirement from active service with the participating employers. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuations as of December 31, 2024 and 2023, are as follows:

- Interest: 6.75% compounded annually.
- Mortality: RP2014 Blue Collar Mortality Table.
- Medical Cost Inflation: 5.00% compounded annually.
- Retirement Age: Age 65 or the present age, if higher.

If the assumed medical cost inflation rate increased by one percentage point, it would increase the postretirement benefit obligation by \$4,548,600 and \$4,523,400 at December 31, 2024 and 2023, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

**NOTE 9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and participant demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
