1. Description of Plan

The following brief description of the IDEXX Retirement and Incentive Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for complete information.

General

The Plan is a defined contribution plan covering all eligible employees of IDEXX Laboratories, Inc. and Subsidiaries (the Company) employed in the United States. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Trustee

The trustee of the Plan is Vanguard Fiduciary Trust Company (Vanguard or VFTC).

Eligibility and Participation Requirements

Employees 18 years of age or older are eligible to participate in the Plan on the first day of a calendar month following completion of one month of service with the Company. Participants may contribute up to 50% of their annual pre-tax compensation as allowable under Section 401(k) of the Internal Revenue Code (IRC). Eligible employees are automatically enrolled in the Plan at 5% if they do not voluntarily enroll or opt out within 30 days of hire. The Plan automatically increases the contributions of participants who have been automatically enrolled by 1% each year based on their date of hire up to a maximum of 15%. Participants may change their deferral elections after being automatically enrolled and may also invest amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan has a Roth 401(k) feature which allows participants to contribute a portion of their annual after-tax compensation to the Plan. Annual limitations on employee contributions apply to pre-tax and after-tax contributions in the aggregate.

Company Contributions

Employees are eligible to receive employer matching contributions as soon as administratively possible (i.e., the next pay period) following the completion of six months of service with the Company. For the year ended December 31, 2024, the Company matched 100% of the first 5% of the participants' eligible compensation contributed to the Plan. The Company may also make a discretionary contribution which would be allocated to eligible Plan participants in proportion to each participant's annual pre-tax compensation to the aggregate annual compensation of all participants. For such Company discretionary contributions to be allocated to a participant's account, a participant must complete 500 hours of credited service during the Plan year, or must have retired after reaching 65 years of age, or died during the Plan year. There was no such discretionary contribution for the year ended December 31, 2024.

Participants' Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, and allocations of the Company's discretionary contribution and Plan earnings or losses and fees.

Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Company's matching contribution, plus earnings thereon. For Company discretionary contributions, participants are vested after three years of credited service.

Notes Receivable from Participants

Participants may borrow from their accounts an amount between \$1,000 and the lesser of \$50,000 (reduced by the highest outstanding loan balance in the previous 12 months) or 50% of their vested account balance. Loan originations are treated as a transfer from the investment fund to the Participant Loans Fund. Repayments of loans are treated as a transaction from the Participant Loans Fund to the investment fund. All loans from the Plan, with the exception of loans used to purchase a principal residence, must be repaid within five years of origination. Principal and interest is paid ratably through periodic payroll deductions. The plan administrator will also determine the rate of interest to be charged. Interest rates for these loans were between 4.25% and 9.50% as of December 31, 2024.

Payment of Benefits and Withdrawals

Upon reaching the age of 59½, participants may elect to receive the value of their vested accounts either by a lump-sum payment or by installment payments over the expected remaining life of the participant. Participants may also withdraw amounts in the event of financial hardship, in accordance with safe harbor withdrawal rules. In the event of termination of service, if no distribution election is made within 60 days, the participant's vested account balance will be paid in a lump-sum distribution if the account balance is less than \$1,000; if the account balance is between \$1,000 and \$5,000, the participant's account balance will be rolled into a qualified Vanguard individual retirement arrangement; and if the account balance is greater than \$5,000, the balance can remain in the Plan.

Forfeitures

Forfeitures of terminated nonvested account balances from discretionary contributions may be used to pay administrative expenses or to reduce the amount of future contributions required to be made by the Company.

Plan Termination

The Company reserves the right to terminate the Plan or discontinue its contributions at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of the Plan's financial statements in conformity with U.S. generally accepted accounting principles (U.S. GAAP) requires the plan administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Dividend income is recorded on the ex-dividend date. Interest income is accrued when earned. Purchases and sales of investments are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan gains and losses on investments bought and sold as well as held during the year.

The Plan has investments in collective trusts managed by Vanguard. The investment objective of the collective trusts varies depending on the specific collective trust. However, the objective is generally to provide stability of principal and income, track the performance of a benchmark or bond index, or provide current income and some capital appreciation. Withdrawals are permitted at any time by participants for benefit payments, transfer of investment elections (except to competing vehicles), and payment of fees. Plan sponsor directed redemptions are subject to a 12 month advance written notice requirement.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan Document.

Risks and Uncertainties

The Plan provides for various investment options in mutual funds, collective trusts, and a money market fund. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

For purposes of the preparation of these financial statements in conformity with U.S. GAAP, management has considered transactions or events occurring through October 8, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Parties-In-Interest

The Plan invests in shares of mutual funds, collective trusts, and a money market fund managed by an affiliate of VFTC. VFTC acts as trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

Certain distributions made by the Plan are in the form of loans to the Plan's participants. These loans are also considered to be party-in-interest transactions which are exempt from the prohibited transaction rules.

The administrative expenses of maintaining the Plan, including Plan audit, fiduciary, and legal fees, are paid by the Company. Fiduciary fees paid to VFTC totaled \$839,095. Account maintenance and distribution fees are paid from the participants' accounts.

4. Tax Status

The Plan is part of a pre-approved plan designed by The Vanguard Group, an affiliate of VFTC. The Internal Revenue Service has determined and informed The Vanguard Group by a letter dated June 30, 2020 that the pre-approved plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination; however, the plan administrator believes that the Plan is designed and currently operated in compliance with the applicable requirements of the IRC.

6. Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement of the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds and money market fund: Valued at the net asset value (NAV) of shares in the funds, which is based on quoted market prices of the underlying investments. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trusts: Valued at the NAV of units held by the Plan. The NAV is used as a practical expedient to estimate fair value, which is, therefore, not classified into the levels described above. The NAV is based on the fair value of the underlying investments in the accounts. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

While the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
