## INDEPENDENT AUDITOR'S REPORT

To the Administrator of GapShare Puerto Rico Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of GapShare Puerto Rico Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

## NOTES TO FINANCIAL STATEMENTS AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

### 1. DESCRIPTION OF PLAN

**General** – The GapShare Puerto Rico Plan (the “Plan”) is a defined contribution plan and trust, which was established to provide a source of retirement savings to participants and to enable participants to defer a portion of their eligible compensation. The following brief description of the Plan is provided for general information purposes only, participants should refer to the Summary Plan Description and official plan documents for more complete information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan is intended to qualify under Sections 1081.01(a) and 1081.01(d) of the Puerto Rico Internal Revenue Code of 2011, as amended, and supplements (collectively, the “Code”).

All employees of Gap Inc. (the “Company” or “Plan Sponsor”) and employees of Gap Inc. (Puerto Rico), who have attained the age of 18 are immediately eligible to participate in the Plan.

**Contributions** – The minimum level of participant contributions is 1% of base salary. Total pretax contributions may not exceed a maximum of 30% of total eligible compensation for a pay date. Total after-tax contributions may not exceed a maximum of 10% of eligible compensation for a pay date. Total pretax and after-tax contributions cannot exceed 40% of total eligible compensation. The maximum annual allowable pretax contribution qualifying for deferral for individual income tax purposes was \$15,000 for the calendar year ended December 31, 2024. The maximum annual compensation allowable for Plan allocation purposes was \$345,000 for the year ended December 31, 2024.

Participants who are eligible to make tax-deferred contributions and who attain age 50 before the close of the calendar year are allowed to make catch-up contributions in any plan year not exceeding \$1,500 for the calendar year ended December 31, 2024.

If a participant contributes between 1% and 9% on a pretax basis, Gap Inc. will automatically increase the deferral percentage by 1% of eligible pay each year on the anniversary of the participant’s hire date. The percentage increase will continue until the participant reaches a deferral percentage of 10%. Participants can change or stop their deferral election at any time and can opt out of the automatic increase provisions of the Plan.

Company contributions are made according to a matching formula established prior to the beginning of each plan year. For 2024 and 2023, the formula provided for a 100% matching contribution up to 4% of base pay per pay period of participant contributions on a pretax, after-tax, or catch-up basis. A participant’s aggregate annual contribution, which includes participant and Company contributions, could not exceed \$69,000 for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined contribution plans.

All full-time employees participating in the Plan are immediately eligible to receive the Company matching contributions. All other active employees participating in the Plan who have attained the age of 18 are eligible to receive the Company matching contributions upon being credited with at least 1,000 hours of service to the Company during the 12-consecutive-month period beginning on the employee’s date of hire by the Company or during any calendar year beginning after the employee’s date of hire.

Investments of participant and Company contributions are allocated to the funds as elected by the participant. Allocations of each fund’s earnings or losses are based on participant account balances in those funds. Participants may transfer accumulated account balances between funds at any time.

**Participant Accounts** – Individual accounts are maintained for each participant of the Plan. Each participant’s account is credited with the participant’s contribution and related matching and nonelective contributions and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of Plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances. Participants are entitled to any vested amounts in their account.

**Trustee, Custodian, and Recordkeeper** – T. Rowe Price Trust Company (the “Custodian”) serves as the custodian; T. Rowe Price Retirement Plan Services, Inc. (the “Recordkeeper”) serves as the recordkeeper, and Banco Popular de Puerto Rico (the “Trustee”) serves as the trustee. The Plan Sponsor authorized the Recordkeeper to receive an annual administrative fee that covers the cost of recordkeeping, custody, legal, and audit services.

**Investment Options** – As of December 31, 2024 and 2023, the Plan’s assets were invested in a number of mutual funds and collective trust funds.

**Vesting** – All active employees are 100% vested in all employer contributions, participant contributions, and earnings thereon.

**Notes Receivable from Participants** – For a fee of \$50, participants may apply to receive a loan of up to the lesser of 50% of their vested amounts or \$50,000, minus the highest balance of any other loan outstanding in the preceding 12 months. Participants are allowed to maintain one general purpose loan and one principal residence loan. The minimum amount participants may borrow is \$1,000. Loans are repaid through payroll deductions for up to a period of five years, unless the loan is for the purchase or construction of a principal residence, in which case terms range from one to fifteen years. If an unpaid loan balance exists at the time a participant leaves the Company and withdraws from the Plan, it must be repaid by the participant or deducted from the participant’s total distribution. The fixed interest rate charged is 1% over the prime rate (as published in *The Wall Street Journal*) on the last business day of the month preceding the month in which the loan is requested. As of December 31, 2024, loans had interest rates ranging from 4.25% to 9.50%, including loans maturing through 2032.

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the plan document.

**Automatic Enrollment** – The Plan provides for automatic enrollment. Upon completion of the eligibility requirements, individuals are notified of their eligibility and the opportunity to enroll in the Plan and to make contribution and investment elections. If an individual becomes eligible to participate in the Plan before the second anniversary of his/her hire date and does not enroll, he/she will be automatically enrolled in the Plan by Gap Inc. on the second anniversary of his/her hire date. If an individual becomes eligible to participate in the Plan after the second anniversary of his/her hire date and does not enroll, he/she will be automatically enrolled in the Plan by Gap Inc. on the next anniversary of his/her hire date. The default percentage for automatic enrollment will be 1% of eligible pay. The contributions for those participants who are automatically enrolled in the Plan will be 100% invested in the Plan's qualified default investment alternative, an age-based T.Rowe Price Retirement Trust (based on the year the participant turns age 65), unless the participant elects another investment alternative. Participants can elect to change or stop contributions to the Plan at any time following enrollment.

**Payment of Benefits** – Upon termination of employment, participants will receive a lump-sum distribution payment of their account. If the account balance is greater than \$1,000, the participant's consent is required prior to the distribution.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event certain financial needs and hardship standards are met. Following a hardship withdrawal, participants are not allowed to contribute to the Plan for a period of twelve months.

**Excess Contributions Payable** – The Plan is required to return contributions received during the plan year in excess of limits as established by the Code. There were no excess contributions due to participants as of December 31, 2024 and 2023.

**Administrative Expenses** – Each participant account under the Plan is charged an annual Plan administrative fee that covers the cost of recordkeeping, custody, legal, and audit services. Fees will change from year to year to reflect actual changes in Plan administrative costs. For the year-ended December 31, 2024, the plan administrative fee was \$23 annually (\$5.75 quarterly). The Plan administrative fee is deducted from the participant's account balance on a pro-rata basis over the calendar year on the last business day of each quarter and prorated across all investment options held in the account.

**Forfeited Accounts** – The plan document permits the use of forfeitures to reduce future employer contributions or pay plan administrative expenses for the plan year, among others. However, if a participant is reemployed and fulfills certain requirements, as defined in the plan document, the account will be reinstated. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,732 and \$2,624, respectively. During 2024, forfeited nonvested accounts were not used to reduce employer contributions.

## 2. SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

**Administration Expenses** – Administrative expenses of the Plan are paid by the Plan or the Plan sponsor, as provided in the Plan document. Participants pay administrative costs for general administrative services and individual service fees for loans, distributions and qualified domestic relation orders.

All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Use of Estimates** – The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Risks and Uncertainties** – The Plan utilizes mutual funds and common collective trust funds. These investments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the financial statements.

**Investment Valuation and Income Recognition** – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of mutual funds and collective trust funds are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Any resulting appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contributions** – Employee contributions and employer matching contributions are recorded when withheld.

**Payment of Benefits** – Benefit payments to participants are recorded upon distribution. There were no unpaid amounts at December 31, 2024 and 2023.

### 4. FAIR VALUE MEASUREMENTS

The Plan classifies its investments into Level 1, which refers to securities valued using quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Investments are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish the daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Stable Value Fund**—The Fund is a Collective Trust Fund comprised of guaranteed investment contracts, synthetic investment contracts, and money market funds. The net asset value (“NAV”), as provided by the Custodian, is used as a practical expedient to estimate fair value. This NAV represents the Plan's fair value since this is the NAV at which the Plan transacts with the Fund. This practical expedient is not used when it is determined to be probable that the Fund will sell the investment for an amount different than the reported NAV.

Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, then the issuer reserves the right to require 12-month notification to ensure that securities liquidations will be carried out in an orderly business manner.

**Collective Trust Funds**—Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to confirm that securities liquidations will be carried out in an orderly business manner.

### 6. TAX EXEMPT STATUS

The Plan is intended to qualify as a profit-sharing plan under Section 1081.01(a) of the Puerto Rico Internal Revenue Code of 2011, as amended (the “Code”), with a cash or deferred arrangement under Section 1081.01(d) of the Code. The Code requires all plan sponsors to file for a determination letter from the Departamento de Hacienda de Puerto Rico (“Hacienda”). The Plan has obtained a favorable tax determination letter from Hacienda, dated December 3, 2024 (reflecting amendments made to the Plan loan provisions effective as of January 1, 2023); therefore, the Plan is in compliance with the Code and no provision for income taxes has been included in the Plan’s financial statements. The Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the Code, and the Plan and related trust continue to be tax-exempt.

### 7. PLAN TERMINATION

The Plan is intended to be permanent; however, in the event of the termination of the Plan, the assets of the Plan allocable to each participant shall be segregated, liquidated, and paid proportionately to the participants until all funds have been distributed.

### 8. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments include shares of a mutual fund and units of collective trust funds managed by T. Rowe Price (“TRP”), the recordkeeper and custodian, as defined by the Plan and, therefore, these transactions qualify as exempt parties-in-interest transactions. During the year ended December 31, 2024, administrative expenses were incurred by the Plan and paid to TRP. The Plan issues loans to participants, which are secured by the vested balances in the participants’ accounts.

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including Mercer Investment Consulting, Inc. (“Mercer”) who is a registered investment advisor ERISA fiduciary and, therefore, Mercer’s services qualify as party-in-interest transactions. During the year ended December 31, 2024, administrative expenses were incurred and paid to Mercer by the Plan.
