Note 1. Description of the Plan

The following description of the Susquehanna International Group, LLP 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan. Employees of Susquehanna International Group, LLP and certain of its affiliates (the "Company") are eligible to enroll in the Plan as of the first day after thirty-one days of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* ("ERISA"). The trustee and the record-keeper of the Plan is Fidelity Management Trust Company ("FMTC"), which provides to the Plan detailed information regarding investment balances and valuation, changes in investments, and investment income.

Contributions

Participants may contribute up to 75% of pre-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, participants may contribute up to 75% of after-tax compensation into the Roth portion of the Plan, as defined by the Plan. In no event may participants pre-tax, and after-tax contributions exceed any statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan has an automatic enrollment of 6% deferral for all newly eligible participants of the Plan, unless an employee affirmatively elects otherwise.

The Company has a discretionary matching 401(k) contribution equal to the minimum of an amount not to exceed 50% of each participant's first 8% of compensation contributed as elective deferrals for the Plan year, as defined in the Plan, or 50% of each participant's elective deferrals for the Plan year, as defined in the Plan. Participants employed by the Company on the last day of the Plan year are eligible to share in the discretionary matching contribution for such Plan year.

Contributions to the profit-sharing portion of the Plan are made by the Company, at its absolute discretion, provided that the aggregate contribution for a Plan year shall not exceed the applicable limits set by the Internal Revenue Code (the "Code"). Participants employed by the Company on the last day of the Plan year are eligible to share in the allocations for such Plan year.

Participant's Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contribution portion of their accounts, plus actual earnings thereon, is as follows:

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, unless the loan was taken under the CARES Act provisions. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates (rates range from 4.25% to 9.50% per annum at December 31, 2024). Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installments, or more frequent installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$503,000 and \$354,000, respectively. These accounts will be used to reduce future employer contributions. Also, in 2024, employer contributions were reduced by approximately \$360,000 from forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual method of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Substantially all expenses, with the exception of fees related to notes receivable from participants, incurred in connection with the administration of the Plan are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates

Investment Certification

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, FMTC, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule(s) is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

Level 1: Quoted prices in active markets for identical assets or liabilities

Level 2: Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

Level 3: Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no significant changes in the valuation techniques during the year ended December 31, 2023.

Money market funds: Valued at the daily closing price as reported by the fund. Money market funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common stocks, corporate bonds, and U.S. Government Securities: Valued at the closing price reported on the active market on which the individual securities are traded.

Common/collective trust (the "Trust"): The Trust is primarily composed of non-convertible bonds, U.S. government and government agency obligations, U.S. government agency mortgage securities, asset-backed securities, collateralized mortgage obligations, and fully benefit-responsive investment contracts. Investments in the Trust are valued at the NAV per unit computed on the balance sheet date or the redemption date. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the Trust, the investment adviser reserves the right to temporarily delay withdrawal from the Trust in order to ensure that securities liquidations will be carried out in an orderly business manner. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the Trust at contract value. The Trust contains several redemption restrictions to withdraw at contract value, including the right to require a 12-month waiting period/advance notice period for fund withdrawals initiated by the Company. The notice period may be waived by the trustee at its sole discretion. Withdrawals initiated by participants of the Plan will be honored when received. As of December 31, 2024 and 2023 there were no unfunded commitments, the redemption frequency for participant transactions in the Trust is daily, and there are no participant level notice period redemption requirements.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) as a practical expedient to fair value have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

Tax Status

The Employer adopted a profit-sharing plan with a cash or deferred arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020 which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the advisory letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Related-Party Transactions and Party-In-Interest Transactions

Certain investments are shares of registered investment companies and a common/collective trust managed by FMTC. FMTC is the Plan trustee, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan were \$97,554 for the year ended December 31, 2024.

Fidelity or its affiliates receive revenue from certain investments in the Plan. Fidelity and the Company have agreed that if this revenue exceeds an agreed upon revenue rate, Fidelity shall make an amount equal to such excess available to the Plan to either pay ERISA qualified plan administrative expenses or to be allocated to the account of the participants. For the year ended December 31, 2024, an excess of \$27,012 was made available to the Plan. The remaining balance available to pay future expenses was approximately \$165,000 and \$270,000 as of December 31, 2024, and 2023, respectively.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Mutual Fund Fees

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads, or 12b-1 fees. 12b-1 fees, which are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940, are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity and thus not separately identifiable as an expense.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date which the financial statements were available to be issued.

Note 1. Description of the Plan

The following description of the Susquehanna International Group, LLP 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan. Employees of Susquehanna International Group, LLP and certain of its affiliates (the "Company") are eligible to enroll in the Plan as of the first day after thirty-one days of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* ("ERISA"). The trustee and the record-keeper of the Plan is Fidelity Management Trust Company ("FMTC"), which provides to the Plan detailed information regarding investment balances and valuation, changes in investments, and investment income.

Contributions

Participants may contribute up to 75% of pre-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, participants may contribute up to 75% of after-tax compensation into the Roth portion of the Plan, as defined by the Plan. In no event may participants pre-tax, and after-tax contributions exceed any statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan has an automatic enrollment of 6% deferral for all newly eligible participants of the Plan, unless an employee affirmatively elects otherwise.

The Company has a discretionary matching 401(k) contribution equal to the minimum of an amount not to exceed 50% of each participant's first 8% of compensation contributed as elective deferrals for the Plan year, as defined in the Plan, or 50% of each participant's elective deferrals for the Plan year, as defined in the Plan. Participants employed by the Company on the last day of the Plan year are eligible to share in the discretionary matching contribution for such Plan year.

Contributions to the profit-sharing portion of the Plan are made by the Company, at its absolute discretion, provided that the aggregate contribution for a Plan year shall not exceed the applicable limits set by the Internal Revenue Code (the "Code"). Participants employed by the Company on the last day of the Plan year are eligible to share in the allocations for such Plan year.

Participant's Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contribution portion of their accounts, plus actual earnings thereon, is as follows:

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, unless the loan was taken under the CARES Act provisions. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates (rates range from 4.25% to 9.50% per annum at December 31, 2024). Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installments, or more frequent installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$503,000 and \$354,000, respectively. These accounts will be used to reduce future employer contributions. Also, in 2024, employer contributions were reduced by approximately \$360,000 from forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual method of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Substantially all expenses, with the exception of fees related to notes receivable from participants, incurred in connection with the administration of the Plan are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates

Investment Certification

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, FMTC, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule(s) is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

Level 1: Quoted prices in active markets for identical assets or liabilities

Level 2: Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

Level 3: Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no significant changes in the valuation techniques during the year ended December 31, 2023.

Money market funds: Valued at the daily closing price as reported by the fund. Money market funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common stocks, corporate bonds, and U.S. Government Securities: Valued at the closing price reported on the active market on which the individual securities are traded.

Common/collective trust (the "Trust"): The Trust is primarily composed of non-convertible bonds, U.S. government and government agency obligations, U.S. government agency mortgage securities, asset-backed securities, collateralized mortgage obligations, and fully benefit-responsive investment contracts. Investments in the Trust are valued at the NAV per unit computed on the balance sheet date or the redemption date. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the Trust, the investment adviser reserves the right to temporarily delay withdrawal from the Trust in order to ensure that securities liquidations will be carried out in an orderly business manner. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the Trust at contract value. The Trust contains several redemption restrictions to withdraw at contract value, including the right to require a 12-month waiting period/advance notice period for fund withdrawals initiated by the Company. The notice period may be waived by the trustee at its sole discretion. Withdrawals initiated by participants of the Plan will be honored when received. As of December 31, 2024 and 2023 there were no unfunded commitments, the redemption frequency for participant transactions in the Trust is daily, and there are no participant level notice period redemption requirements.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Employer adopted a profit-sharing plan with a cash or deferred arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020 which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the advisory letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Related-Party Transactions and Party-In-Interest Transactions

Certain investments are shares of registered investment companies and a common/collective trust managed by FMTC. FMTC is the Plan trustee, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan were \$97,554 for the year ended December 31, 2024.

Fidelity or its affiliates receive revenue from certain investments in the Plan. Fidelity and the Company have agreed that if this revenue exceeds an agreed upon revenue rate, Fidelity shall make an amount equal to such excess available to the Plan to either pay ERISA qualified plan administrative expenses or to be allocated to the account of the participants. For the year ended December 31, 2024, an excess of \$27,012 was made available to the Plan. The remaining balance available to pay future expenses was approximately \$165,000 and \$270,000 as of December 31, 2024, and 2023, respectively.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Mutual Fund Fees

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads, or 12b-1 fees. 12b-1 fees, which are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940, are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity and thus not separately identifiable as an expense.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date which the financial statements were available to be issued.
