**Note 1. Description of the Plan**

***General***

The following description of the 401(A) Thrift Plan of Kips Bay Boys & Girls Club, Inc. (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a noncontributory, defined-contribution plan sponsored by the Kips Bay Boys & Girls Club, Inc. (the Club or the Sponsor) for the benefit of its employees who have at least one year of service and are age 21 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Mutual of America Life Insurance Company (Mutual of America) is the custodian of the Plan.

***Contributions***

Employees become eligible to participate in the Plan on the entry date (January 1 or July 1) following the attainment of age 21 and completion of one year of service. Each year, the Club contributes to the Plan 6% of each participating employee's compensation. Participants may not contribute to the Plan.

Rollovers from a qualified retirement plan, 403(b) tax-sheltered annuity, or governmental 457 plan are permitted. Additionally, rollovers from 403(b) annuities may be rolled over if directly rolled over or if rolled over to an IRA. All rollovers are subject to the approval of the Plan Administrator. Rollovers are immediately fully vested.

***Participant Investment Account Options***

Upon enrollment in the Plan, a participant may direct contributions in a variety of investment options with Mutual of America, the custodian of the Plan. Participants may change their investment options at any time.

***Participant Accounts***

Each participant's account is credited with the Sponsor's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Vesting in the Club's contribution portion plus earnings thereon is based on years of service. A participant vests 20% after two years of credited service and 20% each additional year, until 100% vested after six years of credited service. Participants retiring as a result of a permanent disability (as defined for purposes of Social Security disability benefits) immediately become 100% vested in their account balances.

***Notes Receivable from Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator which currently range from 4.60 to 5.85%

***Payment of Benefits***

Upon termination of service due to disability, retirement, or death, married participants (or a spouse upon death) with balances in excess of \$5,000 may elect to receive the vested interest in his or her account in either a lump-sum amount (with spousal approval), rolled over into an eligible retirement plan, or in the form of an annuity. Unmarried participants may only elect the lump-sum or rollover options. For termination of service for other reasons or for account balances of \$5,000 or less, participants may choose distribution through lump-sum or rolled over into an IRA. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts were \$0 and \$6,186, respectively. These accounts will be used to reduce future employer contributions. Also, in 2024, employer contributions were reduced by \$16,348 from forfeited nonvested accounts.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments in pooled separate accounts of the custodian are valued at estimated fair value, which have been determined based on unit values of the accounts as provided by Mutual of America. Quoted market prices, if available, are used to value investments.

The Plan's general investment account with Mutual of America is valued at fair value. The fair value of the general investment account is calculated by the custodian utilizing current interest rates. There are no front-end or back-end charges and the value reflected on the statement is immediately redeemable. The account is similar to a cash equivalent and is issued with variable rates that are periodically adjusted based on changes in economic conditions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Club or the Plan, at the Club's discretion.

**Note 3. Certifications of Plan Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual of America, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are shares of pooled separate accounts and general investment accounts managed by the custodian. These transactions qualify as party-in-interest transactions.

Fees paid by the Plan for investment management services were included as a reduction of the investment return on each fund. In addition, the Plan paid \$1,635 of administrative fees to Mutual of America for the year ended December 31, 2024. The Sponsor provides certain administrative services at no cost to the Plan.

**Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

**Recurring Measurements**

The following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Club has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants still in the employ of the Club on the date of termination will become 100% vested in their account balances, and any unallocated funds remaining after satisfaction of all liabilities under the Plan will be allocated, on a proportional basis, among all participants on the date of termination.

**Note 7. Tax Status**

The Plan, together with the investment vehicles, is intended to be a profit-sharing plan under Section 401(a) of the Internal Revenue Code of 1986, as amended. The Plan has not requested or obtained a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and is not subject to tax.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9. Subsequent Events**

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.
