INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of the
RSH Staffing 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the RSH Staffing 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from the qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by the qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current Plan instrument, including all Plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. 1. Description of Plan

The following description of the RSH Staffing 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more detailed description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of RSH Staffing, LLC (the Company), as defined in the Plan document. The following employees are excluded from participating in the Plan: employees covered under a collective bargaining agreement and non-resident aliens. All employees are eligible for participation after they have completed two months of service and are able to enter the Plan on the first day of the month coinciding after the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2024 and 2023, the Company encountered a layoff of more than 20% of its personnel, resulting in partial plan terminations. Due to the partial plan terminations, all affected participants became fully vested in their Company contributions.

Contributions

The Plan includes an automatic enrollment feature for all eligible participants. The participants will automatically be initially enrolled at 5% of eligible compensation unless the participant elects otherwise. Participants may make pre-tax and/or Roth contributions of up to 100% of eligible compensation, as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024, plus up to an additional \$7,500 catch-up deferral for participants who have reached at least 50 years of age by the end of the year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). In-Plan Roth rollover contributions and conversions are also permitted.

The Company may make a discretionary matching contribution based on a percentage of each participant's deferral, which the matching percentage is determined annually. During 2024, the Company provided discretionary matching contributions equal to 100% of the employee contributions up to 3% of eligible compensation and 50% of the employee contributions up to the next 2% of eligible compensation. The annual maximum match contribution was 4% of eligible compensation if the participant contributed 5% of eligible compensation or more during the year. The Company may make a discretionary profit-sharing contribution on behalf of eligible participants. In 2024, the Company did not make a discretionary profit-sharing contribution.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, Company contributions, earnings and losses on the investments in their account, and is charged with administrative expenses and transaction fees for services received by individual participants. A participant may direct contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and rollover contributions, plus actual earnings and losses thereon. For discretionary matching contributions, discretionary profit-sharing contributions, and earnings and losses thereon, participants vest 20% after 1 year of service, then 20% per year thereafter until they are fully vested after 5 years of service. Participants will become fully vested upon death or total and permanent disability. Participants affected by the partial plan termination in 2024 and 2023 became fully vested in their Company contributions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have two notes outstanding at any time. The notes are secured by the balance in the participant's account. As of December 31, 2024, notes had fixed rates ranging from 5.25% to 10.50% for the term of the note, not to exceed 5 years unless used for the purchase of the participant's primary residence. Principal and interest are paid through payroll deductions. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

Payment of Benefits

At the time of death, disability, termination of employment, or retirement, a participant, with an account balance greater than \$7,000, or their beneficiary may elect to receive a payment of the vested interest in their account in a lump sum distribution or installment payments. Upon severance of employment, participants with account balances of \$7,000 or less will automatically receive a distribution of their account as soon as administratively feasible. Participants are eligible to receive hardship withdrawals when certain conditions are met. After attaining the age 59½, participants may also be eligible to make a withdrawal of all or any part of their vested account.

Forfeited Accounts

Forfeited non-vested account balances totaled \$76,600 and \$3,299 as of December 31, 2024 and 2023, respectively. These accounts may be used to pay administrative expenses or reduce future Company discretionary matching contributions. In 2024, forfeitures of \$236,376 were used to reduce Company discretionary matching contributions.

Administrative Expenses

The Plan permits for payment of operational and administrative expenses and are allocated proportionately based on the value of the account balances. Expenses relating to the acquisition and disposition of investments and specific participant transactions (i.e., loan setup, distribution request, etc.) are charged directly against the appropriate participant's account. These expenses are paid to service providers of the Plan and, therefore, qualify as party-in-interest transactions. The Company pays for certain administrative expenses not paid by the Plan which included the Plan's audit fee and certain recordkeeping expenses. The Company does not expect reimbursement from the Plan for payment of these administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company discretionary matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan and approved by the Company. Discretionary profit-sharing contributions are payable to the Plan once they are approved by the Company. There were no unfunded participant or Company contributions as of December 31, 2024 and 2023.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments. Interest income is recorded when received.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the plan administrator deems the note to be in default, the participant notes receivable balance is reduced and a benefit payment is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the qualified institution.

4. Investments

Plan investments include shares of mutual funds and a money market fund managed by Fidelity. Fidelity is a service provider to the Plan; therefore, transactions in these investments qualify as party-in-interest transactions.

Investments are exposed to various risks such as interest rate, currency, market, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include public healthcare emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds and the money market fund are stated at quoted market prices for the identical security in an active market (Level 1).

The Plan invests in a stable value fund which invests in security-backed contracts that include group annuity contracts, bond funds, and guaranteed investment contracts (GICs), which are general obligations of the insurance companies that issue the contracts. The stable value fund trades daily at the net asset value which is based on contract value of the underlying investments (Level 1). The stable value fund has redemption restrictions that limit the timing of withdrawals. The trustee of the underlying fund has the right to delay any participant-initiated withdrawal for

up to 30 days if it determines that immediate withdrawal may have an adverse impact on the fund and has the right to delay any other withdrawal for up to 12 months.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their Company discretionary matching contributions and Company discretionary profit-sharing contributions.

6. Income Tax Status

Through July 31, 2023, the Plan operated under a pre-approved plan originally created by Retirement Plan Administrators, LLC (RPA). As of August 1, 2023, the Plan moved to a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (pre-approved plan) sponsored by FMR LLC doing business as Fidelity Institutional Asset Management. The Internal Revenue Service has opined and informed FMR LLC by letter dated June 30, 2020, that the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt and has no income subject to unrelated business income tax. The Plan's returns for the past three years are subject to examination by taxing authorities and may change upon examination.
