## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of  
Wesleyan Health Care Center Employee Health Plan  
Marion, Indiana

### Opinion

We have audited the accompanying financial statements of Wesleyan Health Care Center Employee Health Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits – cash basis and the statements of plan's benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits – cash basis and the statements of changes in plan's benefits obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits – cash basis and accumulated plan benefits of Wesleyan Health Care Center Employee Health Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits – cash basis and changes in its accumulated plan benefits for the years then ended, in accordance with the cash basis of accounting.

### Basis for Opinion

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:


- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Wesleyan Health Care Center Employee Health Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Wesleyan Health Care Center Employee Health Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Basis of Accounting**

As described in Note 2 to the financial statements, which describes the basis for accounting, the financial statements are prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

**NOTES TO FINANCIAL STATEMENTS**  
December 31, 2024 and 2023

**1. DESCRIPTION OF THE PLAN**

The following description of the Wesleyan Health Care Center Employee Health Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan provides certain health benefits, including medical, dental and vision benefits, to those employees of Wesleyan Health Care Center and their spouses and dependents who are eligible for coverage under the Plan. All employees who have completed at least 60 days of service and who are working at least 30 hours per week can elect coverage under the Plan. However, employees who are over the age of sixty-five and who have elected Medicare benefits as primary to the benefits provided by the Plan are not eligible to participate. The participating employees are required to make bi-weekly predetermined payroll contributions to help offset the cost of coverage. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Certain plan assets are held in a trust checking account. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**2. SUMMARY OF ACCOUNTING POLICIES**

The Plan's policy is to prepare its financial statements on the cash basis of accounting; consequently, certain additions to plan assets are recognized when received rather than when earned, and certain deductions from plan assets are recognized when cash is disbursed rather than when the obligation is incurred.

Plan obligations at December 31 for health claims incurred by active participants but not reported at that date are estimated by the Plan's third party administrator using actual claims paid for the audit period through August 31, 2025. Such estimated amounts are reported in the accompanying statement of the Plan's benefit obligations at present value, based on a 0% discount rate since they are paid in a short period of time.

The process of preparing financial statements requires the use of estimates and assumptions regarding certain types of assets, liabilities, revenues, and expenses. Such estimates primarily relate to unsettled transactions and events as of the date of the financial statements. Accordingly, upon settlement, actual results may differ from estimated amounts.

**2. SUMMARY OF ACCOUNTING POLICIES (continued)**

Expenses of the third-party claims administrator and other fees are paid by the Plan.

The Plan's management has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

**3. REPORTABLE TRANSACTIONS**

There were no reportable transactions within the plan year in excess of 5 percent of the current value of plan assets for 2024 or 2023.

**4. REINSURANCE**

The Plan maintains a stop-loss insurance policy which provides up to \$1,000,000 of medical coverage per participant per year. For the year ended December 31, 2024 this policy attaches when any participant's claims exceed \$100,000 per individual per year or when the total of qualified net claims paid by the plan exceed \$15,575,123 per year. Certain individuals are subject to a higher specific limit. The life insurance benefits under the Plan are fully insured.

For the year ended December 31, 2023, the specific stop-loss was \$100,000 per covered person and the policy attached when claims paid by the Plan exceeded \$14,905,159 per year.

**5. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA.

**6. FEES**

Administrative fees consist of fees paid to third-party claims administrators. Other fees consist of other administrative expenses, such as bank and audit fees.

**7. CREDIT RISK**

The Plan maintains its cash accounts at two commercial banks. The accounts are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At December 31, 2024, deposits in excess of the insured amount totaled \$4,665,767.

**8. TAX STATUS**

The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)9 of the Internal Revenue Code and, accordingly, the Trust's net investment income is exempt from income taxes.
