Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Stratton Lumber/TRG Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of Stratton Lumber/TRG Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is sponsored by Stratton Lumber, Inc., and Boundary Co. d/b/a Moose River Lumber Co., Inc. and Timber Resource Group, Inc., wholly-owned subsidiaries of Stratton Lumber, inc. (collectively, the Company).

General

The Plan is a defined contribution plan sponsored by the Company. All full-time employees of the Company are eligible to participate in the Plan after completing three consecutive months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute up to 100% of their eligible pre-tax compensation, as defined to the Plan subject to certain Internal Revenue Code (IRC) limitations. In addition, participants' contributions may consist of rollovers from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company provides safe harbor contributions to employees who have attained the age of 18 and completed one year of service equal to 100% of the first 4% of the participant's elective deferrals. The Company may also elect to make discretionary matching contributions in any plan year. There were no discretionary matching contributions made in 2024 or 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, as well as allocations of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always 100% vested in their own contributions, and the Company's safe harbor and discretionary matching contributions, as well as any earnings thereon.

Notes Receivable from Participants

Participants may borrow from their vested account balance, subject to a minimum loan amount of \$1,000 and a maximum loan amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the participant's vested account balance. The interest rate for participant loans is set at 1% above the prime rate, as determined at the time the loan is made (notes bear interest ranging from 4.25% to 9.5% at December 31, 2024). Repayment is made through periodic payroll deductions, with the repayment period generally not exceeding five years, except for loans used to purchase a primary residence, which may have a longer term. Generally, only one outstanding loan is permitted at a time.

Distributions

Generally, no amounts may be distributed to participants from their accounts prior to their termination of employment or their attainment of age 59½ unless the participant has incurred a hardship, as defined.

Expenses of the Plan

Certain administrative expenses, loan initiation and service fees are paid by the Plan and its participants to Commonwealth Equity Services LLC, Capital Group Retirement Services and Downeast Pension Services, Inc. These payments are considered to be party-in-interest transactions although they are not prohibited under ERISA. All other administrative costs are paid by the Company.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in mutual funds are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

The Plan invests in the Reliance Trust Company Stable Value Fund Collective Investment Trust, Series 25053 (the Trust), which invests in the MetLife Group Annuity Contract 25053 and certain other MetLife Group Annuity Contracts. This investment is stated at Net Asset Value (NAV), which is the amount participants would receive if they were to initiate permitted transactions under the Plan. Certain employer-initiated events may limit the Trust's ability to transact at NAV; however, such events are not probable to occur.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as those held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of Benefits

Payments to participants are recorded when paid.

Subsequent Events

Management has considered transactions or events occurring through October 10, 2025, which is the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Fair Value Measurements

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued based on the market prices of the underlying assets.

Collective trust: Valued at the underlying NAV of units held by the Plan at year-end. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

6. Tax Status

The Plan is part of a pre-approved plan. The Internal Revenue Service has determined and informed the trustee by a letter dated June 30, 2020, that the pre-approved plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination; however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Party-In Interest Transactions

In addition to the party-in-interest transactions previously disclosed, certain of the Plans investments are mutual funds managed by affiliates of Capital Bank and Trust Company. These transactions are considered to be party-in-interest transactions, although they are not prohibited under ERISA.
