Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the 2024 financial statements of PROtect, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The 2024 financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion of the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the 2024 Audit of the Financial Statements section:

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Description of Plan

The following description of PROtect, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General: The Plan was established on January 1, 2014, as a defined contribution plan covering the qualified employees of PROtect, LLC (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Members of management serve as the Plan Trustees.

Change in third-party administrators: During 2024, the Plan changed its custodian and record keeper of the Plan from American United Life Insurance Company (AUL) to Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal). The Plan was amended and restated effective April 1, 2024, to transition to a nonstandard preapproved plan adoption agreement sponsored by Principal.

Eligibility: Employees are eligible to participate in the Plan upon the age of 18 years. Prior to October 1, 2024, employees were required to complete six months of eligible service to participate in the Plan for all types of contributions. The Plan was amended effective October 1, 2024, to remove the six-month service requirement for employee elective deferral contributions.

Entry date: Employees may enter the plan on the first day of the calendar quarter coinciding with or following the date they satisfy the Plan's eligibility requirements. The Plan was amended October 1, 2024, to allow entry on the date the employees satisfy the Plan's eligibility requirements. The plan excludes employees classified as independent contractors, nonresident aliens, and bargaining employees from eligibility.

Contributions: Participants may elect to contribute to the Plan, in the form of pretax deferrals or after-tax (Roth) deferrals, up to 100% of their eligible compensation, as defined in the Plan documents, up to the maximum allowable by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are also eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

The Company's contributions are safe harbor nondiscretionary, matching contributions of 100% of the first 3% and 50% of the next 2% of the participant's eligible compensation. The Company may also make additional matching, profit-sharing or discretionary contributions determined annually by the Company's Board of Directors. No such additional discretionary contributions were made for the year ended December 31, 2024. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Participants may change their investment options daily. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately 100% vested in their voluntary contributions and Company safe harbor contributions, plus earnings thereon. Vesting in the Company's nonelective and additional matching contributions plus earnings thereon is based on years of credited service. A participant is fully vested after six years of service, earning 20% after year two and 20% each year after.

Payment of benefits: Upon retirement, termination of service, death or disability, a participant may elect to receive a lump-sum amount equal to the value of their vested balance or substantially equal periodic payments over the expected life of the participant (not to exceed the value of the account), as defined in the Plan. Upon termination, a participant with a balance of less than \$1,000 will automatically be paid out by the Plan, participants with a balance between \$1,000 and \$7,000 can still be automatically paid out if their balance is rolled into a qualified individual retirement account. Distributions may be made at the participant's election prior to termination upon attainment of age 59½, hardship, qualified reservist and in-service withdrawals as defined in the Plan document.

Notes receivable from participants: Participant loans were permitted by the Plan from September 16, 2022 to July 12, 2023. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of a participant's vested account balance or \$50,000, reduced by the highest outstanding loan balance in your account during the prior 12-month period. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate established by the Plan Administrator. Outstanding notes receivable are due through June 2028. Principal and interest is paid ratably through payroll deductions.

Notes receivable from participants have been classified as investment assets for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements are prepared using the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets available for benefits. Actual results could differ from those estimates.

Valuation of investments and income recognition: Fully benefit-responsive investment contracts held by a defined contribution plan are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. All other investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Note 2. Summary of Significant Accounting Policies (Continued)

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses was recorded as of December 31, 2024 and 2023. Delinquent participant notes are recorded as distributions on the basis of the terms of the Plan document.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Contributions: Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the participant compensation is withheld from compensation.

Payment of benefits: Benefit payments to participants are recorded when paid.

Administrative expenses: Certain operating expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' account. Investment-related expenses are included as an offset to net appreciation (depreciation) in the fair value of investments.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

Note 3. Information Certification or Provided by the Plan Custodians

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified as complete and accurate by the current and former custodian. Principal, the current custodian, certified the balances as of December 31, 2024, and AUL, the former custodian, certified the balances as of December 31, 2023, in the table below.

Note 4. Disclosures About Fair Value of Plan Assets

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted, quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the quoted prices of identical shares as determined in active markets, held by the Plan at year-end.

Collective trust fund: The collective trust fund is valued at net asset value (NAV), which is provided by the custodian and used as a practical expedient to estimate fair value. The NAV is based on the fair value of the observable market prices of the underlying assets held by the fund less liabilities.

Pooled separate account: The unit value of pooled separate accounts is calculated based on the observable NAV of the underlying investments at the end of the plan year. The NAV is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Guaranteed Income Fund

The Plan has a fully benefit-responsive guaranteed investment contract (GIC) with Principal Life Insurance Company (Principal Life). Principal Life maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Principal Life. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Principal Life is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract value of the Principal Life investment contract was \$123,658 as of December 31, 2024. The contract value of the AUL Stable Value Fund investment contract was \$2,768 as of December 31, 2023.

The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0.15% or greater than 3%.

As described in Note 2, because the GIC is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIC. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) Plan Sponsor events (for example, divestitures or spin-off of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with the participants are probable of occurring.

If the Plan Sponsor decides to terminate the Plan's interest in the investment contract, there will be a 12-month delay in the payment. The Plan Sponsor may request immediate payment subject to a 10% surrender fee. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7. Tax Status

The Plan adopted a nonstandardized form of a preapproved plan sponsored by Principal. The preapproved plan had obtained an opinion letter dated June 30, 2020, in which the IRS stated that the form of the preapproved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. The Plan Administrator has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has no uncertain tax positions that require adjustment to or disclosure in the financial statements. Therefore, no provision or liability for income taxes is included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Party-in-Interest Transactions

The Company paid certain expenses related to Plan operations and investment activity to various service providers. Certain plan investments as of December 31, 2024, are a pooled separate account, a collective trust fund, and a guaranteed investment contract managed by Principal. These transactions qualify as party-in-interest transactions.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.
