INDEPENDENT AUDITORS' REPORT

To the Board of Trustees
Local 282 Legal Services Trust Fund

Opinion

We have audited the financial statements of Local 282 Legal Services Trust Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in benefit obligations and in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the benefit obligations and net assets available for benefits of Local 282 Legal Services Trust Fund as of December 31, 2024 and 2023, and the changes in benefit obligations and in net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

NOTE 1 – DESCRIPTION OF PLAN

The following description of Local 282 Legal Services Trust Fund (the “Plan”) provides only general information. Participants should refer to the benefit booklet for a more complete description of the Plan's provisions.

General: The Plan was established on January 1, 1979, for the purpose of providing legal benefits to eligible participants and their dependents. The Plan provides participants, eligible for benefits provided by Local 282 Welfare Trust Fund (the “Welfare Trust Fund”), with various legal services, emphasizing the process of educating participants and their dependents of their legal rights and responsibilities. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan was amended to change the Plan year to a calendar year-end effective January 1, 2023.

Plan Administration: The administration of the Plan is the responsibility of a Board of Trustees comprised of Union and Employer Trustees. The Union Trustees and Employer Trustees have equal voting rights.

Benefits: The Plan provides legal benefits to all eligible participants of the Plan through the law firm Trivella & Forte, LLP.

Contributions: The Plan's contributions are made directly to the Welfare Trust Fund by employers in accordance with the collective bargaining agreement between Local 282 of the International Brotherhood of Teamsters (the “Union”) and certain employers. The Plan receives a portion of the employer contributions from the Welfare Trust Fund for the purpose of providing legal benefits on an "as needed" basis. Any net change in net assets is transferred to the Welfare Trust Fund to ensure the Plan shows a zero balance for net assets (see Note 4).

Plan Termination: The Plan may be terminated at any time deemed necessary or appropriate by the Welfare Trust Fund. Upon termination, each participant and dependent being represented by an attorney retained by the Plan shall designate or cause to be designated another attorney not retained by the Plan to represent such individuals in all pending and future matters.

Other: Although they have not expressed any intention to do so, the Plan's Board of Trustees has the right under the Plan to modify benefits provided to participants and to terminate the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements were prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE 3 – TAX STATUS

The Trust established under the Plan to hold the Plan's assets is intended to be qualified pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC), as amended and, accordingly, the trust's net income is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service. The Plan has been amended since receiving the determination letter. However, the Plan's management believes that the Plan currently is designed and is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the related trust is tax exempt. Consequently, no provision for income taxes has been included in the plan's financial statements.

NOTE 4 – TRANSACTIONS WITH PARTY IN INTEREST

Since the Plan is fully funded by the Welfare Trust Fund, the net change in net assets is transferred to the Welfare Trust Fund to ensure the Plan shows a zero balance for net assets.



