

**NOTE 1 – DESCRIPTION OF PLAN**

Forever Orange 401(k) Plan (the Plan) is a qualified retirement plan, covering substantially all eligible employees of Forever Orange, LLC (the Company). The Plan was originally adopted by the Company effective January 1, 2016, to provide employees with the opportunity to save for retirement on a tax-advantaged basis. The Plan was amended effective January 1, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and is administered by the Company.

Significant provisions of the Plan are summarized below. Participants should refer to the legal plan document for a more complete description of the Plan's provisions.

Eligibility: All non-excluded employees of the Company are eligible to participate in the Plan. For purposes of all contributions, employees are eligible to participate in the Plan after two months of service. For purposes of employer contributions, employees who have attained age 21 and have fulfilled a service period of 2 months are eligible for such contributions. Effective January 1, 2024, the age requirement was removed. The entry date will be the first day of the month on or after the employee satisfies the eligibility requirements.

Contributions: Participants may elect to reduce their compensation by a specific percentage or dollar amount and have that amount contributed to the Plan as a salary deferral, not to exceed the dollar limit which is set by law. There are two types of salary deferrals: pre-tax 401(k) deferrals and Roth 401(k) deferrals. Participants who are at least age 50 or will attain age 50 before the end of a calendar year may elect to defer additional amounts called catch-up contributions. The Plan also includes an automatic enrollment feature. The Company will automatically withhold 2% of an eligible employee's compensation and contribute that amount to the Plan as a pre-tax 401(k) deferral, unless the employee modifies or terminates the election. Participants are permitted to begin or change their deferral elections as soon as administratively feasible following the entry date.

The Company may make discretionary matching contributions equal to a uniform percentage of each tier of salary deferrals. Each year, the Company will determine the amount of the discretionary percentage. Currently, the Company matches 100% on the first 1% of participant's salary deferrals, and 25% of elective deferral contributions up to 5% of eligible compensation.

The Company may also make a discretionary nonelective profit sharing contribution to the Plan. To be eligible, participants must be employed on the last day of the year and have completed a year of service. During 2024, the Company did not make any discretionary nonelective profit sharing contributions.

Participants are also permitted to deposit into the Plan distributions received from other retirement plans or certain IRAs as rollover contributions.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeitures of employer profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are always 100% vested in their salary deferrals including pre-tax and Roth 401(k) deferrals, catch-up contributions, rollovers, and any earnings thereon. Vesting for Company contributions is based on vesting years of service. Company matching contributions and discretionary matching contributions are subject to a five-year graded vesting schedule in which participants become 100% vested after five years of service by earning 25% each year after two years of service.

Payment of Benefits: Upon termination of service before normal retirement age, a participant may elect to receive a single lump-sum payment in cash equal to the value of the participant's vested account balance, or to rollover the distribution directly to another qualified plan under section 401 of the Internal Revenue Code (IRC). If a participant's vested account balance does not exceed \$5,000 upon termination of employment, it will be automatically distributed regardless of whether a participant consents to receive it. Upon normal retirement, disability, or death, the participant or beneficiary is entitled to receive the amount credited to their account. Benefits may be paid to the participant in a single lump-sum payment in cash or a direct rollover to another qualified plan. If the participant or their beneficiary is required to take minimum distributions, benefits may be paid in a series of payments as required by the IRC.

Participants may take in-service distributions while still employed with the Company if they are age 59½ or older at the time of the distribution. If a participant has a financial hardship due to immediate and heavy financial need, they may also withdraw from their vested account.

Notes Receivable From Participants: Loans are available to participants on a reasonably equivalent basis. The minimum loan amount is \$1,000 and the maximum amount is the lesser of 50% of the participant's vested account balance in the Plan, or \$50,000 reduced by the highest outstanding loan balance during the prior 12-month period. Loans are adequately secured and charged a commercially reasonable rate of interest. Participants may only have one outstanding loan at any given time, and may only request one loan during any one-year period.

Forfeitures: If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account remains in the Plan and is called a forfeiture. Forfeitures may be used to pay Plan expenses or to offset employer contributions to the Plan. Forfeited non-vested accounts totaled \$42,237 and \$37,972 at December 31, 2024 and 2023, respectively. In 2024, \$6,554 of forfeitures were used to offset administrative expenses and \$13,582 of forfeitures were used to reduce employer contributions.

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participants' accounts will become 100% vested. The Company will direct the distribution of participants' accounts in a manner permitted by the Plan as soon as practicable.

Administrative Expenses: The Plan permits the payment of Plan expenses to be made from the Plan's assets. If expenses are paid using the Plan's assets, then the expenses will generally be allocated among the accounts of all participants in the Plan. There are certain other expenses that may be paid just from a participant's account. These are expenses that are specifically incurred by, or attributable to, a participant.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 8, 2025, which is the date the financial statements were available to be issued.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Excess Contributions: Refunds of excess participant deferral contributions may be required to satisfy the relevant nondiscrimination provisions of the Plan. Such refunds are accrued as a liability and reduction in contributions in the Plan year in which the excess deferrals were made to the Plan.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by The Standard Insurance Company (The Standard).

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

**NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)**

The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund’s net asset value per unit.

**NOTE 5 – PARTY IN INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds units of pooled separate accounts managed by The Standard. The Standard is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees to The Standard qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 6 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
