**INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator of

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the R.G. Johnson Company, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

***Opinion***

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section.

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

NOTE 1      PLAN DESCRIPTION

The following description of the R.G. Johnson Company, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a complete description of the Plan’s provisions.

*General*

The Plan is a defined contribution plan covering substantially all full-time employees of R.G. Johnson Company, Inc. (the Company) who have completed 750 hours of service and attained the age of 18. An employee who has completed one year of service is deemed to have met the service requirement. An eligible employee may enter the Plan on the first day of the following month following eligibility.

*Contributions*

Participants may contribute a percentage of their annual compensation to the Plan on a tax-deferred basis subject to certain limitations. All participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. The Company must contribute a safe harbor matching contribution of 3% of each eligible employee’s compensation regardless of whether the employee makes contributions to the Plan.

The Plan includes an automatic enrollment policy. The deferral rate for eligible employees is automatically set at 4% of their eligible compensation. The deferral rate does not automatically increase each year.

The Plan provides the option to the Plan Sponsor to contribute a discretionary matching contribution. The Plan Sponsor made discretionary matching contributions of 100% of participants’ contributions up to 6% of eligible compensation in 2024. The Company can also make a discretionary profit-sharing contribution.

*Participant Accounts*

Participants directed the investment of their contributions and the Company’s contributions into various investment options offered by the Plan. Each participant’s account is credited with their voluntary contribution and Company contributions and investment income (loss) of the elected investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### *Vesting*

Participants are immediately vested in their contributions and the Company's safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contributions plus actual earnings thereon is based on years of credited service. A participant vests ratably over four years of credited service.

### *Benefits*

On termination of service due to death, disability, or retirement age of 60, a participant becomes eligible to receive a lump-sum amount equal to the value of the participant's vested interest in their account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. If the participant's account balance is less than \$1,000, the Company may make a lump-sum payment without the participant's consent. If a participant's employment is terminated for any reason other than death, disability, or attainment of the participant's retirement age, then the participant shall be entitled to their benefits upon an occurrence of an event which would result in a distributable event had the terminated participant remained in the employ of the employer. Additionally, at the election of the participant, the Plan Administrator shall direct the distribution of the entire vested portion of the terminated participant's account as soon as administratively feasible six months after termination of employment.

### *Participant Loans*

Participant loans are not permitted as defined in the plan document.

### *Forfeiture Accounts*

Forfeited balances of terminated participants' non-vested accounts can be applied to offset administrative expenses of the Plan and to reduce the Company's contributions to the Plan, as defined in the plan document. There were no forfeited balances at December 31, 2024 and 2023.

## NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### *Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). Plan management determines the valuation policies utilizing information provided by Ascensus Trust Company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Payments to Participants*

Benefits are recorded when paid.

#### *Administrative Expenses*

Certain administrative expenses are paid by the Company or the Plan, as provided by the plan document.

#### *Investment Management Fees and Operating Expenses*

Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned daily and are reflected as a component of net appreciation or depreciation in fair values of investments.

### NOTE 3 FAIR VALUE MEASUREMENTS

The Plan performs fair value measurements in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, which defines fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance. ASC 820 also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy establishes three (3) levels of inputs that may be used to measure fair value:

- Level 1 – inputs are unadjusted quoted prices in active markets for identical assets or liabilities;
- Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund on the last day of the Plan's year end using a quoted price in an active market and are classified within Level 1 of the fair value hierarchy.

Common collective trust fund: The Plan invests in the Great Gray Collective Investment Trust III for MetLife Group Annuity Contract No. 25554 Class J (the "Fund"), a common collective trust managed by Great Gray Trust Company, LLC. The Fund is designed to provide safety of principal, adequate liquidity, and a competitive yield with low return volatility. The Fund is invested in a group annuity contract issued by Metropolitan Life Insurance Company ("MetLife"), which guarantees the contract value and provides benefit-responsive features.

The contract value represents contributions made to the Fund, plus earnings, less participant withdrawals and administrative expenses. The fair value of the Fund is based on the underlying investments held in separate accounts by MetLife. The common collective trust fund may be redeemed daily and, as of December 31, 2024 and 2023, the fund has no unfunded commitments. The common collective trust fund is valued using the NAV provided by the trustee on the last day of the Plan's year end. The NAV is based on the value of the underlying assets owned by the trust, minus its liabilities, and then divided by the number of shares outstanding.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Ascensus Trust Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investment information included in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA required supplemental schedule.

#### NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In the event of plan termination, participants become 100% vested in their accounts.

## NOTE 6 TAX STATUS

Effective July 28, 2022, the Plan was restated for regulatory compliance purposes and adopted a pre-approved plan document of Ascensus Trust Company, which received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the restated pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC).

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. Federal, State, or Local tax authorities for years before 2021.

## NOTE 7 RISKS AND UNCERTAINTIES

The Plan's investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with these investments and the level of uncertainty related to changes in the value of these investments, it is at least reasonably possible that changes in the near term could materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

## NOTE 8 RELATED PARTY TRANSACTIONS

Certain plan investments were managed by Ascensus Trust Company, trustee, therefore, these transactions qualify as party-in-interest transactions. The Company pays certain expenses of the Plan. The Company is the Plan Sponsor as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under Section 408(b) of the ERISA regulations.

Certain administrative functions are performed by officers or employees of the Company at no cost to the Plan. These transactions are not deemed prohibited party-in-interest transactions because they are covered by statutory or administrative exemptions from the IRC and ERISA's rules on prohibited transactions.

## NOTE 9 SUBSEQUENT EVENTS

Subsequent events were considered through October 3, 2025, which is the date that financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
