### 1. Description of the Plan

The following description of the HaystackID, LLC Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of HaystackID, LLC (the “Company”), except nonresident aliens, independent contractors, or employees covered by a collective bargaining agreement. Employees who completed three months of service and have attained age 21 are eligible to participate in the Plan on the first day of the month on or after satisfying the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

#### Contributions

The Plan provides for employees salary deferral contributions of a percentage of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions in addition to their regular deferral contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer matching contributions of 100 percent of the first 3 percent of the contributing participant’s elective deferral amount and 50 percent of the next 2 percent of the contributing participant’s elective deferral amount. The Company may, in its discretion, make a true-up contribution for any Plan year.

#### Participant Accounts

Individual accounts are maintained for each participant. Each participant’s account is credited with the participant’s contribution, the Company’s contributions, and an allocation of investment earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable are secured by the balance in the participant’s account and bear interest at the prevailing interest rate (prime plus 1%) at the time of borrowing, as determined by the Plan administrator. Principal and interest are repaid ratably through payroll deductions. The interest rate on the notes receivable from participants ranged from 4.25% to 9.5% as of December 31, 2024 and 2023.

#### Benefits Payments

Upon termination of service, death, disability, or retirement, participants or their beneficiaries may elect to receive, in either a lump sum or partial payment, an amount equal to the value of the participant’s vested interest in his or her account. In-service distributions may be made from a participant’s vested account at any time after the attainment of age 59 ½.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the Plan agreement.

### **Vesting**

Participants' contributions, employer matching contributions, and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

### **Administrative Expenses**

Various administrative costs are paid by the Company.

## **2. Summary of Significant Accounting Policies**

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for their integrity and objectivity. These accounting policies conform to accounting principles generally accepted in the United States of America ("GAAP") and have been consistently applied in the preparation of the financial statements.

### **Basis of Accounting**

The financial statements are prepared on the accrual basis of accounting in accordance with GAAP.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses had been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### **Investment Valuation and Income Recognition**

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

### **Benefit Payments**

Benefit payments are recorded when paid.

### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Subsequent Events**

The Plan has evaluated events through October 9, 2025, the date these financial statements were available to be issued.

### 3. Investment Information Certified by the Trustee

The Company has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, LLC, acting as agent of Ascensus Trust Company, the trustee, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Total investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i – schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to information certified by the trustee, except for comparing such information to the related information included in the above named financial statements and supplemental schedule.

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used for at December 31, 2024 and 2023.

*Mutual funds:* Valued at quoted prices in an active market.

*Money Market Fund:* Valued at quoted prices in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
