Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Employment Solutions, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Employment Solutions, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

1. Description of Plan

The following description of the Employment Solutions, Inc. (the "Company") 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and became effective January 1, 2024. The Plan is administered by Capital Bank and Trust Company.

Eligibility

The Plan covers substantially all employees of the Company. Employees are eligible to participate in the Plan after completing six months of service and 500 work hours, or one year of service. Employees may enter the Plan on the first day of the month after fulfilling the eligibility requirements. Employees covered by a collective bargaining agreement between the Company and employee representatives, leased employees, nonresident aliens and residents of Puerto Rico are not eligible to participate at any time.

Contributions

Each year, participants are permitted to contribute up to 90% of their total annual eligible compensation, as defined in the plan agreement, as a before-tax salary deferral contribution. Participants may also elect to defer a portion of their after-tax compensation as Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company makes an annual safe harbor matching contribution for all participants equal to 100% of the first 5% of compensation contributed by the participant. Contributions from the participant and the Company for the Plan year cannot exceed the maximum limit determined by Internal Revenue Service regulations. The Company may also make discretionary employer matching or nonelective contributions.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contributions and the Plan Sponsor's contributions, an allocation of plan earnings or losses, and administrative expenses. Allocations are based on participant earnings, account balances, or participant transactions as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct their investment of their contributions into various investment options provided by the Plan. If no such direction is made, participant accounts are invested in accordance with default investment alternatives as established under the Plan. The Plan Sponsor's contributions are automatically invested in the same investment options at the same percentage as participant deferral contributions.

1. Description of Plan (Continued)

Benefits and Vesting

The benefit to which a participant is entitled is the benefit which can be provided from the participant's vested accounts, which includes participant and Company contributions and related earnings thereon. Earnings are allocated based on the individual participant's account balance in relation to total participant account balances. Participants are vested immediately in all contribution types as well as earnings on those contributions, other than employer profit sharing contributions and employer matching contributions. Employer profit sharing contributions and employer matching contributions are vested according to a six year graded vesting schedule.

Payment of Benefits

Upon termination of service, a participant may elect to receive the value of the vested interest in his or her account either in via a lump-sum distribution, substantially equal instalments, or a partial withdrawal. For vested account balances under \$5,000, the participant's benefit will be automatically distributed.

Participants may also be entitled to in service distributions for hardship, qualified reservists, deemed severance, or age 59 ½, subject to Plan provisions.

Forfeited Accounts

Forfeited balances of terminated participants' non-vested accounts may be used to reduce future Plan Sponsor matching contributions or to pay reasonable Plan expenses. As of December 31, 2024, there were \$115 in forfeited non-vested accounts.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan. All other administrative expenses are paid by the Plan Sponsor.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the modified cash basis of accounting and present the net assets available for benefits and changes in those net assets. Consequently, certain additions and the related assets are recognized when received rather than when earned and certain deductions are recognized when paid rather than when the obligation is incurred. The modified cash basis of accounting is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

2. Summary of Significant Accounting Policies (Continued)

The net appreciation (depreciation) in fair value for each investment option is included in investment income in the statement of changes in net assets available for benefits. The net appreciation (depreciation) in fair value of investments includes both realized gains and losses on investments sold during the year and unrealized gains and losses on investments held at the end of the year.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Benefits Paid

Benefit payments to participants are recorded upon distribution.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. As of December 31, 2024, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Management's Review of Subsequent Events

The Plan has evaluated and considered the need to recognize or disclose subsequent events through October 9, 2025, which represents the date that these financial statements were available to be issued. Subsequent events past this date, as they pertain to the year ended December 31, 2024, have not been evaluated by the Plan.

3. Information Certified by the Plan's Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company, the custodian of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statement of net assets available for benefits (modified cash basis) as of December 31, 2024 and investment related activity reflected in the statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024.

- Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Tax Status

The Plan is based on a non-standardized defined contribution pre-approved plan, which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC).

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods currently in progress. The Plan's Form 5500 is open for inspection by taxing authorities, generally for three years after being filed.

6. Party-in-Interest Transactions

Certain investments in the Plan are managed by Capital Bank and Trust Company, the custodian of the plan. Therefore, these transactions qualify as party-in-interest transactions.

Certain employees and officers of the Company, who are also participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

The Plan pays certain investment advisory, Plan recordkeeping, and third-party administration fees to Nova 401K Associates, Capital Retirement Group Plan Services, and Raymond James Financial, Inc. which are parties-in-interest to the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all amounts credited to participant accounts will be fully vested and will be paid to the participants. In case of a partial termination, only those affected will become fully vested.

8. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Plan Transfer of Assets

The Plan Sponsor was previously a member of a pooled employer plan with Securian Financial. During 2024, the Plan Sponsor transferred the assets from Securian Financial into the Employment Solutions, Inc. 401(k) Plan. Assets transferred from the pooled employer plan totaled \$4,052,800.
