### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of First Security Bank Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### 1. DESCRIPTION OF PLAN AND OTHER MATTERS

The following brief description of the First Security Bank Employee Stock Ownership Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for complete information.

#### *General*

Security Capital Corporation (Company) established the First Security Bank Employee Stock Ownership Plan (Plan) effective as of January 1, 1985. The Plan operates, in relevant part, as an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). As such, essentially all investments are in the Company's common stock. The Plan is administered by First Security Bank's Board of Directors. The trust department of the First Security Bank is the Plan's Trustee.

#### *Eligibility*

Employees of the Company and its participating subsidiaries who have attained the age of 21 are generally eligible to participate in the Plan after one year of service, providing they worked at least 1,000 hours during such year. Participants are eligible to share in the employer contribution for the year unless they separate from service and have worked less than 500 hours in the Plan year.

#### *Employer Contributions*

The Company may make contributions in cash or Company common shares to the plan as the Company determines. For the years ended December 31, 2024 and 2023, the Company contributed \$455,535 and \$426,358, respectively, to the Plan. During 2024, the company declared a 25% stock dividend resulting in 110,765 additional shares. Employees are not permitted to make contributions.

#### *Payment of Benefits*

Except as noted below, no distributions from the Plan will be made until a participant retires, dies (in which case, payment shall be made to his or her beneficiary, or, if none, to his or her legal representative), or otherwise terminates employment with the Company and its participating subsidiaries. Distributions are made in cash or, if a participant elects, in the form of Company common stock plus cash for any fractional share of common stock.

Under the provisions of the Plan, the participants can put their shares in the Company at the latest annual independent appraisal value or submit their shares for sale at the next auction price.

### *Expenses*

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company.

### *Voting Rights*

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant.

### *Participant Accounts*

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations of the Companies' contributions are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balance.

### *Vesting*

If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, the participant will vest in the balances in his or her account based on total years of service with the Company. For any participant who completes at least one hour of service in a plan beginning after December 31, 2006, the following vesting schedule will apply. Additionally, in accordance with the HEART ACT, a participant that dies while performing qualified military service will receive credit for such military service as service for vesting purposes, as though the participant had resumed employment under USERRA immediately prior to the participant's death.

### *Put Option*

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

### *Diversification*

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution.

### *Plan Termination*

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

Upon termination of the Plan, the Administrator shall direct the Trustee to pay all liabilities and expenses of the trust fund and to sell shares of financed common stock held in a loan suspense account to the extent it determines such sale to be necessary in order to repay any loans due from the Plan.

### *Forfeitures*

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures allocated to participants during the year ended December 31, 2024 and 2023, totaled \$36,034 and 0, respectively.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting. Investments held by a defined contribution plan are required to be reported at fair value.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is determined by annual independent appraisals. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is accrued on the ex-dividend date. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Subsequent Events*

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The valuation process involves the selection of an independent appraiser annually. Plan management accumulates the data for the appraiser from historical and projected financial information of the Companies. The appraiser prepares a report of the per share value of the Corporation.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market account:* Valued at amortized cost, which approximates fair value.

*Investment in Sponsor Company:* The fair value of Security Capital Corporation common stock held by the Plan is valued at estimated fair value based upon an independent appraisal. This appraisal was based upon the use of standard techniques and practices and involved due diligence on behalf of the appraiser.

*Collective investment fund:* This is a daily-valued collective investment fund that seeks to maintain a stable value of \$10.00 per unit of participation. The fund’s investment objective is stability of principal and high current income. The fund pursues this investment objective by investing primarily in stable value products including traditional guaranteed investment contracts (“GICs”) and synthetic GICs. The fund’s underlying asset information (with its own FASB ASC 820 disclosure) is available from Federated Investors.

### 7. INCOME TAX STATUS

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated April 10, 2015, stating that the Plan is in compliance with the applicable requirements under the appropriate section of the Internal Revenue Code.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with such investment securities and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in risk in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
