Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Engineers Construction, Inc. 401(k) Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. 1) Description of the Plan

The following description of the Engineers Construction, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan's provisions.

General - The Plan is a 401(k) retirement plan covering substantially all employees, except union employees, leased employees and nonresident aliens, of Engineers Construction, Inc. (the "Company"). Participants can join the Plan upon attaining the age of 21 years and 3 months of service. Unless an affirmative election is made, participants are auto enrolled in the Plan at a 3% deferral rate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Contributions consist of employee salary deferrals and employer contributions. Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, up to Internal Revenue Code (IRC) contribution limits. Employees that reach 50 years old and over by the end of the year are allowed to make catch up contributions not to exceed Internal Revenue Service (IRS) established limits. Participants can roll over part or all of an eligible rollover distribution from another qualified plan to the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Company makes a safe harbor nonelective contribution to all employees of 3% of the total eligible compensation. Additional profit sharing contributions may be contributed at the discretion of the Company's Board of Directors. The Company elected to make a profit sharing contribution of 3.04% and 1.5% of eligible compensation for 2024 and 2023, respectively.

Participant accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and, (b) Plan earnings, and charged with an allocation of investment expenses. Allocations are based on eligible participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions and the safe harbor nonelective contributions, plus actual earnings thereon. Vesting in the Company's profit sharing contribution of their accounts plus actual earnings thereon is based on years of credited service. Participants will earn 20% vesting per year after two years of service. A participant is 100% vested after six years of credited service.

Payment of benefits - Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, annual installments over a period of time not to exceed the participant's life expectancy, or the joint life expectancy of the participant and their beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. Non-vested portions are maintained by the Plan in the forfeiture account. The Plan allows for vested account balances less than \$5,000 to be automatically distributed without participant consent.

Notes receivable - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested interest, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a constant rate throughout the term. These loans are granted only for reasons of financial hardship.

Forfeited accounts - Forfeitures are used to reduce future employer contributions or pay expenses. Total forfeitures used in 2024 and 2023 were \$4,855 and \$934, respectively. Forfeited non-vested accounts at December 31, 2024 and 2023 totaled \$9,664 and \$4,283, respectively.

2) Summary of Significant Accounting Policies

Basis of presentation - The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition - Investments are stated at fair value using quoted market prices in active markets. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits - Benefits are recorded when paid.

Administrative costs - The Plan pays certain record keeping and custodian fees. Other administrative costs of the Plan are paid by the Company.

Risks and uncertainties - The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

Notes receivable - Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Newport Trust Company and Ascensus, LLC, the custodian of the Plan assets, certified to the completeness and accuracy of all investments on the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, the schedule of assets held for investment purposes as of December 31, 2024, and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023.

4) Fair Value Measurements

Generally accepted accounting principles establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Additionally, the Company may amend the Plan at any time without the consent of any participant or any beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.

6) Tax Status

The Plan is based on a prototype plan that has received a determination letter as a prototype non-standardized plan, which is acceptable under Section 401 of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7) Parties-in-Interest

The Plan has a number of service providers. Such parties are considered parties-in-interest under ERISA.

8) Withdrawing Participants

There were no distributions requested by participants in 2024 but not paid until 2025.
