INDEPENDENT AUDITORS' REPORT

To the Trustee

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of BrightKey, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have audits of BrightKey, Inc. 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

1. Plan Description

The following description of the BrightKey, Inc. (Company) 401(k) Retirement Plan (Plan) provides only general information. Participants and interested parties should refer to the Plan agreement for a more complete description of the Plan's provisions.

- a. General - The Plan became effective on January 1, 1997, and is a defined contribution plan covering substantially all employees of the Company who have six consecutive months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is not subject to Pension Benefit Guarantee Corporation Coverage.
- b. Contributions - Participants may make voluntary contributions to the Plan. The amount that may be contributed is limited by the Internal Revenue Code applicable to the type of plan. Participants are automatically enrolled in the Plan upon becoming eligible. Elective deferrals of 1% of compensation are contributed automatically unless otherwise elected by the participant.

The Company matches a percentage, which is determined every year, of the participants' contributions. A participant must be employed on the last day of the year to be eligible for a matching contribution. The Company also may make a discretionary contribution, but no such contribution was made for the year ended December 31, 2024. Investments of contributions are participant-directed.

- c. Participant Accounts - Each participant's account is credited with the participant's contribution, the Company's match, and an allocation of (a) the Company's discretionary contributions, (b) plan earnings, and (c) forfeitures of terminated participants' non-vested accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.
- d. Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting on the remainder of their account is based on years of service with a minimum of 1,000 hours of service. Participants vest 20% annually after two years of service with full vesting after four years. Participants, however, are fully vested upon retirement, death, disability, early retirement age, or plan termination, as defined in the Plan document.
- e. Payment of Benefits - Upon termination of service, a participant is entitled to the benefit that can be provided from that participant's account.

1. Plan Description (continued)

- f. Participant Loans - Participants may elect to borrow from their accounts the lesser of 50% of the vested account balance or \$50,000 reduced by any outstanding loan balance, with a minimum loan of \$1,000. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.
- g. Forfeited Accounts - Forfeitures are allocated to participants in the same manner as employer contributions. Forfeitures were used to reduce employer contributions in the amount of \$15,150 during 2024. The forfeitures balance in the forfeiture holding account totaled \$10,605 and \$14,730 as of December 31, 2024 and 2023, respectively.

2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results, including realization of assets, could differ from those estimates.

Investment Valuation and Income Recognition

Investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued interest. Delinquent loans are reclassified as distributions based upon the terms of the plan document.

Payments of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses for maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' account and are included in administrative expenses. Investment related expenses are included in net appreciation/ depreciation in fair value of investments.

Subsequent events

Management has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable, typically with little, if any, market activity.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in *registered investments (mutual funds)* of The Vanguard Group (Vanguard) are carried at their estimated market value provided by Vanguard, representing reported prices of the units held by the Plan at year-end.

4. Investment certifications

Ascensus Trust Company, the trustee of the Plan's investments, was responsible for collecting receipts and handling trust asset transactions. The trustee has certified all Plan investments, receipt and disbursements included in the accompanying financial statements for the applicable periods.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time or to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

6. Tax Status

The Company has received an opinion letter from the Internal Revenue Service that the Plan and related trust are designed in accordance with Section 401(a) of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe the Plan is designed and currently being operated in accordance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Party-in-interest

The Vanguard Group is a related party of Ascensus Trust Company, the trustee and Ascensus LLC, the Plan's record keeper and is a party-in-interest as defined by ERISA as a result of investing plan assets in its funds, as discussed in Notes 3 and 4.
