NOTE 1: DESCRIPTION OF PLAN

The following description of the Kleen-Rite Corporation 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a safe harbor defined contribution plan with a 401(k) provision. The Plan is a prototype Plan sponsored by The Retirement Advantage, Inc. The Plan was adopted by Kleen-Rite Corporation (the sponsor employer), Kleen-Rite Transportation (participating employer), 16th Street Corporation (participating employer), Best Price Propane (participating employer) and Ship-Rite (participating employer) herein referred to as "the Companies". The Plan covers all employees of the Companies, except union employees, nonresident aliens and leased employees, who have attained age 21 and have completed six months of service. The Plan is subject to the provisions of ERISA.

Contributions

Each year participants may contribute up to 100% of their annual pretax compensation, as defined in the Plan; however, the participant's contribution cannot exceed amounts allowable under applicable federal regulations. In addition, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Companies also contribute a nonelective employer contribution of 3% of eligible compensation to all participants who have met the eligibility requirements. The Companies may also make discretionary matching contributions and profit sharing contributions. Contributions are subject to certain IRS limitations. Participants direct the investment of all contributions into various investment options offered by the Plan. For the Plan years ending December 31, 2024 and 2023, the Companies made nonelective contributions of \$266,209 and \$242,561, respectively, to the Plan. For the Plan years ending December 31, 2024 and 2023, the Companies made profit sharing contributions of \$335,885 and \$336,527, respectively, to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Companies' nonelective and discretionary contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Companies' nonelective contributions plus actual earnings thereon. Vesting in the Companies' discretionary contributions is based upon years of continuous service. A participant is 100% vested after two years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participants' accounts and bear interest at 1% above prime rate, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Participants are allowed to have only one loan outstanding at a given time.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested account balance, a direct rollover to another retirement plan or individual retirement account, or periodic installments over a fixed period of time. In-service withdrawals are available to participants who have attained age 59 1/2 or have reached the Plan's normal retirement age, which is 65. A participant may request a hardship withdrawal of all or part of the eligible balance in his or her account.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$17,973 and \$15,546, respectively. These accounts can be used to reduce administrative expenses or reduce employer contributions. During the years ended December 31, 2024 and 2023, \$9,573 and \$31,965 of forfeited balances and the related earnings were used to reduce administrative expenses, respectively.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value.) Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator and Plan sponsor management determine the Plan's valuation policies utilizing information provided by investment advisors and the Plan's trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Companies pay nearly all administrative costs of maintaining the Plan. Investment related expenses are charged directly to the participant's account, which are recorded as administrative expenses in the statements of changes in net assets available for benefits.

Subsequent Events

Events that occurred subsequent to December 31, 2024, have been evaluated by the Plan through October 7, 2025, which is the date the financial statements were available to be issued.

NOTE 3: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market and mutual funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The mutual funds are required to publish their daily net asset values and to transact at those prices. The mutual funds are deemed to be actively traded.

Collective investment trust

Valued at net asset value, which is not publicly quoted, but is available to current Plan participants on their online accounts. The investments can be redeemed at the option of the investor of the funds. There are no circumstances noted in which redeemable investments might not be redeemed.

NOTE 4: INCOME TAX STATUS

The Plan has adopted a prototype document that was restated to comply with various tax law changes. The latest prototype Plan received a favorable opinion letter dated June 30, 2020. Plans that use prototype documents are not required to file for an individual determination letter.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5: PLAN TERMINATION

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their employer contributions.

NOTE 6: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7: RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Capital Bank and Trust Company. Capital Bank and Trust Company is the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. The fair value of these funds totaled \$12,616,372 and \$10,810,414 at December 31, 2024 and 2023, respectively. The Plan paid no administrative fees to Capital Bank and Trust Company during the years ended December 31, 2024 and 2023.

As previously discussed, the Plan may issue notes receivable to participants that are secured by participant account balances. Participant loans totaled \$122,058 and \$110,084 at December 31, 2024 and 2023, respectively. Interest income from participant loans was \$7,329 and \$7,021 for the years ended December 31, 2024 and 2023, respectively. All of these transactions qualify as party-in-interest transactions.

NOTE 8: INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the years then ended, was obtained and derived from information supplied to the Plan administrator and certified as complete and accurate by Capital Bank and Trust Company, the trustee of the Plan.
