## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Feldco 401(k) Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Feldco 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. #### **NOTE 1 – PLAN DESCRIPTION**

The following description of Feldco 401(k) Plan (the "Plan") provides only general information. The Plan document, related adoption agreement, and individual statements provided to each Plan participant should be referred to for more complete information.

##### **A. GENERAL**

The Plan is a profit sharing and defined contribution plan under the provisions of Section 401(a) of the United States Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company and any adopting participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as certain provisions of the federal income tax laws.

The Plan covers all employees of Feldco Factory Direct, LLC, Feldco Factory Direct National, LLC (a wholly owned subsidiary of Feldco Factory Direct, LLC), and Trio Management Inc. (a wholly-owned subsidiary of Feldco Factory Direct, LLC) (collectively the "Company").

The Plan investments are administered and held in a trust by the Plan's investment custodian, John Hancock Life Insurance Company (the "Investment Custodian"), which also serves as the recordkeeper of the Plan. The Plan administrator is responsible for overseeing and ensuring compliance with the Plan document. The Investment Custodian, recordkeeper and the Plan administrator are appointed by the Company.

##### **B. ELIGIBILITY**

All employees are eligible to participate in the Plan who meet the eligibility requirements, except those individuals classified as union employees, non-resident employees, or Puerto Rico employees. Eligibility requirements are 60 days of service with no age requirement. Employees can enter the Plan on the first day of the calendar month, coincident with or next following the date the requirements are met.

##### **C. CONTRIBUTIONS**

Under the Plan, participants are allowed to defer a portion of their compensation under a salary reduction agreement. Elective deferrals may be made in any amount between one percent and ninety percent of eligible compensation, subject to certain maximum limitations imposed by the IRC. "Compensation" is defined as a participant's W-2 earnings. Participants may change elective deferral elections on the first day of each month of the Plan year.

Eligible employees are automatically enrolled in the Plan at a contribution rate of six percent of eligible compensation. This rate automatically increases by one percent annually, up to a maximum of twelve percent, unless the employee elects otherwise. Employees who do not wish to participate must actively opt out of the Plan.

The Company makes contributions to the Plan equal to a discretionary percentage on behalf of eligible participants that are employed at the end of the Plan year and meet the minimum hours requirement. For the years ended December 31, 2024 and 2023, the discretionary match totaled 6% of an employee's contribution during the year. The employer match is determined subsequent to year-end.

##### **C. CONTRIBUTIONS – (CONTINUED) –**

A Plan participant may make a transfer to the Plan of a benefit from a qualified retirement plan of another employer, referred to as a rollover, with certain restrictions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

##### **D. PARTICIPANT ACCOUNTS**

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan administrator establishes and maintains a separate account for each participant, which is credited with rollover and voluntary contributions the participants make, Company contributions, and Plan earnings, gains, losses and expenses. Income earned and net appreciation or depreciation on Plan investments, for a given investment, are allocated in proportion to the participant's account balances in that fund. A participant is entitled to the amount in his or her vested Plan account.

##### **E. NOTES RECEIVABLE FROM PARTICIPANTS**

Participants who are active employees may borrow against their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The loans, in the form of promissory notes, are secured by the balance in the participant's account, and bear interest at reasonable rates, which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions and generally repaid within 5 years. Participants may not have more than one loan outstanding at any time.

##### **F. VESTING**

Participants are 100% vested in their voluntary contributions or rollover contributions made to the Plan. In the case of the employer's discretionary contributions, the Plan uses a graduated scale for vesting:

A participant becomes fully vested upon attainment of normal retirement age while an employee, death while an employee, or upon suffering a disability while an employee. Vesting years are subject to a minimum hours requirement.

##### **G. PAYMENT OF BENEFITS**

On termination of service due to death, disability, retirement, or other reasons, a participant is entitled to receive the value of his or her vested account balance. Distributions may also be elected upon attainment of age 59½ or in the case of financial hardship, as defined by the Plan agreement.

##### **G. PAYMENT OF BENEFITS – (CONTINUED) –**

The Plan defines normal retirement age as 65. At the normal retirement date, or upon earlier termination of service, disability, or death, a participant (or the participant's beneficiary) is entitled to 100% of the vested account balance.

Benefits are generally paid in a single lump sum; however, installment options may be available subject to Plan provisions and applicable IRS minimum distribution requirements. Spousal beneficiaries may elect a direct rollover to an IRA.

For participants with vested account balances of \$200 or less, the Plan provides for an automatic cash distribution following termination of employment. If the vested balance exceeds \$200 but does not exceed \$5,000, the Plan provides for an automatic rollover to an IRA unless the participant elects otherwise. For balances greater than \$5,000, participants may elect to receive benefits in the form of a lump sum or installments, as permitted under the Plan.

##### **H. PLAN EXPENSES**

Administrative expenses, including preparation fees for filing the annual return with the Internal Revenue Service, costs associated with the annual audit of the plan, and record-keeping and custodian fees are to be paid out of the Plan or by the Company. Administrative expenses that are to be paid from the Plan are first paid from forfeitures, if any, and any remaining amounts are paid from the Plan's trust funds and allocated to all participants on a pro rata basis. Certain expenses relating to the administration of the Plan have been paid by the Company and are not significant to the operation of the Plan.

##### **I. PLAN TERMINATION**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, no further contributions will be made to the Plan and all amounts credited to the participant's account will become 100% vested. The Company will direct the distribution of the participant's account in a manner permitted by the Plan as soon as practicable. Presently, there is no intention on the part of the Company to terminate the Plan.

#### **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### **A. FINANCIAL REPORTING FRAMEWORK AND BASIS OF ACCOUNTING**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with U.S. GAAP, as promulgated by the Financial Accounting Standards Board ("FASB") in the Accounting Standards Codification ("ASC").

##### **B. ESTIMATES**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments, including realized gains and losses on sales during the year and current changes in unrealized appreciation (depreciation) in the market value of investments held at year end, is presented in the statement of changes in net assets available for benefits.

##### **D. CONTRIBUTIONS**

Contributions from Plan participants and employer contributions, if any, are recorded in the year in which the participant contributions are withheld from compensation.

##### **E. NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make scheduled repayments and the Plan Administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced and a benefit payment recorded. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

##### **F. PAYMENT OF BENEFITS**

Benefit payments to participants or beneficiaries are recorded when paid.

##### **G. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is, at least, reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

##### **H. SUBSEQUENT EVENTS**

The Plan evaluated subsequent events through October 10, 2025, which is the financial statement issuance date. All items which are required for disclosure have been included in the accompanying financial statements and notes thereto.

#### **NOTE 3 – FORFEITURES**

According to the Plan document, forfeitures are to be used to pay for administrative expenses and to be applied to future employer matching contributions. Forfeited, non-vested account balances amounted to \$4,515 and \$2,179 as of December 31, 2024 and 2023, respectively. Approximately, \$2,311 of forfeitures was used to pay certain administrative expenses in the plan year ended December 31, 2024.

#### **NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEES**

The Plan's investments are held in a trust fund administered by the Investment Custodian, the trustee of the Plan. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by the Trustee.

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income (loss), interest income on notes receivable from participants, and other income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### **NOTE 5 – TAX STATUS**

The Plan sponsor adopted a plan which received a favorable determination letter from the Internal Revenue Service dated June 30, 2020, which states that the Plan is designed in accordance with the applicable sections of the IRC and is, therefore, not subject to tax under present income tax law. The Plan has been amended since receiving the determination letter. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, based on the technical merits, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

#### **NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator ("TPA"), investment managers, investment advisors, legal counsel, and Plan auditor.

#### **NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS – (CONTINUED) –**

Certain Plan investments are shares in mutual funds managed by the Investment Custodian therefore, these transactions qualify as party-in-interest transactions. As of December 31, 2024 and 2023, there were investments that qualify as party-in-interest transactions totaling \$435,903 and \$585,507, respectively. The Plan also has notes receivable from participants that qualify as party-in-interest transactions. The total of the notes receivable from participants were \$321,747 and \$208,349 for the years ended December 31, 2024 and 2023, respectively.

#### **NOTE 7 – FAIR VALUE MEASUREMENTS**

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement).

In accordance with the framework, the Plan groups assets and liabilities measured at fair value into three levels based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value. These levels are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuations techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts* – separate accounts are valued at their “accumulation unit value” (AUV). The separate account is valued daily as the number of accumulation units held multiplied by the AUV. The AUV is determined daily based on the net asset value of shares of the underlying fund, the fund's dividends, and the Plan's contract account charges. Since the AUV is determined based on a combination of the fund NAV and the separate account charges, Level 2 was deemed the proper classification.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
