We have performed an audit of the financial statements of RM Acquisition, LLC d/b/a Rand McNally 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

### 1. Description of the Plan

The following brief description of the RM Acquisition, LLC d/b/a Rand McNally 401(k) Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

#### *General*

The Plan is a defined contribution plan and was adopted by RM Acquisition, LLC (the Company or Employer) effective January 1, 1990 and restated on March 1, 2024, to provide deferred tax benefits, savings, and Company contributions to eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### *Eligibility*

The Plan covers substantially all employees of the Company, except employees covered by a collective bargaining agreement, non-resident aliens, leased employees, and employees who reside in Puerto Rico. Employees are permitted to enter the Plan on the date the entry requirements are satisfied.

#### *Contributions*

Participants may elect to make pre-tax contributions and/or after-tax (Roth) contributions up to the dollar limitation of the Internal Revenue Code (IRC). Participants aged 50 and older may also elect to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a discretionary matching contribution determined and calculated each payroll period. The Company elected to match 50% up to 4% of eligible compensation.

#### *Participant Accounts*

Each Participant's account is credited with the Participant's contributions, rollovers, the Employer matching contribution, and earnings (losses) on the investments in their account and is charged with transaction fees for services received by the Participant. Participants direct the investment of their account into various investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

#### *Vesting*

Participants are fully vested in their salary deferrals, rollovers, and the related earnings (losses) upon entry into the Plan. Employer contributions vest 50% after completion of one full year of vesting service and are 100% vested after two years of continuous service.

### 1. Description of the Plan (cont.)

#### *Payment of Benefits*

A Participant's contributions and vested Company contributions may be withdrawn upon retirement on or after the attainment of normal retirement age, termination of employment, or death. For account balances of terminated Participants that are less than \$7,000, balances will be involuntarily cashed out. Under certain qualifying circumstances, hardship withdrawals are permitted under the Plan. In-service withdrawals are allowed for Participants who have attained age 59½.

#### *Notes Receivable from Participants*

A Participant may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes are secured by the Participant's account balance and bear interest at a reasonable rate of interest as determined by the trustee, based on prevailing interest rates charged for similar loans in the loan market. Loans must be repaid within 5 years.

#### *Forfeitures*

At December 31, 2024 and 2023, forfeited accounts totaled \$67,775 and \$22,254, respectively. Forfeitures can be used to reduce Company contributions or Plan expenses. During the year ended December 31, 2024, forfeitures in the amount of \$15,780 were used to pay Plan expenses.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan were prepared using the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

#### *Investment Valuation and Income (Loss) Recognition*

The investments of the Plan are reported at fair value with the exception of fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measurement for that portion of the net assets available for benefits because contract value is the amount Participants normally would receive if they initiate permitted transactions under the terms of the Plan.

The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for information on fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### 2. Summary of Significant Accounting Policies (cont.)

#### *Contributions*

Contributions from Plan Participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### *Notes Receivable*

Notes receivable from Participants represent Participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from Participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a Participant ceases to make loan repayments and the Plan administrator deems the Participant loan to be a distribution, the Participant loan balance is reduced, and a benefit payment is recorded.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Plan Expenses*

Administrative expenses of the Plan are paid by either the Company or by the Plan, as determined by the Plan administrator. These expenses may include, but are not limited to, legal fees, accounting fees, recordkeeping fees, and other fees for services provided to the Plan.

The Plan participates in a revenue credit program. Income from the revenue credit program can be used to pay Plan expenses. The Plan used no revenue credits to pay Plan expenses for the year ended December 31, 2024. The revenue credit program account balance was \$13,757 and \$12,976 at December 31, 2024 and 2023, respectively.

### 3. Certified Information

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company (collectively "Principal"), the Custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the period March 1, 2024 through December 31, 2024. Vanguard Fiduciary Trust Company (Vanguard), the Custodian of the Plan through February 24, 2024 has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2023, and the period from January 1, 2024 through February 29, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by qualified institutions.

### 4. Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

#### *Basis of Fair Value Measurements*

*Level 1* - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

*Level 2* - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

*Level 3* - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies* - Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts* - The fair value of the pooled separate accounts is based on the NAV of the account calculated based on the NAV of the underlying investments. The NAV is used as a practical expedient to estimate fair value.

*Common Collective Trusts* - Valued at the net asset value using NAV as the practical expedient based on the last reported sales price of the underlying investments held. The Plan's interest in the collective trust funds is based on information using the audited financial statements of the collective trust funds at year-end. The investment income (loss) is allocated to Participants based on their proportionate share of the net assets of the funds.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Investment in Insurance Contract

Principal Fixed Income Guaranteed Option is a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (PLIC). PLIC maintains the contributions in a separate account. The account is credited with earnings (losses) on the underlying investments and charged for Participant withdrawals and administrative expenses. PLIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. PLIC makes this guarantee, and although PLIC may credit a higher interest rate, the credited interest rate will not fall below the lifetime guaranteed minimum of 2.5%.

### 5. Investment in Insurance Contract (cont.)

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported to the Plan by PLIC, represents contributions made under the contract, plus credited interest, less Participant withdrawals and fees. Participants ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with TLIC. Such events include the following: (1) the Plan no longer meets applicable requirements of the Internal Revenue Code and/or ERISA, (2) deposits are not received by TLIC on a timely basis, (3) TLIC determines that it can no longer continue to provide benefits under this Contract because of a change in the Plan, (4) the Company files or has filed against it a petition for bankruptcy. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with Plan Participants, is probable.

### 6. Tax Status

For the period from January 1, 2023 through February 29, 2024, the Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (Vanguard pre-approved plan), sponsored by The Vanguard Group. The Internal Revenue Service (IRS) has opined and informed The Vanguard Group by a letter dated June 30, 2020, stating that the form of the Vanguard pre-approved plan document was in compliance with the applicable requirements of the IRC.

For the period from March 1, 2024 through December 31, 2024, the Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (Principal pre-approved plan), sponsored by PLIC. The IRS has opined and informed Principal by letter dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. The Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants will become 100% vested in their accounts.

### 8. Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others. Vanguard performed services and maintained certain investments of the Plan for the period from January 1, 2023 through February 29, 2024 and Principal performs services and maintains certain investments of the Plan starting March 1, 2024 through December 31, 2024, for which fees are charged to the Plan. Party-in-interest transactions also include notes receivables from Participants. Such transactions, while considered party-in-interest transactions under ERISA, are permitted under the provisions of the Plan and are specifically exempt from the prohibited transaction rules.

### 9. Risks and Uncertainties

The Plan's investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect Participant's account balances and amounts reported in the statements of net assets available for benefits.

At December 31, 2024, 33% of the Plan's investments were invested in the Principal Large Cap S&P 500 Index Separate Account Fund.

### 10. Delinquent Participant Contributions

During 2022, employee withholdings of \$684 were not remitted by the Company within the time period described in that regulation. Plan management intends to remit these 2022 contributions, including lost earnings, during 2025. These transactions constituted prohibited transactions as defined by ERISA.

### 11. SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

### 12. Subsequent Events

The Plan has evaluated, for consideration of recognition or disclosure, subsequent events that have occurred through the date of issuance, October 06, 2025, and has determined that no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on these financial statements.
