### Note 1: Description of Plan

The following description of the Pioneer Technical Services, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Pioneer Technical Services, Inc. (the "Sponsor") who have six consecutive months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Eligibility

Employees are eligible to participate in salary deferral contributions and safe harbor matching contributions after six consecutive months of work completing at least one hour of service during that time and having attained the age of 21. If an employee does not complete at least one hour of service during the first six months of employment, they will then have to complete one year of service. Employees are eligible to participate in discretionary profit sharing contribution after one year of service and having attained the age of 21. An employee will have completed one year of service if at the end of their first twelve months of employment they have been credited with at least 1,000 hours of service. If the employee does not complete 1,000 hours of service within the first twelve months of employment, the employee will satisfy the service requirement at the end of any following plan year during which the employee was credited with 1,000 hours of service. Employees are allowed to enter the Plan quarterly on the 1<sup>st</sup> of January, April, July and October, immediately following the date the eligibility requirements are met. The Plan's trustees are responsible for oversight of the Plan.

#### Contributions

Each year, participants may contribute a specific percentage or dollar amount of their compensation, as defined in the Plan, as either pre-tax or Roth after-tax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Sponsor contributes matching contributions equal to the sum of 100% of the amount of the participant's deferrals that are not in excess of 3% of the participant's compensation, plus 50% of the participants elective deferrals that exceed 3% of the participants compensation but are not in excess of 5% of the participants compensation. The Sponsor may also elect to make a discretionary profit sharing contribution to the Plan for a given year. The discretionary contribution may be determined as a uniform percentage of compensation or as a uniform dollar amount. For the Plan year ending December 31, 2024, the Sponsor made safe harbor matching contributions of \$393,908. The Sponsor did not elect to make a discretionary profit sharing contribution for the year ending December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Sponsor safe harbor matching contributions, and allocations of (a) the Sponsor's discretionary profit sharing contribution and (b) plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions and safe harbor match contributions plus actual earnings (losses) thereon. Vesting in the Sponsor's discretionary profit sharing contribution portion of a participant's account is based on the number of years of service.

Sponsor's discretionary contributions vest according to the following schedule:

	Vesting %
Less than 2 years	-
2 years	20 %
3 years	40 %
4 years	60 %
5 years	80 %
6 or more	100 %

Participants are considered to have completed one year of service for purpose of vesting upon the completion of 1,000 hours of service at any time during 12 consecutive months.

Participants will always be 100% vested upon normal retirement age if still employed with the Sponsor. Normal retirement age is defined as the date the participant has attained age 59 1/2. Participants will also be 100% vested if they die or become disabled while still employed with the Sponsor.

#### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants can only have two loans currently outstanding from the Plan. Loan terms may not exceed five years unless for the purchase of a primary residence. The loans must be adequately secured. Generally, a participant must use no more than 50% of their vested interest in the Plan as security but the Plan administrator may request additional collateral. The interest rate charged must be comparable to the interest rates charged by financial institutions for similar loans. The interest rate that will apply will be determined by the plan administrator and ranged from 4.25% - 9.50% for notes outstanding as of December 31, 2024. Principal and interest are to be paid ratably through payroll deductions at least quarterly.

### Note 1: Description of Plan (Continued)

#### Payment of Benefits

All distributions from the Plan will be made in a single lump-sum payment of cash or installment payments. If an employee's vested benefit in the Plan exceeds \$5,000 the employee must consent to the distribution before it will be made. A distribution is required to be made if the vested benefit under the Plan (excluding amounts attributable to rollovers) does not exceed \$5,000. Minimum distribution rules must be followed. A participant may also elect to rollover all or a portion of their distribution to an Individual Retirement Account or another qualified plan. Benefits are recorded when paid.

In-service distributions are permitted if a participant is at least age 59 1/2 at the time of distribution or for financial hardship if certain conditions are satisfied. Participants should refer to the Plan document for conditions relating to these in-service distributions.

#### Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$54,061 and \$59,523, respectively. When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents forfeiture. The non-vested portion may be used to reduce the Sponsor's contributions (including qualified matching contributions (QMACs), qualified nonelective contributions (QNECs), safe harbor contributions, and non-elective contributions) or may be used to pay administrative expenses of the Plan. During the year ended December 31, 2024, Sponsor contributions were reduced by \$10,379 from forfeited nonvested accounts.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable is recorded as benefit payments on the basis of the terms of the plan document.

#### **Use of Estimates in Preparation of Financial Statements**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value except for fully benefit-responsive investment contract (FBRIC). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 and Note 5 for discussion of fair value measurements and FBRIC.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Change in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRIC is reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income or loss.

#### **Subsequent Events**

The Plan has evaluated subsequent events through July 23, 2025, which is the date the financial statements were available to be issued. The Plan Administrator and Recordkeeper changed from Empower to Vanguard on March 27, 2025. The plan assets were moved to Vanguard on April 3, 2025.

### Note 3: Information Prepared and Certified by Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest from notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the Custodians of the Plan.

Accordingly, at the request of the plan administrator, this information has not been audited by the Plan's independent auditors, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Fair value of pooled separate accounts is based on quoted net asset values of underlying investments held by the pooled separate accounts adjusted by an asset charge. The underlying investments held by pooled separate accounts are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price.

### Note 5: Fully Benefit-Responsive Investment Contract (FBRIC)

The Plan has a group fixed deferred annuity contract with Empower Annuity Insurance Company of America ("Empower"). Empower maintains the contributions in a general account. The account is credited with all contributions made by or on behalf of the participant as well as earnings and charged for participant withdrawals and administrative expenses. The contract issuer must repay the principal and a specified interest rate is guaranteed to the Plan. Participants may ordinarily direct the withdrawal or transfer of all of a portion of their investment at contract value.

### **Note 5: Fully Benefit-Responsive Investment Contract (FBRIC)** (Continued)

Certain events limit the Plan's ability to transact at contract value with Empower including plan termination and other events as specified in the FBRIC. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The FBRIC does not permit Empower to terminate the agreement prior to the scheduled maturity date.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield earned by the Plan and the average interest rate credited to the participants' accounts for the year December 31, 2024 was 1.41%.

### **Note 6: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Sponsor discretionary contributions.

### **Note 8: Tax Status**

The Plan utilizes a volume submitter plan, which obtained a favorable determination letter from the IRS dated March 31, 2014, stating that the volume submitter plan is qualified under the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

### **Note 9: Related-Party Transactions and Party-in-Interest Transactions**

Certain plan investments are managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC. Empower Annuity Insurance Company of America and Empower Trust Company, LLC are the Custodians, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan for the investment management services were \$71,035 for the year ended December 31, 2024.

Certain plan investments are managed by Advised Assets Group. Advised Assets Group is the investment manager of the Plan, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan for the investment management services \$22,960 for the year ended December 31, 2024.

Certain plan investments are managed by Royal Alliance Associates, Inc. Royal Alliance Associates is the advisor of the Plan, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Advisor fees were offset against earnings.

The trustees are Plan participants. The trustees make contributions and receive benefits in the same manner as all other participants of the Plan.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.


