Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Rogers Enterprises Incentive Savings Plan (REISP), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Description of Plan

The following description of Rogers Enterprises Incentive Savings Plan (REISP) (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Rogers Enterprises, Inc. and its subsidiaries (Company) who have completed one full year of service, as defined, and attained at least 18 years of age. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation. Effective January 1, 2022 and January 1, 2024, the Plan was amended and restated. Effective January 1, 2024, long-term part-time employees who have reached 21 years of age are eligible to make elective deferrals to the Plan, as defined in the plan document.

Company Contributions

Company 401(k) matching contributions are discretionary amounts determined by the Board of Directors of the Company. The Company made discretionary matching contributions of 40% of the first 5% of participant contributions for the years ended December 31, 2024 and 2023. Discretionary matching contributions totaled \$170,256 and \$144,595 for the years ended December 31, 2024 and 2023, respectively.

Participant Contributions

Each pay period participants may elect to make 401(k) contributions in an amount equal to any whole percent of compensation, as defined in the Plan, not to exceed the maximum permitted by the Internal Revenue Service. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Effective April 1, 2022, all employees who are eligible to make pretax contributions can also make Roth contributions. Effective July 1, 2022, new employees are automatically enrolled at a 1% pretax contribution rate unless the employee elects a higher or lower pretax contribution rate or declines participation in the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, rollover contributions, and allocations of (a) the Company's matching or discretionary contributions and (b) plan earnings and charged with an allocation of administrative expenses. Company matching contributions are allocated to participant accounts based upon the amount of their elective salary deferrals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective salary deferrals, rollover allocations, and the related earnings thereon. Participants become vested in the Company contributions as follows:

Years of Service	Vesting Percentage
1	25%
2	50%
3	75%
4	100%

Payment of Benefits

Upon retirement, disability, death or termination of service prior to retirement, participants (or their beneficiaries) are eligible to be paid their account balances either in a lump-sum amount or in installments as provided for in the Plan.

Hardship withdrawals are subject to approval by the plan administrator. Participants may withdraw their employee pre-tax contributions plus earnings to satisfy immediate and heavy financial needs, as defined in the Plan.

Participant Notes Receivable

Participants may borrow from their investment accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Prior to January 1, 2022, participants could have an unlimited number of loans outstanding at any time. Effective January 1, 2022, participants may have five loans outstanding at one time. The rate of interest shall be the prevailing prime rate at the time the loan is made as published in *The Wall Street Journal*, plus 1%. Principal and interest are paid ratably through payroll deductions. The loan period may not exceed five years, unless the proceeds of the loan are used to purchase a primary residence, for which the repayment period may not exceed fifteen years. The loans bear interest from 4.25% to 9.50% at December 31, 2024.

Forfeited Accounts

All forfeitures will be used to pay plan administrative expenses or used to reduce Company contributions to the Plan. During 2024 and 2023, \$7,503 and \$2,262 of forfeitures were used to reduce plan expenses, respectively. During 2024 and 2023, \$274 and \$0 of forfeitures were used to reduce Company contributions, respectively. At December 31, 2024 and 2023, there were \$6 and \$5 of forfeitures available for future use, respectively.

Investment Options

Participants may direct the investment of all contributions in one or more of the various investment options offered by the Plan. The Plan currently offers various registered investment companies and a common or collective trust fund as investment options for participants. Automatic enrollment contributions are invested in the Fidelity Freedom funds.

Revenue Sharing

Effective January 1, 2019, the Plan entered into an agreement with Alerus Financial, N.A. (Alerus) under which Alerus receives revenue sharing from registered investment company or common or collective trust fund service providers, net of certain service fees. Such amounts referred to as “net revenue sharing” are allocated back to participant’s accounts based upon the individual participant’s average daily balance in

the funds which generate the revenue sharing. During 2024 and 2023, net revenue sharing allocated back to participant's accounts totaled \$14,067 and \$11,892, respectively, and have been offset against administrative expenses on the statements of changes in net assets available for benefits.

Note 2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared using the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value.

Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan.

The common or collective trust fund is valued at the net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. The underlying investments are primarily invested in a pool of investment contracts that are issued by insurance companies and commercial banks and in contracts that are backed by bond funds and trusts. There are no participant redemption restrictions for these investments and participant redemptions are allowed daily. There were no unfunded commitments at December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the December 31, 2023, excess contributions payable amounts to the applicable participants before March 15, 2024.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses relating to the Plan are paid by the Company on behalf of the Plan. Such expenses include costs related to certain employees of the Company who perform administrative and trustee services for the Plan for which the Plan does not reimburse the Company. Investment management fees are included in the net appreciation in fair value of investments. Other administrative and transaction costs incurred by the Plan are recognized as incurred.

Note 3. Information Certified by the Custodian of the Plan

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Alerus Financial, N.A., a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Noninterest-bearing cash, investments, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income components and interest income from notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted market prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of shares of registered investment companies is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Party-in-Interest Transactions

The Plan paid expenses, prior to the effect of revenue sharing, in the amounts of \$100,296 and \$91,039 during 2024 and 2023, respectively, for legal, accounting and other professional services rendered by parties-in-interest.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Note 7. Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype profit sharing plan and trust sponsored by Alerus Financial, N.A. This prototype plan document has been filed with the appropriate agency and the sponsor has obtained an opinion letter from the IRS stating that the prototype plan constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risk and Uncertainties

The Plan provides for investments that, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Note 9. Subsequent Events

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.
