## **Note 1 - Description of Plan**

The following brief description of the Great Plains Health 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering qualified employees of North Platte, Nebraska Hospital Corporation d/b/a Great Plains Health (Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The 401(k) Committee is responsible for oversight of the Plan as well as determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

### **Eligibility**

Employees are eligible to participate in the Plan if they have reached 21 years of age.

### **Entry Date**

Employees are eligible to enter the Plan immediately upon satisfying the Plan's eligibility requirements. For employees automatically enrolled, there is a window of up to 60 days for administrative period after which the employee is automatically enrolled.

### **Contributions**

Contributions made to the Plan are as follows:

Participant Contributions – Each year participants may elect to make contributions of their pretax or post tax compensation, as defined in the Plan. The Plan includes auto-enrollment and auto-escalation provisions. Employees are automatically enrolled in the Plan unless they affirmatively choose not to participate. Automatically enrolled employees have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated fund until changed by the employee. Participant deferral rates auto-escalate by 1% each year up to a maximum of 10% of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Discretionary Employer Contributions – The Employer may contribute a discretionary matching contribution. For the year ended December 31, 2024, the Employer elected to contribute 100% of the first 4% of covered compensation that a participant contributes to the Plan.

Participant Rollover Contributions – Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Contributions are subject to certain Internal Revenue Service (IRS) limits.

### Participant Accounts

Each participant's account is credited with the participant's contributions (including rollovers) and the Employer's matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's compensation, account balances, or specific participant transactions, as defined by Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Investment Options

Upon enrollment to the Plan, a participant may direct deferrals, rollovers, and Employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

### Vesting

Participants are vested immediately in their contributions as well as rollover contributions, plus actual earnings (losses) thereon. Employer contributions plus actual earnings (losses) vest as follows:

<u>Periods of Service</u>	<u>Vesting Percentage</u>
Less than 3	0%
3 or more	100%

Separate provisions apply in the event of death or disability of the participant or when the participant reaches normal retirement age. Specific participants who were employees of the Great Plains Health Home Health division that were part of a divestiture to an unrelated entity were considered 100% vested as of June 30, 2023.

### Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$18,874 and \$32,334, respectively. These accounts will be used to reduce future Employer contributions. In 2024, Employer contributions were reduced by \$251,808 from forfeited nonvested accounts.

### Payment of Benefits

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or installments as defined in the Plan document upon retirement, termination of service, death or disability. A terminated participant with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$7,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. Distributions may be made at the participant's election prior to termination upon attainment of age 62 or hardship as defined in the Plan document.

## **Plan Termination**

Although it has not expressed any intent to do so, the Board of Directors of the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

## **Note 2 - Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Committee determines the Plan's valuation policies utilizing information provided by investment advisors and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

### **Contributions**

Participant contributions and the related Employer discretionary matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**Expenses**

The Plan's expenses are paid by either the Plan or the Employer, as provided by the Plan document. Expenses that are paid directly by the Employer are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net asset available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits. In addition, certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan.

**Subsequent Events**

The Plan has evaluated subsequent events through October 9, 2025, the date which the financial statements were available to be issued.

**Note 3 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds (including money market mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued at the Plan's share of the NAV of the common collective trust's underlying investments. The NAV is used as a practical expedient to estimate fair value.

**Note 4 - Certified Information**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the trustee of the Plan).

**Note 5 - Tax Status**

The Plan uses a pre-approved plan document sponsored by The Vanguard Group, which received an opinion letter from the IRS, dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Party-in-Interest Transactions**

Certain Plan investments consist of a common collective trust fund issued by Vanguard Fiduciary Trust Company (Vanguard) and shares of mutual funds managed by Vanguard Group, Inc. and Vanguard Wellington Fund, related parties of Vanguard. Vanguard is the trustee as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

**Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8 - Plan Amendments**

In connection with the SECURE 2.0 Act, the Plan has not yet been formally amended. However, the Plan is required to operate in accordance with required provisions in accordance with the effective date of each new provision, as well as any optional provisions as elected by the Plan. Along with required provisions, the Plan elected certain optional provisions including permitting self-certification of hardship withdrawals and, effective for distributions made after December 31, 2023, the Plan has elected to apply a threshold of \$7,000 for involuntary cash-out distributions. In addition, effective January 1, 2025, the Plan will allow higher catch-up contribution limits for employees who have attained age 60, 61, 62 and 63.
