INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Getaway 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements is complete and accurate.

Opinion

In our opinion, based on our audit and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Responsibilities of Management for the Financial Statements

Notes to Financial Statements

December 31, 2024

1. Description of Plan

The following description of the Getaway 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Getaway (the Company), as defined in the Plan document. The Plan was formed on January 1, 2024 and allowed for contributions to start effective May 10, 2024. All employees of the Company, except union employees, leased employees, and non-resident aliens, become eligible to participate in the Plan after completing twelve months of service and attaining the age of 18. Employees defined as interns, temporary, or seasonal can enter the Plan on the first day of January or July coincident with or next following meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In December 2024, the Company was acquired. On July 1, 2025, participants were no longer eligible to contribute to the Plan. Following the acquisition, participants began transferring their account balances out of the Plan throughout 2025. Additionally, balances under \$5,000 were forced-out in accordance with the Plan provisions. The plan administrator is in the process of distributing the remaining balances to participants and/or beneficiaries, and the Plan will remain in existence only as long as necessary to complete the distribution of all assets and satisfy all outstanding obligations. The financial statements do not include any adjustments that might result from the Plan's ultimate termination. The Plan will continue to file required regulatory reports until all assets have been distributed and the Plan is fully terminated.

Contributions

Each participant may make pre-tax and/or Roth contributions of up to 100% of eligible compensation as defined by the Plan document not to exceed a maximum of \$23,000 in 2024, plus up to an additional \$7,500 for participants who have reached at least 50 years of age by the end of the Plan year. Upon satisfying the eligibility requirements, participants are automatically enrolled in the Plan at 1% of eligible compensation, unless the employee elects otherwise. The Plan started allowing contributions in May 2024, at which time all eligible employees were automatically enrolled at 1% of eligible compensation, unless they elected otherwise. The Plan allows for an annual automatic increase of participant contributions, of 1% each year up to a maximum of 15%, unless the employee elects otherwise. For employees automatically enrolled prior to October 1st of the Plan year, their first deferral rate increase will occur on the first day of the immediately following Plan year; and for employees automatically enrolled on or after October 1st of the Plan year, their first deferral rate increase will occur on the first day of the second following Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company may, in its sole discretion, make a discretionary employer matching contribution or discretionary non-elective contribution on the participants' behalf in an amount determined by the Company for eligible employees. In order to be eligible for discretionary employer contributions an employee must have 1,000 hours of service during the Plan year and be employed by the Company on the last day of the Plan year. For the year ended December 31, 2024, the Company did not make any discretionary employer matching or discretionary non-elective contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, any discretionary employer contributions, and earnings and losses on the investments in their account, and is charged with certain administrative expenses. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in their contributions and rollovers plus actual earnings thereon. Participants vest in discretionary matching and discretionary non-elective contributions at 20% per year beginning at the completion of their second year of service and each year thereafter and are fully vested after six years.

Payment of Benefits

At the time of death, disability, termination of service, or retirement, the participant or their beneficiary may elect to receive a payment of the vested interest in their account in a lump-sum distribution. The participant's contributions may also be withdrawn in certain hardship situations. In-service withdrawals of all or part of the participant's vested account, are also permitted for participants who have attained age 59½. If a participant terminates employment and has an account balance less than \$5,000, the participant will automatically receive the lump-sum distribution.

Administrative Expenses

Certain administrative expenses are permitted to be paid by the Plan in accordance with Plan's provisions. Certain transaction fees for withdrawals are charged directly to the respective participants' accounts. Additionally, certain Plan administrative and recording keeping fees are charged against participant accounts. These expenses are paid to a service provider of the Plan and therefore qualify for party-in-interest transactions. Certain expenses incidental to the administration of the Plan are paid by the Company. The Company does not expect reimbursement from the Plan for any expenses paid on behalf of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company discretionary matching and discretionary non-elective contributions are considered payable to the Plan when approved by the Company. Any unfunded participant or Company discretionary contributions are included in participant or employer contributions receivable on the statement of net assets available for benefits as of December 31, 2024.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments. Interest is recorded when received.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to participant contributions. The Plan distributed the required excess contributions to the participants in accordance with IRS regulations.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024, and the net change in fair value of investments for the year then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Inspira Financial Trust, LLC, the Plan's qualified institution.

4. Investments

Fees incurred by the Plan for investment management services are included in net change in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

Investments are exposed to various risks, such as market, currency, interest rate and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include a healthcare crisis, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cyber security attack, or other similar events. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets or liabilities in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value.

Investments in exchange-traded funds are stated at quoted market prices for the identical security in an active market (Level 1).

5. Plan Termination

Although there has not been a formal resolution to terminate the Plan, as noted in Note 1, after the acquisition of the Company, the plan administrator is in the process of distributing participant balances. Once all balances have been distributed, the plan administrator plans to formally terminate the Plan in accordance with the provisions of ERISA. There have been no employer discretionary contributions to the Plan, so the future termination has no impact on vesting of participants' accounts.

6. Income Tax Status

The Plan is a non-standardized pre-approved profit sharing plan with CODA document created by CCH Incorporated, DBA ftwilliam.com (CCH). The Internal Revenue Service has determined and informed CCH by a letter dated June 30, 2020, that the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has not obtained an individual determination letter, and has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns since inception are subject to examination by taxing authorities and may change upon examination.
