1. Description of the Plan

The following description of the Beltway International, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. Beltway International, LLC is the plan sponsor. See Note 7 for information on a plan merger that occurred on December 10, 2024.

- A. General - In addition to the plan sponsor, Beltway International, LLC, the controlled group of participating employers includes the following entities: Central Maryland International Trucks, LLC and Beltway Kenwood, LLC (effective September 1, 2016) (collectively, the Company). The Plan became effective on January 1, 1989. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a qualified plan under section 401(a) and 401(k) of the Internal Revenue Service Code (the Code) and is therefore exempt from federal income taxes under provisions of the Code section 501(a). The Plan was most recently amended and restated effective February 18, 2022. The Company's management oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

The Plan is a defined contribution and profit-sharing plan covering all employees of the Company, as defined by the Plan. The Plan allows all employees (excluding non-resident aliens with no U.S. income and independent contractors, as defined by the Company) who have completed six months of eligibility service, as defined by the plan document, and having attained the minimum age of 21, to enter the Plan on the first day of the month following the date all requirements are met.

- B. Contributions - Each year, participants may contribute up to 86% of their eligible compensation, as defined in the Plan. Participants may also make after-tax Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, pooled separate accounts, and a common collective trust as investment options for participants. Contributions to the Plan are matched by the Company at the rate of 50% of the first 4% of participant contributions. The Company may also make discretionary contributions to the Plan to be allocated to all active participants during the plan year based on an integrated formula as defined by the Plan. The Company made no discretionary contributions to the Plan for the period from January 1, 2024 to December 10, 2024.
- C. Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and (b) plan earnings and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific transaction as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

- D. Vesting - Participants are immediately vested in their voluntary contributions, rollover contributions, and qualified company contributions, plus actual earnings thereon. Participants are vested in company matching and discretionary contributions according to the following graduated vesting schedule:

Participants become 100% vested in the Company's matching and discretionary contributions if employed and in the event of normal retirement at age 65, disability, death (including qualified military service), or if the Plan is terminated or partially terminated.

- E. Notes Receivables from Participants - Participants may borrow from their vested accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 (reduced by the highest outstanding loan balance during the prior one-year period ending the day before the loan is made), or 50% of their vested account balance (reduced by any outstanding loan balance, without regard to the intended use of the funds). The maximum number of loans outstanding for a participant at any one time is two. The number of loans approved for a participant in any 12-month period shall be limited to two. Notes receivables are collateralized by the participant's vested account balance and accounted for as a specific investment of the borrowing participant's account. Principal and interest are paid ratably through bi-weekly payroll deductions. Notes receivable bear interest at prime rate plus 2%. Notes receivable for reasons other than the purchase of a primary residence are to be repaid within five years.

- F. Payment of Benefits - Upon termination of service, retirement (age 65), death, disability, or attainment of age 59 ½, a participant, or their beneficiary in the event of death, is entitled to a distribution of their vested account balance, as defined by the plan agreement. A participant may elect to receive either: (a) a lump-sum amount equal to the vested portion of the participant's account, (b) an annuity, or (c) equal installments over a period not to exceed the joint life expectancy and last survivor of the participant and his or her beneficiary. If a participant's vested account balance upon termination is less than \$5,000 but greater than \$1,000, and no distribution election is made by the participant, the plan administrator will direct the trustee to process a direct rollover into an individual retirement plan for the benefit of the participant. If a participant's vested account balance is less than \$1,000 upon termination of service and no election is made, the plan administrator will direct the trustee to make a lump sum distribution.

Upon proof, to the satisfaction of the plan administrator, of an immediate and heavy financial need, participants are allowed to take hardship withdrawals from their elective deferral accounts, and from the vested portion of their account balance attributable to the Company's matching contributions and the Company's discretionary contributions. Participants may also elect an in-service distribution from their vested account balance resulting from rollover contributions. Qualified Reservist distributions are also allowed by the Plan. Distributions are subject to the applicable provisions of the plan agreement. In all cases, certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½.

- G. Forfeited Accounts - Nonvested amounts will be forfeited by participants upon termination. Any forfeitures may be used to reinstate previously forfeited account balances of participants, satisfy certain contributions as defined by the plan document, and to pay administrative expenses of the Plan. Any remaining forfeitures are then allocated to reduce the same type of future contribution (ie: forfeitures attributable to matching contributions are used to reduce future matching contributions for the plan year). Lastly, forfeitures in excess of these amounts are to be allocated to participants as an additional contribution. At December 10, 2024 and December 31, 2023, forfeited nonvested amounts totaled \$7 and \$4, respectively. For the period from January 1, 2024 to December 10, 2024, forfeitures of \$7,336 were used to reduce company contributions, and forfeitures of \$1 were used to pay administrative fees.

2. Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management of the plan sponsor determines the Plan's valuation policies utilizing information provided by the trustee and the Plan's investment advisor. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1), and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 10, 2024 and December 31, 2023.

Level 1 Fair Value Measurements

The fair value of registered investment companies (mutual funds) is based on quoted net asset values of the shares as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investments Measured at Net Asset Value

Common collective trusts are valued at the NAV of shares in each account held by the Plan at year end. The NAV is not a publicly quoted price in an active market. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

Pooled separate accounts are valued at the NAV of shares in each account held by the Plan at year end. The NAV is not a publicly quoted price in an active market. The NAV, as provided by the insurance carrier, is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related-Party Transactions

Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal) is the trustee of the Plan. Pursuant to a trust agreement, Principal provides plan administration services to the Plan for which fees are charged. Plan investments include a Principal common collective trust and pooled separate account. Pursuant to a service expense agreement, RCM&D provides certain administrative and consulting services to the Plan. The Plan allows participants to take out loans against their vested balances. The Company provides certain accounting and administrative services to the Plan for which no fees are charged. Such transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

7. Plan Merger

During 2024, the Company approved a plan to merge the Plan into a pooled employer plan. The merger effective date was December 10, 2024. On that date the Plan merged into the 401(k) Group Purchase Plan, Adopted by Beltway International, LLC. A blackout period began on November 29, 2024. Plan investments were liquidated by Principal on December 9, 2024, and wired to the Empower Trust Company, LLC on December 10, 2024.

8. Tax Status

The company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the plan has been amended since adopting the pre-approved plan document, the plan administrator believes the plan is designed, and is currently operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

9. Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.
