Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Precision Products Group, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (collectively, the 2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the 2024 financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

1. Plan Description

The following description of Precision Products Group, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Precision Products Group, Inc. (the Company) who are aged 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended effective January 1, 2024.

Effective January 1, 2023, the Breyden Products, Inc. 401(k) Plan was merged with the Plan. The assets and liabilities of the Breyden Products, Inc. 401(k) Plan were transferred to and merged with the assets of the Plan on March 7, 2023, resulting in \$1,950,997 of net assets transferred into the Plan. Former participants were enrolled in the Plan at their elected deferral percentages as of March 7, 2023.

Eligibility

All employees, with the exception of leased and collective-bargaining employees, are immediately eligible to participate upon reaching 21 years of age. Participants may enter the Plan on the day that the entry requirement is satisfied.

Contributions

Participants may contribute a portion of their annual pre-tax compensation, as determined by the Plan agreement, not to exceed the maximum allowable contribution under the Internal Revenue Code (IRC). Participants are permitted to make rollover contributions from other qualified retirement plans into the Plan.

The Company, at its discretion, may contribute to the Plan, on behalf of each eligible participant in the form of a matching contribution. Participants are eligible for Company matching contributions once they have reached 21 years of age and have completed six months of service, as defined by the Plan. The Company made discretionary matching contributions equal to 50% of participants' eligible compensation up to a maximum of 3% calculated on a per-payroll basis. During the years ended December 31, 2024 and 2023, the Company's matching contributions totaled \$145,063 and \$153,739, respectively.

The Company may also make a qualified non-elective contribution to the Plan. To be eligible for the qualified non-elective contribution, participants must be actively employed on the last day of the Plan year; have completed at least six months of service, as defined by the Plan; and be at least 21 years of age. During the years ended December 31, 2024 and 2023, the Company did not elect to make a qualified non-elective profit-sharing contribution to the Plan.

The Company may also make an additional discretionary contribution to the Plan each Plan year. The amount is determined annually at the option of the Company's Board of Directors. Participants are eligible to receive a portion of the discretionary contribution if they were an active participant at December 31 or were active during the Plan year and died, retired after having reached normal retirement age, or became totally disabled. The amount of the discretionary contribution received

by a participant is based on the participant's annual pay divided by the total annual pay of all participants eligible to receive the discretionary contribution. During the years ended December 31, 2024 and 2023, the Company did not elect to make an additional discretionary contribution.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contributions, and allocations of (a) Plan earnings and (b) administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and Company matching, qualified non-elective, and discretionary contributions plus earnings thereon.

Investment Options

A participant may direct contributions in any of the investment funds offered by the Plan. Participants may change their investment options at any time.

Payment of Benefits

Upon termination of service, retirement (age 65), death, disability, or attainment of age 59½, a participant or their beneficiary, in the event of death, is entitled to a distribution of their vested account balance. Distributions from the Plan are payable in the form of a lump-sum payment prior to retirement age. Upon obtaining retirement age, disability, or death, benefits may be requested in the form of a lump-sum or installments. Upon proof, and to the satisfaction of the Plan Administrator, of an immediate and heavy financial need, amounts contributed by the participant may be withdrawn for a hardship purpose. Distributions are subject to the applicable provisions of the Plan agreement. Certain income taxes and penalties may apply to withdrawals or distributions prior to age 59½. As of December 31, 2024 and 2023, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but have not received the funds as of year-end.

Notes Receivable from Participants

Participants may borrow against the value of their vested account balance within the Plan, without regard to the intended use of the funds. The minimum note amount is \$1,000. A participant may not have more than two notes outstanding at a time or request more than two notes in a 12-month period. The total amount of borrowings cannot exceed the lesser of 50% of the participant's vested account balance or \$50,000 less the highest outstanding notes balance for the previous 12-month period. Notes bear interest at a fixed rate that is equal to the local prevailing commercial interest rate at the time of loan issuance, as determined by the Plan Administrator. All notes, including those for the purchase of primary residence, are to be repaid within five years. The notes are repaid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks, such as interest risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivables from Participants

Participant loans are classified as notes receivable from participants and are measured at the unpaid principal balance plus unpaid accrued interest. Interest income on loans from participants is recorded on the accrual basis. Defaulted loans, if any, are reclassified as distributions based upon the terms of the Plan agreement and recorded as benefits paid to participants in the statements of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

All administrative expenses are paid with the assets of the Plan, unless paid by the Company, at its discretion. During the years ended December 31, 2024 and 2023, the Company paid a portion of the administration expenses related to the Plan. Expenses that are paid directly by the Company are excluded from the Plan's financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant accounts and included in administrative expenses. Certain investment-related expenses are included in net appreciation in fair value of investments.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date. An active market for the asset or liability is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2 - Inputs are other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, including:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the assets or liabilities.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs are unobservable for the asset or liability (including the entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability) and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Plan management uses the following methods and significant assumptions to estimate fair value of investments. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset values and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust Funds (CITs) - Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. Participant transactions (purchase and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidation will be carried out in an orderly business manner. There were no unfunded commitments or liquidity or redemption restrictions related to the collective investment trust funds.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Guaranteed Investment Contract with Insurance Company

The Plan entered into a benefit-responsive investment contract with Principal Life Insurance Company. Principal Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The Principal Fixed Income Guaranteed Option (PFIGO) is valued at contract value for presentation in the Plan's net assets available for benefits. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The contract has a 5% surrender fee should the Plan discontinue without property notification as prescribed in the contract.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is a blended rate determined using a dollar-weighted average of all the guaranteed interest rates of the guaranteed interest funds under this contract. Under the terms of the existing contract, the guaranteed minimum crediting interest rate is 1.55% and can be reset on a semi-annual basis. The PFIGO is a single group annuity contract with a fixed rate of interest. The contract value of the investment contract at December 31, 2024 and 2023 was \$185,287 and \$152,647, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA, as amended. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

5. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company (Trustee), a qualified institution.

6. Party-in-Interest Transactions

Investments in certain CITs and a guaranteed investment contract are managed by Principal Global Investors Trust Company and Principal Life Insurance Company, affiliate of the Trustee and contract holder, respectively, as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid to the Plan for recordkeeping services were \$38,549 and \$38,629 for 2024 and 2023, respectively. Notes receivable from participants also qualify as party-in-interest transactions.

7. Tax Status

The Internal Revenue Service (IRS) ruled on June 30, 2020 that the Non-Standardized Pre-Approved Profit-Sharing Plan with CODA (the pre-approved plan of Principal Life upon which the Plan is based) qualifies under Section 401(a) of the IRC and the related trust is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended subsequent to the IRS ruling. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there currently are no audits for any tax periods in progress.

8. Corrective Contributions

The Plan experienced certain operational deficiencies in 2023. The Company did not calculate the employee contribution or Company matching contribution on certain eligible wages and had certain participant withholdings not remitted to the Plan in a timely manner. The Plan recorded a receivable in the amount of \$16,989 as of December 31, 2023, to correct the operational deficiencies. The Company self-corrected the operational deficiencies under the IRS self-correction guidelines. The Company believes that the matters remediated did not cause the Plan to be disqualified by the IRS; therefore, no provision for income taxes was included in the Plan's financial statements. During the year ended December 31, 2024, there were no operational deficiencies or late remittances identified requiring correction.

9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions and terminate the Plan. In the event of termination or partial termination of the Plan, all amounts credited to a participants' account, including Company contributions, become fully vested.

10. Subsequent Events

The Plan evaluated subsequent events through October 9, 2025, the date the financial statements were issued.
