Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Humphreys & Partners Architects 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

Note 1. Description of the Plan

The following description of the Humphreys & Partners Architects 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

Humphreys & Partners Architects 401(k) Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was established on April 1, 1999, and amended and restated July 12, 2024, covering substantially all employees of Humphreys & Partners Architects, L.P., and its subsidiaries (collectively, the Company or Plan Administrator). Empower Trust Company and Empower Annuity Insurance Company of America, formerly known as Great-West Trust Company, LLC and Great West Life & Annuity Insurance Company (Empower or Trustees), in conjunction with Empower Retirement Services (Recordkeeper), serve as the Trustees and Recordkeeper, respectively.

Eligibility

Employees are eligible to participate upon attaining the age of 21 and completing 30 days of service with the exception of residents of Puerto Rico, as defined by the plan document. Participants may enter the Plan on the first day of the month following attainment of the eligibility requirements.

Contributions

The Plan is funded through participant elective deferrals and Company discretionary matching contributions. Each year, participants may contribute from 1% to 100% of annual compensation, as defined by the Plan, not to exceed \$23,000 in 2024 in accordance with the Internal Revenue Service (IRS) regulations. Roth deferrals subject to federal income taxes in the year of deferral are also allowed. In addition, those participants, who are over age 50 or turning age 50 on or before December 31, 2024, are eligible for an additional catch-up contribution of \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan utilizes automatic enrollment for newly hired employees. Employees are notified 30 days prior to their eligibility entry date of an automatic enrollment rate of 5%, unless otherwise elected by the participant.

The Plan allows the Company to make discretionary matching contributions or qualified profit-sharing contributions. Discretionary matching contributions were \$313,923 for the year ended December 31, 2024. Profit-sharing contributions were \$0 for the year ended December 31, 2024.

Participant accounts

Subject to certain limitations on annual additions, each participant's account is credited with participant elective deferrals, Company discretionary matching contributions, an allocation of plan earnings or losses, and charged with certain administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Description of the Plan, continued

Vesting

Participants are immediately vested in rollover contributions, participant contributions, after-tax contributions and any earnings thereon. Vesting of Company discretionary matching contributions and earnings thereon is based on years of continuous service. Participants vest 33% per year after one year of service, 66% after two years of service and are 100% vested after three years or upon occurrence of the participant's retirement, death or disability, as defined by the Plan document.

Notes receivable from participants

Borrowings are available for all participants. Notes receivable from participants are limited to a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balances, subject to certain restrictions as defined by the IRS. A participant may only have two notes outstanding at any given time. The notes are secured by the balance in the participants' accounts and bear interest at the prime rate plus 1%. Any note must be repaid within five years unless for the purchase of a primary residence. Repayments are made through payroll deductions and are reinvested in the participant accounts according to individual investment elections.

Benefits paid to participants

Upon normal retirement age, death, disability or termination, a participant's benefits may be payable in a lump-sum amount or installments equal to 100% of the participant's vested account balance. Employees may also make hardship withdrawals on the balance of their accounts related to their elective deferral contributions, vested profit sharing and vested match accounts. Participants with vested account balances greater than \$5,000 may defer their distributions to a later date. Participant account balances less than \$5,000, upon termination, may be rolled over to an individual retirement account or, if less than \$1,000, directly to the participant by the Company.

Forfeitures

Forfeited, nonvested accounts are retained in the Plan and may be used to reduce Company contributions or to pay Plan expenses. At December 31, 2024 and 2023, the balance of forfeited non-vested accounts was \$129,773 and \$6,138, respectively. During 2024, amounts forfeited were \$122,635, gain on the forfeiture account totaled \$1,000, and no forfeitures were used to reduce Company contributions.

Note 2. Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Note 2. Summary of significant accounting policies, continued

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value except for the fully benefit-responsive group annuity contract, which is valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Contract value is the relevant measure attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the provisions of the Plan. See Note 5 for discussion of the guaranteed investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation, or depreciation, includes the Plan's gains and losses on investments purchased and sold as well as those held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions based on the terms of the Plan agreement.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain Plan expenses, such as fees related to the administration of notes receivable from participants or related to distributions from the Plan, are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Payment of benefits

Benefit payments to participants are recorded when paid.

Note 3. Certified investments

All investment information disclosed in the accompanying financial statements and supplemental information, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, investment interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to Plan management and certified as complete and accurate by Empower Annuity Insurance Company of America.

Note 4. Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Accounting Standards Codification 820 (ASC 820) are described below:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. The mutual funds are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Note 5. Investment contract with insurance company

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America (Empower) as of December 31, 2024 and 2023, totaling \$669,483 and \$762,964, respectively. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 4%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

Note 6. Related-party transactions and party-in-interest transactions

Plan assets are held and managed by the custodian. The custodian invests cash received, and interest income and dividend income as directed by the participants of the Plan. The custodian also makes distributions to participants.

Parties-in-interest are defined under DOL regulations as any fiduciary to the Plan or party rendering services to the Plan, the employer, auditor, and certain others. As such, transactions conducted with the Company and the custodian of the Plan qualify as party-in-interest transactions.

Certain administrative functions are performed by employees of the Company. However, no such employees receive compensation from the Plan. The Company and the Plan share in administrative expenses for the Plan.

Note 7. Risks and uncertainties

The Plan may invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Tax status

Effective June 1, 2022, the Plan is based on a non-standardized pre-approved profit sharing/money purchase/CODA plan, developed by Empower Trust Company, LLC, which received a favorable opinion letter dated June 30, 2020, from the IRS stating that the non-standardized pre-approved profit sharing/money purchase/CODA plan, constitutes a qualified plan under Section 401 of the IRC. Through May 31, 2022, the Plan was based on a volume submitter profit sharing plan with CODA, developed by David W Ralston PC, which received a favorable advisory letter dated March 31, 2014, from the IRS stating that the volume submitter plan constitutes a qualified plan under Section 401 of the IRC. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Notes to Financial Statements

Note 9. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants would become 100 percent vested in their employer contributions.

Note 10. Nonexempt transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. As reported on Schedule H, Line 4(a) – Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, certain participant contributions during 2022 and 2023 amounting to \$414,067 were not remitted to the Plan within the time frame specified by the Department of Labor.

Note 11. Subsequent events

The Plan has evaluated subsequent events through October 6, 2025, the date which the financial statements were available to be issued. Effective April 1, 2025, the Plan has been amended to change the name of the Plan to HPA MSO, LLC 401(K) Plan.
