Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Scepter, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a combined defined contribution plan and profit-sharing plan covering substantially all full-time employees of Scepter, Inc. (the “Company”) who are at least age 20 and are eligible to begin contributing immediately upon eligibility. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Participants may elect to contribute up to 75% of their eligible wages, subject to annual Internal Revenue Service contribution limitations. Participant contributions to the Plan are made by means of payroll deductions during each regular payroll period. Participant contributions may be directed into various mutual funds offered by the Plan.

Nonunion employees are eligible to receive Company discretionary profit-sharing contributions and non-elective safe harbor contributions. Non-elective safe harbor contributions were 3% of defined participant’s compensation for the year ended December 31, 2024. The Company’s discretionary profit sharing contribution was \$197,839 the year ended December 31, 2024.

Union employees are only eligible to receive a non-discretionary employer matching contribution. Eligible participants receive a tiered match calculated as follows: (i) 100% of the first 3% of the eligible participant’s compensation contributed to the Plan, (ii) 50% of the next 2% of the eligible participant’s compensation contributed to the Plan, shall be allocated only to the eligible union participants. Effective March 7, 2020, the Plan was amended to increase the tiered match calculation as follows: (i) 100% of the first 4% of the eligible participant’s compensation contributed to the Plan, (ii) 50% of the next 2% of the eligible participant’s compensation contributed to the Plan.

Participant Accounts: A separate account is maintained for each participant and is credited with participant contributions, Company contributions, and earnings from the participant’s investment accounts, and is charged with his or her withdrawals and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Vesting: Participants are immediately vested in the amount of participant contributions, safe harbor contributions, Company contributions and earnings thereon.

Payment of Benefits: Participants are eligible for payment of vested benefits upon retirement, death, permanent disability, or termination of employment. Payments may be in the form of a lump-sum benefit. Active employees may make withdrawals of all or a portion of their account balances subject to certain withdrawal and contribution suspension rules as defined by the Plan. Generally, withdrawals are available only from the vested portion of a participant’s account. Withdrawals from the accounts are not allowed for participants before attainment of Age 59.5, except under hardship withdrawal and rollover contribution provisions.

Plan Termination: Although it has not expressed any intention to do so, the Company has the right to discontinue contributions at any time and to terminate the Plan subject to the related provisions of ERISA. In the event of a Plan termination or permanent discontinuance of contributions, participants would become 100% vested in their accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Presentation: The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Risks and Uncertainties: Investment securities are exposed to various risks, such as interest rate, market, liquidity and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits, and participants' individual account balances.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Administrative expenses are borne by the Company, to the extent they are not paid by the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through September 8, 2025, which is the date the financial statements were available to be issued. There were no items necessary for disclosure with the exception of the matter included below.

NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the plan.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (level 1 inputs).

NOTE 5 - TAX STATUS OF PLAN

The Internal Revenue Service issued an opinion letter dated March 31, 2014 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined under Department of Labor regulations as any fiduciary of the plan, any party rendering service to the Plan, the employer, and certain others. Certain Plan investments are managed by Fidelity Management Trust Company, the Plan trustee, and therefore, these transactions qualify as party-in-interest transactions. Fees paid to Fidelity Management Trust Company and other parties in interest by the Plan for administrative expenses also qualifies as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.
