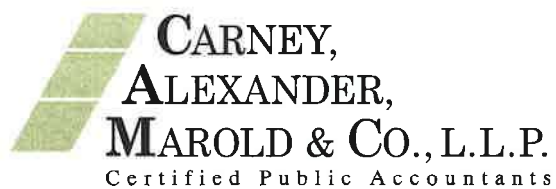

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Friendship Village. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Friendship Village 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to be independent of Friendship Village 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agree to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming an opinion on the supplemental schedules, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1: Description of Plan

The following brief description of the Friendship Village 401(K) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General. The Plan is a defined contribution plan covering substantially all employees of Friends of Faith Retirement Homes, Inc. The Company operates Friendship Village, a continuing care retirement facility, Landmark Commons, L.L.C., a retirement community for adults 55 and older, Friends at Home, L.L.C., a home health care service and It Takes A Village, L.L.C, a childcare facility, in Waterloo, Iowa. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors oversees the governance of the plan.

Contributions. For 2024, participants may contribute up to \$23,000 of pretax annual compensation, as defined in the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers various mutual funds as investment options for participants. The Company matches 100% of the first 3% of base compensation that a participant contributes to the Plan. Additional profit sharing amounts may be contributed at the option of the Company's board of directors and are invested in a portfolio of investments as directed by the employee. Contributions are subject to certain limitations.

Participant Accounts. Each participant's account is credited with the participant's contribution allocations of (a) the Company's contribution and, (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service or upon death or total disability.

Participant Loans. Participant loans are not permitted by the Plan.

Payment of Benefits. On termination of service due to death, disability, or retirement on or after age 65, a participant will receive a lump-sum amount equal to the full value of the participant's interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In service distributions may be taken only after the participant has reached age 59 1/2.

Forfeited Accounts. At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$38,622 and \$25,261, respectively. Forfeited account balances will be used to reduce future employer matching contributions and pay administration fees. In 2024 employer contributions were reduced by \$38,622 and plan expenses of \$0 were paid from forfeited nonvested accounts.

Plan Amendment. There were no plan amendments in the current year.

Note 2: Summary of Significant Accounting Policies

Date of Management's Review

Subsequent events were evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Gains and losses are recognized based on the change in the fair market value of invested assets, not at the time realized by the sale of specific securities. Interest and dividend income is recorded on a cash basis.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Friends of Faith Retirement Homes, Inc., as the Plan sponsor, absorbs significant administrative expenses on behalf of the Plan. These expenses therefore, are not included in the Statement of Changes in Net Assets Available for Benefits. Investment expenses are included in net appreciation of fair value of investments.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of the amount allowed by the IRS have not been recorded as a liability as of the year end as they are not significant. Any amounts payable for excess contributions are distributed to the participants as soon as the amount is determined in the subsequent year.

Note 3: Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 and Level 3 inputs would only be used when Level 1 inputs are not available.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the plan are considered to be actively traded. The fair values of common stocks, corporate bonds and U.S. Government securities, if any, are based on quoted market prices.

Note 7: Related Party Transactions

Certain Plan investments are shares of mutual funds managed by John Hancock Life Insurance Company (John Hancock). John Hancock is the custodian of the plan assets as defined in the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are paid on an indirect basis through the mutual funds to John Hancock.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 8: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the employer contributions.

Note 9: Amounts Allocated to Withdrawing Participants

No amounts have been allocated for participant withdrawals but not paid as of year end for either of the years ended December 31, 2024 and 2023 respectively. No amounts were recorded on the Schedule of Net Assets Available for Benefits or Schedule H of Form 5500.

Note 10: Tax Status

The Company adopted a prototype Volume Submitter Plan Document provided by the Plan's third party administrator, Qualified Plan Consultants, LLC. The Internal Revenue Service had notified the third party administrator that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). As permitted by the IRC, the Company is relying on the opinion letter and has not requested a determination letter of its own.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax position that more likely or not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities, however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2022.

Note 11: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
