NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of the Nazareth University Defined Contribution Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan available to all employees of Nazareth University (the University) who meet certain eligibility requirements. The Plan is administered by the authorized officers of the University. Teachers Insurance and Annuity Association (TIAA) is the recordkeeper of the Plan's assets and an insurance company of the Plan. College Retirement Equities Fund (CREF) is also an insurance company of the Plan. TIAA, FSB (through July 2023) and TIAA Trust, N.A. (from July 2023 through December 31, 2024) is the directed custodian of certain assets of the Plan record kept by TIAA. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees are eligible to begin salary deferrals upon hire and receive University contributions after completing two years of service and obtaining age 21, unless they are part of a group of excluded employees.

Contributions

Active participants may make voluntary pre-tax contributions in the form of salary reductions and any applicable rollovers from other qualified plans, subject to certain limitations of the Plan and the Internal Revenue Code (IRC) under Section 403(b).

Provided that the Participant has made the required elective deferral of 2% of compensation, the University will make contributions as a percentage of compensation based upon years of eligible service on the following schedule: 5% of eligible compensation if the employee has less than five years of eligible service, 7% of eligible compensation if the employee has greater than five years of eligible service.

Vesting

Participants are immediately vested in their voluntary contributions, University contributions, and actual earnings/losses thereon.

Participant Accounts

Each participant's account is credited with the participant's contribution, the University's contribution, an allocation of Plan earnings/losses on all contributions, and an allocation of administrative expenses. Allocations of Plan earnings/losses and administrative expenses are based on participant account balances according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Payment of Benefits

Vested funds are paid to participants when they retire or terminate employment with the University. Benefits may be paid out in a single lump sum or in periodic installments over a period that is not greater than or equal to the life expectancy of the participant.

1. DESCRIPTION OF PLAN (Continued)

Plan Loans

Plan loans were issued directly from the funds owned by TIAA and CREF and were not issued directly from a participant's account. Accordingly, these loans are not presented as part of the plan assets in the accompanying statement of net assets available for benefits. A portion of the participant's account equal to 110% of any outstanding loan is held in collateral in case of default. Interest rates on plan loans range from 4.44% to 4.65%. As of December 31, 2024 and 2023, total plan loans outstanding to the Plan were \$7,922 and \$21,232, respectively. The Plan no longer offers collateralized plan loans.

Notes Receivable from Participants

Participants are allowed to borrow against their respective account balance. Participants may borrow up to the lesser of 50% of their vested account balances, or \$50,000 reduced by the highest outstanding loan balance incurred by the participant during the 12-month period ending on the day before the date on which the loan was made. Loans are repayable over periods not to exceed five years, except in the case of a loan taken for the purpose of purchasing a primary residence. All loans bear interest at the prime rate plus 1%. Defaulted loans are deemed as distributions to the extent the law allows.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from a participant's account. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

Investments

Investments are reported at fair value, except for fully benefit responsive fixed annuity contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant directed.

Annuity Contracts

The Plan utilizes Retirement Annuity (RA) contracts with TIAA, which are included in the non-benefit responsive fixed annuity contracts in the statements of net assets available for benefits. TIAA maintains plan contributions in separate accounts. Under RA contract terms, lump-sum withdrawals are not available. All withdrawals and transfers from the account must be spread over 10 annual installments (over 5 years for withdrawals after termination of employment).

The Plan has fully benefit responsive fixed annuity contracts. TIAA maintains the Plan contributions in separate accounts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The accounts are credited with contributions and earnings on the underlying investments and are charged for Plan withdrawals. Earnings on the underlying investments are guaranteed by TIAA at a rate of 3%.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement - Definition and Hierarchy

Accounting Standards Codification (ASC) Section 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 inputs are based on quoted prices (unadjusted) in active markets for identical assets and liabilities that the Plan has the ability to access at the measurement date.
- Level 2 inputs are based on quoted market prices for markets that are not active or financial instruments for which all significant inputs are observable, either directly or indirectly.
- Level 3 inputs are based on pricing inputs that are unobservable for the assets and reflect certain assumptions to determine fair value.

The following is a description of the valuation methodology used for assets measured at fair value.

Registered Investment Companies and Variable Annuity Accounts: Valued using closing quoted prices in active markets.

Pooled separate accounts: A separate account invested in real estate properties and real estate related investments that are valued using closing quoted prices in active markets.

Non-benefit responsive fixed annuity contracts: Value is calculated as accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals.

There were no changes in valuation methodologies used during 2024 or 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Related fees are charged directly to the borrowing participant's account and are included in fees when incurred. As of December 31, 2024 and 2023, no allowance has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a distribution based on the terms of the Plan document.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, political, currency, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the financial statements.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Substantially all administrative expenses associated with the Plan are paid by Plan participants through a reduction of investment income.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

The plan administrator assesses the fair value measurement policies and procedures applied by TIAA on a continuing basis. Periodically, the plan administrator, with assistance from an independent third-party, determines if the current valuation techniques used in the fair value measurements are still appropriate.

5. PARTY-IN-INTEREST TRANSACTIONS

TIAA and CREF are the insurance companies and issuers of the annuity contracts of the Plan. TIAA, FSB (through July 2023) and TIAA Trust, N.A. (from July 2023 through December 31, 2024) is a directed custodian of certain assets of the Plan. As such, transactions between TIAA, CREF, TIAA, FSB, TIAA Trust, N.A., and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants are party-in-interest transactions.

6. TAX STATUS

The Plan has adopted a volume submitter plan document that has received an opinion letter from the Internal Revenue Service dated August 7, 2017, stating that the form of the volume submitter plan document was in accordance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended since adopting the volume submitter plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes that the Plan is qualified and no provision for income tax has been included in the Plan's financial statements.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the University has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would remain 100% vested in their accounts.

8. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of and for the year ended December 31, 2024 and 2023.

9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 3, 2025, which is the date the financial statements were available to be issued.
