## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Golden Valley Health Centers 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following brief description of the Golden Valley Health Centers 403(b) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document and amendments for more specific provisions.

**A. General**

The Plan is a defined contribution plan that was established in 2009 by Golden Valley Health Centers (the "Company") to provide benefits to eligible employees, as defined in the Plan document. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the "Code") and provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

**B. Eligibility**

All employees of the Company are eligible to make elective deferrals upon employment. For employer discretionary matching contributions, there is no eligibility requirement or restrictions. Employer matching contributions are made at the same time employees make their contributions.

**C. Participant Contributions**

Participants may elect to make pre-tax and/or Roth after-tax contributions to the Plan up to the maximum amount permitted under provisions of the Code. Each participant's pre-tax and Roth contributions are subject to applicable Code limits. Participants of age 50 or older may elect to make additional catch-up contributions as allowed under Code regulations. Participants who make pre-tax contributions to the Plan receive an equivalent reduction in taxable compensation.

Newly hired employees who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are auto-enrolled in the Plan at a pre-tax deferral rate of 2% of compensation.

Participants are also allowed to make rollover contributions of eligible amounts received from other tax-qualified employer sponsored retirement plans subject to approval of the plan administrator. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction.

**D. Company Contributions**

The Company is allowed to make discretionary matching contributions, as defined in the Plan. During the year ended December 31, 2024, the Company matched 100% of the first 2% of compensation deferred by participants.

**E. Participant Accounts**

Each participant's account is credited with the participant's contributions, rollovers, Company matching contributions, if any, and an allocation of Plan earnings or losses and expenses. Plan assets are invested based solely on instructions received from participants.

**E. Participant Accounts (Continued)**

The contributions of participants who decline to make an investment election are allocated to the Vanguard Target Retirement Funds appropriate for a participants' age and projected retirement date.

**F. Vesting and Forfeitures**

Participants are immediately 100% vested in their accounts.

**G. Expenses**

Investment fund operating expenses are incurred directly by the funds and are therefore factored into each fund as a reduction in investment return. Record keeping, brokerage and investment advisory fees were paid by the Plan in 2024. The Company pays other Plan administrative costs.

**H. Payment of Benefits**

Normal retirement age under the Plan is age 62. Upon termination of service, death, disability, retirement, or attainment of age 59½, a participant or beneficiary may maintain his or her account in the Plan or elect to receive benefits in a lump sum equal to the value of the participant's vested account. Under limited circumstances, the plan administrator may approve hardship withdrawals. Benefits are recorded when paid.

**I. Notes Receivable from Participants**

The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their account balance. A loan is secured by a participant's account, bears interest at a fixed rate based on available market financing rates at loan inception and must be repaid to the Plan within a five-year period, unless a loan is used for the purchase of a principal residence in which case the maximum repayment period may be extended up to fifteen years. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 3.25% to 8.50% with various maturities through November 2029.

Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan document.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Investment Valuation and Income Recognition**

Investments are stated at fair value except for fully benefit-responsive investment contracts which are stated at contract value. Fair value is the price that would be received to sell an asset

or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made under a contract plus earnings, less participant withdrawals, and administrative expenses.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

**C. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**D. Risks and Uncertainties**

Plan investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in equity markets, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the financial statements.

**NOTE 3 - INCOME TAX STATUS**

The Company adopted a volume submitter plan that has received an opinion letter from the Internal Revenue Service stating that the form of the Plan qualifies under applicable provisions of the Code. The Company believes the Plan has been designed and is operated to comply with applicable requirements of the Code and is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEES/CUSTODIANS**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements including investments held at December 31, 2024 and 2023, and net appreciation of investments, interest and dividends for the year ended December 31, 2024, was obtained, or derived from information provided to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, UMB Bank, Ameriprise Trust Company, RiverSource Life Insurance Company, Fidelity Management Trust Company, Invesco Trust Company, Midland National and Symetra Financial, trustees/custodians of the Plan.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate or amend the Plan subject to provisions of ERISA. The accounts of participants affected by partial or complete termination of the Plan are nonforfeitable and will be determined as of the termination date.

**NOTE 6 - FAIR VALUE MEASUREMENTS**

Accounting guidance establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Shares of mutual funds are valued at the closing market prices of shares held at year-end. Pooled separate accounts are valued at net asset value of units based upon the quoted market value of the underlying assets. Pooled separate accounts are reported using net asset value as a practical expedient and are excluded from the fair value hierarchy under ASC 820.

Although the plan administrator believes these valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value could result in a different fair value measurement at the reporting date.

**NOTE 8 - GUARANTEED INVESTMENT CONTRACTS**

The Plan has fully benefit-responsive investment contracts with Standard Life Insurance Company, Midland National and Symetra Financial that are maintained in a general account. The contract issuers are contractually obligated to repay principal and a specified interest rate to the Plan. Investment return is determined by a declared interest rate which is accrued daily and compounded quarterly. The contracts meet fully benefit-responsive investment contract criteria and are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants when they initiate permitted transactions under the terms of the Plan. There are no reserves against contract value for credit risk of the contract issuer.

Participants may direct the withdrawal or transfer of all or a portion of their investment in the fund at contract value.

Plan level events resulting in cancellation of investment in the fund may limit the ability of the Plan to transact at contract value.

**NOTE 9 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are provided by affiliates of Charles Schwab Trust Bank, UMB Bank, Ameriprise Trust Company, Fidelity Management Trust Company, Invesco Trust Company, Midland National and Symetra Financial. Purchases and sales of these investments and payments of direct and indirect administrative and investment management fees to Plan service providers by the Plan are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE 10 - RECONCILIATION OF FINANCIAL STATEMENTS TO THE FORM 5500**

The differences between the information reported in the financial statements and the information reported in the Form 5500 arise primarily from presenting the financial statements on the accrual basis of accounting.
