Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the LBS Financial Credit Union 401(k) Retirement Plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of LBS Financial Credit Union 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the LBS Financial Credit Union 401(k) Retirement Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from Standard Insurance Company, the trustee of the LBS Financial Credit Union 401(k) Retirement Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information as described in Note 8 to the financial statements is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by Standard Insurance Company agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the LBS Financial Credit Union 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free of material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about LBS Financial Credit Union 401(k) Retirement Plan's ability to continue as a going concern within one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

DECEMBER 31, 2024 AND 2023

NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the LBS Financial Credit Union (the Plan Sponsor) 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: Effective April 1, 1980, the Plan is a defined contribution plan that incorporates a cash or deferred arrangement under Internal Revenue Code (IRC) Section 401(k). The Plan covers all employees of the Plan Sponsor who have attained three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute up to the deferral limit of pretax annual compensation as defined in the Plan. Effective January 1, 2024, the Plan allows for post-tax Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Each year, the Plan Sponsor decides whether to make a discretionary match of each participant's elective deferral. During the years ended December 31, 2024 and 2023, the Plan Sponsor did not make any discretionary matching contributions.

Investment Options: Participants may direct employee contributions to be invested among various investment options as made available and determined by the Plan Administrator. The Plan currently offers 15 pooled separate accounts and one fixed rate investment as investment options for participants, which are more fully described in the plan document. Participants may change their investment options at any time during the year via direct phone or internet access to Standard Insurance Company.

Participant Accounts: Each participant's account is credited with the participant's contribution and an allocation of the Plan's earnings (losses) based on the account balance. All investments are 100% participant directed. The benefits to which a participant is entitled are the benefits that can be provided from the participant's vested account.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested balance, whichever is less. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loan fund. Loan terms may range up to five years, or up to 30 years if used to purchase the primary residence of the participant. The loans are secured by the participants' vested interest and require the participants to make payments via automatic payroll deductions. Interest rates range from 5.25% to 10.50%.

Vesting: Participants are immediately vested in their deferred salary contributions plus actual earnings (losses) thereon. Vesting in the Plan Sponsor's contribution portion of participants' accounts plus actual earnings (losses) thereon is based on years of service. A participant is 100% vested in the Plan Sponsor's contributions after six years of credited service.

Payment of Benefits: Benefit payments to participants are recorded when paid. Upon termination of service due to disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of their account or one of several life annuity arrangements. In the event of death, the Plan Administrator will distribute the accrued benefits to the participant's beneficiary according to the Plan. Upon termination of service due to other reasons, a participant may elect to receive the value of the vested interest in their account as a lump-sum distribution.

Plan Termination: The Plan Sponsor anticipates and believes that the Plan will continue without interruption but reserves the right to terminate the Plan. In the event of the Plan's termination, each affected participant will become fully vested, and the assets will be distributed to the participants in accordance with the terms of the Plan and requirements of ERISA.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies followed by the Plan are reflected below.

Basis of Accounting: The financial statements of the Plan were prepared under the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Valuation of Investments: The Plan's pooled separate accounts are valued at market value based on quoted prices. When quoted prices are not available, Standard Insurance Company values the account according to accepted accounting practices and applicable laws and regulations. The general (guaranteed) account is valued at the contract price. Contract value represents contributions made under the contract, plus earnings guaranteed at 4.39% for new funds and 2.98% for old funds during 2024, less participant withdrawals and administrative expenses. Contract value approximates fair value at all times. Participant loans are valued at cost, which approximates fair market value.

Fair Value Measurement: The Accounting Standards Codification establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three-tier fair value hierarchy includes the following categories:

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
 - Quoted prices for similar assets and liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in markets that are not active;
 - Observable inputs other than quoted prices that are used in the valuation of the asset or liability (e.g., interest rate and yield curve quotes at commonly quoted intervals); and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Further, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Pooled Separate Accounts (PSAs)* – Pooled separate accounts are valued at the net asset value (NAV) provided by the administrator of the fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient should not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. There are currently no redemption restrictions or unfunded commitments on these investments. While PSAs are not reported on exchanges or other public means, these investments are similar to mutual funds and NAV is the basis for current transactions being published because it is available via investor online reporting. PSAs are classified as Level 2 measurements.
- *General Account* – Valued at the fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations, considering the creditworthiness of the issuer. The general account was considered as Level 3.

The Plan Sponsor’s financial instruments and other accounts that are subject to fair value measurement and/or disclosure are summarized in Note 3.

Notes Receivable from Participants: Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms specified in the plan document.

Benefit Payments: Benefits are recorded when paid.

Administrative Expenses: The Plan pays all expenses, except certain participant-generated transactions. Forfeitures are utilized to pay expenses as they are available. As of December 31, 2024 and 2023, forfeitures available for use amounted to \$0 for each year.

Subsequent Events: The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were transfers of \$818,484 into and \$3,309 out of Level 3 as disclosed above.

NOTE 4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their employer contributions, if any.

NOTE 5 – TAX STATUS

The Plan is operating under a Standard Insurance Company nonstandard prototype plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020 stating that the Plan, as then designed, was in accordance with the applicable sections of the IRC. The Plan has since been amended and restated. However, the Plan Administrator believes that the Plan was designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. No uncertain positions have been identified that would require the recognition of a tax liability or disclosure in the financial statements as of December 31, 2024 and 2023.

NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under the Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employees and certain others. Certain investments of the Plan are held by Standard Insurance Company, the current trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Standard Insurance Company also processes and maintains the participant loan accounts.

The Plan Sponsor provides certain accounting and administrative services to the Plan for which no fees are charged. These expenses constitute exempt party-in-interest transactions under ERISA.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities with Standard Insurance Company. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

The Plan is required to disclose significant concentrations of credit risk regardless of the degree of such risk. As of December 31, 2024 and 2023, the financial instruments that potentially subject the Plan to a concentration of credit risk consist principally of investments and notes receivable from participants.

NOTE 8 – TRUSTEE CERTIFICATION

The investment balances, notes receivable and related investment information included in the financial statements, accompanying notes and supplemental schedule were derived from statements certified by Standard Insurance Company as complete and accurate in accordance with 29 CFR 2520.103-5 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA.
