INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Grants Pass Clinic 401(k) & Profit Sharing Plan
Grants Pass, Oregon

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Grants Pass Clinic 401(k) & Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Grants Pass Clinic 401(k) & Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Grants Pass Clinic 401(k) & Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Plan Description

The following description of Grants Pass Clinic 401(k) & Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions. As of December 31, 2024, the Plan's most recent restatement was effective June 23, 2021.

General

The Plan is a defined contribution plan covering substantially all employees (except union and part-time employees) of Grants Pass Clinic, L.L.P. (the Employer) and former employees of Grants Pass Management Services, Inc. dba Oregon Health Management Services. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Employees became eligible to participate in the Plan upon completion of one year and 1,000 hours of service. The Plan has semiannual entry dates of January 1 and July 1.

Contributions

Participants of the Plan can elect to make tax-deferred or after-tax (Roth) contributions that are partially matched by the Employer. Participants may elect to make contributions up to the statutory limit. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 6 percent of eligible compensation. Contributions are automatically invested in a qualified default investment fund. The automatic enrollment provision does not include an automatic escalation. Participants may also contribute rollover amounts, representing distributions from tax-deferred accounts in other qualified plans.

The Employer makes a matching contribution of 50 percent of the first 6 percent of a participant's compensation contributed to the Plan. The Employer may also make a discretionary profit-sharing contribution for the year. Participants are eligible for profit-sharing contributions if they are employed at the end of the Plan year and have completed one year of service. Profit-sharing contributions are allocated pro rata to participants within the same classification as defined by the Plan. For the years ended December 31, 2024 and 2023, the Employer made discretionary profit-sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's and Employer's contributions and the earnings and change in value of the investments allocated to their account and is charged with an allocation of administrative expenses and fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants directed the investments of their accounts between several alternatives available through an affiliate of Fidelity Management Trust Company, the trustee for the period beginning January 1, 2023 through July 18, 2023. Participants directed the investments of their accounts between several alternatives available through an affiliate of Principal Trust Company, the trustee for the period beginning July 18, 2023 through December 31, 2023 and for the year ended December 31, 2024.

1. Plan Description, continued

Vesting

Participants are vested immediately in their elective deferrals and the Employer's matching contributions, plus earnings thereon. The Employer's profit-sharing contributions are subject to a graded vesting schedule and participants become 100 percent vested after six years. The portion of an individual's account that is not vested at the time an employee terminates their employment is forfeited.

Notes Receivable from Participants

The Plan allows employed participants to obtain loans in an amount not to exceed the lesser of \$50,000 or 50 percent of their vested account balance, reduced by the highest outstanding loan balance during the prior 12-month period. Loan transactions are treated as transfers from the investment funds to the participant's loan fund. Loan terms cannot exceed five years, unless the purpose of such loan was to acquire the principal residence of the participant. The loans are secured by the balance in the participant's vested account and bear interest at a reasonable rate commensurate with prevailing interest rates. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

In the event of termination, death, disability, or retirement, a participant may elect to receive a lump-sum payment or installment payments equal to the value of the participant's vested interest in their account. Participants who have reached age 59 ½ may take in-service distributions of their vested account balance.

If a participant has an immediate and heavy financial need as defined by the Plan, hardship withdrawals are allowed in an amount not in excess of the participant's vested account balance. Beginning in 2024, the Plan elected to allow for domestic abuse distributions under SECURE 2.0 Act.

Forfeited Accounts

A forfeiture of the unvested portion of a participant's account occurs in the Plan year that a participant receives a distribution of their entire vested account or, if no distribution is made, after five consecutive one-year breaks in service. Forfeitures are retained in the Plan and used to reduce future Employer's contributions or pay Plan expenses. During the year ended December 31, 2024, there were forfeited amounts of \$13,200. During the year ended December 31, 2023, there were forfeited amounts of \$40,801, of which \$21,279 was forfeited in error and was restored to participants during 2024. At December 31, 2024 and 2023, forfeited non-vested accounts available for future use totaled \$31,290 and \$44,990, respectively.

During the years ended December 31, 2024 and 2023, the Plan used \$706 and \$546, respectively, of forfeitures to reduce Employer's contributions. During the years ended December 31, 2024 and 2023, the Plan used \$9,409 and \$9,914, respectively, of forfeitures to pay Plan administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 8 for information on fair value measurements. See Note 9 for information on valuation of investment contracts.

Investment income is recorded on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Fees

Certain administrative expenses of the Plan have been paid directly by the Employer and are therefore excluded from these financial statements. Investment related expenses are included in net change in fair value of investments. Fees for the administration of notes receivable from participants are included in administration expenses and charged directly to the participant's account.

Contributions

Employee and employer contributions are recorded in the year in which employee contributions are withheld and underlying compensation is paid.

2. Summary of Significant Accounting Policies, continued

Revenue Sharing

The plan previously contained a revenue sharing expense offset arrangement where the Plan is credited an amount based on plan assets which is used to offset expenses. For the years ended December 31, 2024 and 2023, \$-0- and \$7,670, respectively, was credited to the account and reallocated to participant accounts. The balance in the Plan's revenue sharing account as of December 31, 2024 and 2023 was \$4,635 and \$4,414, respectively.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments – Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

3. Information Certified by the Plan's Trustees

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan for the period beginning January 1, 2023 through July 18, 2023, and Principal Trust Company, the trustee of the Plan for the period beginning July 18, 2023 through December 31, 2023 and for the year ended December 31, 2024, have certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate as of and for the years ended December 31:

4. Tax Status

The Plan is a prototype of a volume submitter profit sharing plan with CODA. FMR LLC, the sponsor of the volume submitter plan, has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, that the adoption agreement and basic Plan document satisfy Internal Revenue Code (IRC) Section 401. The Plan has been amended and restated since receiving the opinion letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

5. Plan Termination

Although they have not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their Employer's contributions.

6. Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of registered investment companies managed by an affiliate of Fidelity Management Trust Company, the prior trustee of the Plan. During the years ended December 31, 2024 and 2023, \$-0- and \$7,308, respectively, of recordkeeping fees were paid directly to the prior trustee from Plan assets. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Certain Plan investments are shares of registered investment companies managed by an affiliate of Principal Trust Company, the current trustee of the Plan. During the years ended December 31, 2024 and 2023, \$28,025 and \$11,368 of recordkeeping fees were paid directly to the current trustee from Plan assets. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under professional standards are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the net asset value (NAV) of shares held by the Plan at year end. All mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. The Plan's mutual funds are deemed to be actively traded and have a readily determinable fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

9. Investment Contracts

On July 18, 2023, the Plan entered into a benefit-responsive investment contract with Principal Trust Company. Principal Trust Company maintains the contributions in a guaranteed interest account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. All assets in the guaranteed interest account are credited with interest using a declared rate. There is no specific portfolio of assets in which the guaranteed interest account invests. The credited interest rate is backed by the income received from assets held in a general account. Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value. The Plan Administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with the Plan participants is not probable. Because the contract is considered fully benefit-responsive, it is stated at contract value on the accompanying statements of net assets available for benefits. As of December 31, 2024 and 2023, assets in the guaranteed interest account were credited at an interest rate of 4.85 percent and 6.05 percent, respectively. At December 31, 2024 and 2023, the contract value of the Principal Guaranteed Option was \$3,038,388 and \$2,276,094, respectfully.

11. Non-exempt Transactions

For the year ended December 31, 2024, participant contributions totaling \$12,279 were not remitted to the Plan within the appropriate time period by the Employer. These transactions constitute prohibited transactions as defined by ERISA. The Employer is taking the appropriate steps to correct the situation by reimbursing employees for lost earnings and interest, and have further implemented a procedure to ensure that all future remittances are made within the prescribed time period. There were no delinquent participant contributions for the year ended December 31, 2023.

12. Subsequent Events

Management evaluates events and transactions that occur after the statements of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.

Effective January 1, 2025, the Plan was restated under a new prototype of a volume submitter profit sharing plan sponsored by Premier Retirement Services, Inc. Included in the restatement is the adoption of a safe harbor contribution provision.
