INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Broadwind, Inc. Employees' 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Broadwind, Inc. Employees' 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Broadwind, Inc. Employees' 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.



Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Broadwind, Inc. they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A - DESCRIPTION OF PLAN

The following description of the Broadwind, Inc. Employees' 401(k) Plan (formerly the Broadwind Energy, Inc. Employees' 401(k) Plan) (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Broadwind, Inc. and subsidiaries (together, the "Company") under the provisions of Section 401(a) of the Internal Revenue Code ("IRC"), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). In order to be eligible to participate in the Plan, employees must have completed one month of service. Subsidiaries of the Company include: Broadwind Heavy Fabrications, Inc., Brad Foote Gear Works, Inc., and Broadwind Industrial Solutions, LLC.

During 2016, the Plan adopted an automatic enrollment feature for new and existing eligible participants that had not previously made an election to participate in the Plan. At the time of adoption, all active and eligible participants with a 0% deferral election were automatically enrolled at a new contribution rate of 1% of compensation. Effective April 1, 2017, eligible participants contributing less than 5% had their deferral percentage increased 1% thereafter annually up to a maximum of 5%. Upon meeting eligibility requirements, newly hired employees are automatically enrolled in the Plan at a contribution rate of 1% of compensation. Effective January 1, 2024, the Plan was amended to change the initial automatic deferral rate from 1% to 3%, with annual 1% automatic increases up to 10%. Employees receive notice regarding these deemed elections before the automatic contributions begin and may opt out of the automatic contributions by either electing a different contribution percentage or electing not to contribute. If the employee does not direct his or her contributions specifically, amounts will be invested in the Plan's Qualified Default Investment Alternative (an asset allocation investment model based on the participant's expected retirement date).

Contributions

Eligible employees can contribute pre-tax or after-tax compensation in an amount up to 100% of compensation, as defined by the Plan, subject to certain limitations under the IRC. All employees are eligible to receive safe harbor matching employer contributions equal to 100% of the first 3% of the participant's elective deferral contributions and 50% of the next 2% of the participant's elective deferral contributions.

The Company's matching contribution may be made in either cash or in Company common stock, at the option of the Company. During the year ended December 31, 2024, a total of \$1,183,080 in employer contributions were made, all of which were in company stock. As of December 31, 2024, the company contribution receivable was \$138,495 (80,054 shares). During the year ended December 31, 2023, a total of \$1,335,347 in employer contributions were made, all of which were in company stock. As of December 31, 2023, the company contribution receivable was \$152,962 (57,291 shares). Once the funds are invested in the Company stock fund, participants have the ability to redirect these funds at their discretion. The allocation of participant contributions and the employer contributions to the various funds is based upon the individual participant's election.

Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and related Company matching and discretionary contributions, as well as the participant's share of the Plan's

administrative expenses. The participant contributions and the related Company matching and discretionary contributions are allocated to the various investment options offered by the Plan as directed by participants. No employee deferrals may be made directly to the Company stock account, nor may any amounts be transferred into the Company stock account. Participants may transfer funds out or receive disbursements from the Company stock account when requested, subject to applicable SEC regulations.

Vesting

Participants are fully vested in their contributions and the Company matching contributions and discretionary contributions upon participation in the Plan.

Payment of Benefits

Upon termination of service due to death, disability or retirement, or in-service distributions upon reaching the age of 59 1/2, or hardship, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum distribution.

Notes Receivable from Participants

The Plan permits a participant to borrow up to the lesser of \$50,000 or 50% of his or her vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate at the month end when the loan is issued. Loan terms may not exceed five years unless the loan is used to acquire a primary residence, in which case longer terms are granted. Principal and interest are paid ratably through payroll deductions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments, other than the Fixed Income Guaranteed Option, are reported at fair value. Fair value is the price that would be received upon the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C, Fair Value Measurements, for discussion of fair value measurements.

The Fixed Income Guaranteed Option is fully benefit-responsive and is valued at contract value. See note D for discussion of contract value determination.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investment bought and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in various investment options. Such investments are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Payment of benefits is recorded when paid.

Administrative Expenses

Certain expenses incurred in the administration of the Plan are paid by the Company. To the extent that these expenses are not covered by the Company, all other expenses are paid by the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent loans are reclassified as distributions based on the terms of the Plan document.

NOTE C - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under U.S. GAAP, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common stock - Traded on a national securities exchange and valued at the last reported sales price on the last business day of the Plan year.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds are held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts - Valued using the NAV of units as a practical expedient, which is determined by the insurance company. The NAV is based on the value of the underlying assets owned by the fund and have no unfunded commitments and can be redeemed daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. Plan management evaluates the significance of transfers between levels based on the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 1, Level 2 or Level 3.

NOTE D – INSURANCE COMPANY GENERAL ACCOUNTS

The Plan includes the Principal Fixed Income Guarantee Option (the “Contract”), a fully benefit-responsive group annuity contract issued by the Principal Life Insurance Company. The Contract is not a portfolio of contracts whose yields are based on changes in the fair value of underlying assets, but is a single group annuity contract with a fixed rate of interest. As a result, the average yield earned by the Plan is the yield earned, or the interest credited, on the group annuity contract. The underlying assets consist primarily of treasuries, commercial real estate mortgages, mortgage-backed securities and short-term cash equivalents.

The interest crediting rate is determined on a semiannual basis and is calculated based upon many factors, including current economic and market conditions, the general interest rate environment, and purchases and redemptions by unit holders and has a guaranteed minimum rate of 1.55%. An employer-level surrender of the Plan's interest in the Principal Fixed Income Guarantee Option or significant employer-initiated transfers are subject to a twelve month irrevocable advance notice or a 5% surrender charge may be incurred.

The average market yield earned by the Contract, which is also the actual interest credited to participants in the Contract, as of December 31, 2024 was 1.55%. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The Contract is reported at contract value as it meets the fully benefit-responsive investment contract criteria. Contract value is calculated as contributions, plus earnings, less withdrawals and administrative expenses. Participant transactions are executed at contract value less surrender charges, if applicable, which is the relevant measure for fully benefit-responsive investment contracts. Although the existence of certain conditions or transactions outside the normal operations of the Contract could limit the Plan's ability to transact at contract value, management has determined that as of December 31, 2024, these conditions or transactions are not considered probable.

The Plan also offers the Principal Pension Builder account that is considered an insurance company general account. The fair value of the participation units owned in this account is based on the contract value of the underlying funds on the last business day of the Plan year. Participant transactions (issuances and redemptions) may occur daily. There were no unfunded commitments and no redemption limitation or notice periods, but the investment advisor reserves the right to temporarily delay withdrawals from collective trust funds in order to ensure that the securities liquidations will be carried out in an orderly business manner. The trust seeks to preserve principal, maintain high-quality liquidity and earn an appropriate market return.

NOTE E – INFORMATION CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE G - TAX STATUS

Effective March 1, 2019, the Plan adopted the Principal Life Insurance Company Volume Submitter Profit Sharing Plan (Volume Submitter Plan) sponsored by Principal Financial Group. The Volume Submitter Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the Volume Submitter Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not requested its own determination letter from the IRS. The Plan has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is designed and currently being operated, in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and that the related trust was tax-exempt as of the financial statement dates.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan administrator has analyzed the tax positions taken or expected to be taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any periods in progress. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

NOTE H - RELATED PARTIES AND PARTIES-IN-INTEREST

Certain Plan investments are managed by Principal Trust Company or its affiliates. Principal Trust Company is the custodian as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. The Plan also allows participants to take out loans, which are considered party-in-interest transactions. The Company common stock fund includes transactions that qualify as party-in-interest transactions. These investment options and transactions are not considered prohibited transactions by statutory exemptions under ERISA regulations.

At December 31, 2024 and 2023, the Plan held approximately 1,537,890 (\$2,891,234) and 1,339,302 (\$3,710,697) shares (dollars), respectively, of common stock of the Company, the sponsoring employer. The employer receivable as of December 31, 2024 was made up of 80,054 shares of Company stock totaling \$138,495. The employer receivable as of December 31, 2023 was made up of 57,291 shares of Company stock totaling \$152,962.

NOTE I – UNTIMELY REMITTANCES

During 2023 and 2022, the Company failed to remit to the Plan's custodian certain employee contribution and loan payments within the period prescribed by the Department of Labor's regulations. The total amount of untimely payments for the years ending December 31, 2023 and 2022 were \$14,601 and \$87, respectively. The Company has self-corrected amounts from the 2023 and 2022 plan years, including lost earnings during 2024.

NOTE J – SUBSEQUENT EVENTS

Management of the Plan has evaluated subsequent events through October 1, 2025, which is the date the financial statements were available to be issued. On September 8, 2025, the Company sold certain assets used in its industrial fabrication operations in Manitowoc, Wisconsin. As a result of this sale, most of the employees at this location became employees of the purchasing entity and were terminated from the Company. Participants may choose to leave their balances within the Plan or transfer them to the new employer's plan. Management does not believe the event will be considered a partial plan termination, however as all employees are fully vested in both their own deferrals and Company match deferrals, a partial plan termination would have no impact on participant vesting.
