### **Report on the Audit of the Financial Statements**

#### ***Opinion***

We have audited the financial statements of Associated General Contractors of America, San Diego Chapter, Inc. Retirement Trust Fund Employee Pension Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Associated General Contractors of America, San Diego Chapter, Inc. Retirement Trust Fund Employee Pension Benefit Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### ***Basis for Opinion***

**Note 1 – Description of the Plan**

The following description of the Associated General Contractors of America, San Diego Chapter, Inc. (the AGC) Retirement Trust Fund (the Retirement Trust) Employee Pension Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of plan provisions.

**General** – The Plan is a noncontributory, defined-contribution money purchase plan established to provide pension, death, and disability benefits for employees of employers not represented by collective bargaining units or by other retirement plans. The Plan is administered by the trustees of the Retirement Trust, and the Retirement Trust is sponsored by the AGC. Employers who are members of the AGC may adopt the Plan. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended.

**Eligibility** – Employees of the participating employers are eligible to participate in the Plan upon reaching the Plan’s minimum age and service conditions. The participating employers may impose minimum age and service conditions that a participant must satisfy in order to participate in the Plan.

**Custodial change** – Effective April 30, 2024, the Plan elected to change its custodian from U.S. Bank to Charles Schwab. All assets were transferred during the period from May 2024 through July 2024.

**Contributions and contributions receivable** – The participating employers in the Plan have elected and are required to make contributions to the Plan based on amounts determined by the contribution formula selected. Each employer can also determine the type of pay on which contributions are based. In general, contributions range between 5% and 10% of compensation. The Plan has contribution receivables, which represent employer contributions that are expected to be received after year-end.

**Participant accounts** – Each participant’s account is credited with the employer’s contribution and (a) allocations of investment income, and (b) charged with an allocation of administrative expenses and investment expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** – A participant’s vested interest in employer contributions is based on the vesting schedule selected by the participating employer.

**Payment of benefits** – Pension, death, and disability benefits are equal to the vested account value from the most current valuation and are payable as a lump-sum cash distribution. Spousal consent is required for certain benefit payment elections.

**Forfeitures** – Forfeitures are the nonvested portion of a participant’s account that is lost upon termination of employment. The employers may elect first to use all or a portion of the forfeiture account to pay administrative costs of the Plan, with any remaining forfeitures being allocated to eligible participants. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$41,822 and \$26,466, respectively. For the year ended December 31, 2024, \$15,357 of forfeitures were used to reduce employer contributions.

**Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP) using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (i.e., the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

**Payment of benefits** – Benefits are recorded when paid. The Plan recorded \$26,665 for distributions paid to participants but not cleared as of December 31, 2024 and 2023.

**Expenses** – Certain administrative expenses of maintaining the Plan are paid to the Retirement Trust. Certain transaction fees and investment management fees are paid by the Plan. See further details in Note 6.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through September 23, 2025, which is the date the financial statements were available to be issued.

## Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

**Level 1** – Inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology that include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. On December 31, 2024 the Plan no longer had any investments valued at net asset value (NAV).

*Registered investment companies (mutual funds)* – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Common stock* – Valued at the closing price reported on the active market on which the individual securities are traded.

*Collective trust* – Units held in the collective trust (CT) are valued using the net asset value practical expedient (NAV practical expedient) of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a CT is calculated based on a compilation of primarily observable market information. The Plan had investments in the JPMorgan Intermediate Bond Trust as of December 31, 2023, which is a collective trust that invests mainly in securities of high- and medium-grade fixed-income securities with intermediate maturities. The CT seeks current income consistent with the preservation of capital. As of December 31, 2024 the Plan no longer had investments classified as collective trusts.

**Note 4 – Tax Status**

The Plan Document is a volume-submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently being operated in compliance with the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes (Accounting Standards Codification 740-10), management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 5 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the near term could materially affect a participant's account balance and the amounts reported in the financial statements.

For the year ended December 31, 2024, a total of four employers contributed to the Plan, with each employer's contribution ranging from 16% to 39% of the total contributions.

**Note 6 – Party-in-Interest Transactions**

The Plan pays a monthly fee to the Retirement Trust equal to an annual rate of 0.8% of the Plan's investments. The Retirement Trust fees are determined each quarter and are used by the Retirement Trust to pay legal, accounting, and other administrative expenses which benefit the Plan. Total Retirement Trust fees incurred by the Plan during the year ended December 31, 2024, were approximately \$40,464, which is included in the administrative expenses on the statement of changes in net assets available for benefits.

In addition, the Plan engages investment managers to oversee the Plan's investments. The investment management fees paid to various money managers qualify as party-in-interest transactions. Approximately \$79,540 in fees to these money managers was recorded during the year ended December 31, 2024, in the investment expenses on the statement of changes in net assets available for benefits.

**Note 7 – Plan Termination**

Although it has not expressed any intention to do so, the Retirement Trust has the right to terminate the Plan. If the Plan is terminated, amounts allocated to a participant's account become fully vested.
