Independent Auditor's Report

**To the Plan Administrator of the
BC&L, Inc. Employee Savings Plan**

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of BC&L, Inc. Employee Savings Plan an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of BC&L, Inc. Employee Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C. to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material

respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of BC&L, Inc. Employee Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about BC&L, Inc. Employee Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of BC&L, Inc. Employee Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate that raise substantial doubt about BC&L, Inc. Employee Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter- Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets Held for Investment Purposes and Schedule of Delinquent Participant Contributions as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and

other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

BC&L Employee Savings Plan Notes to Financial Statements

A. Description of the Plan

The following description of the BC&L, Inc. Employee Savings Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General. The BC&L, Inc. Employee Savings Plan (the Plan) is a defined contribution plan that became effective on January 1, 1969, and is maintained for the benefit of employees of BC&L, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Secure 2.0 Act. The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and included mandatory and optional provisions with varying effective dates in 2024, and later. The Company has until the end of the first plan year beginning on or after January 1, 2025, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Eligibility. All employees of the Company are eligible to participate in the Plan except for residents of Puerto Rico and certain nonresident aliens with no earned income from sources within the United States. Employees were eligible to participate on the first day of the month following or coincident with the completion of the eligibility requirement of two months of service for the Company.

Contributions. Participants may elect to defer up to 100% of their salary and bonuses. Participant salary deferrals are limited by the Internal Revenue Code to \$23,000 for 2024. Participants who have attained age 50 are permitted to contribute additional "catch-up" salary deferrals. Participants who do not complete a salary deferral agreement at the time of their initial eligibility are automatically enrolled with a 5% salary deferral election. A participant may designate all or a portion of his or her salary deferrals as Roth deferrals contributed on an after-tax basis. Participants are allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans.

The Company may, in its discretion, contribute an Employer Matching Contribution. The Company's matching contribution is allocated as of each payroll period to the accounts for all participants who have elected salary deferral for that pay period. The Company declared a discretionary Employer Matching Contribution for 2024 of 50% of the Elective Deferral (other than catch-up contributions) made by each participant on the first 3% of the participant's compensation. For the year ended December 31, 2024, the Company made Employer Matching Contributions to the Plan of \$231,689.

Employer Profit Sharing Contributions. The Company may also contribute, but is not required to do so, a discretionary amount to be allocated to all participants regardless of the amount of service completed during the Plan year. The Company did not declare or fund profit sharing contributions for 2024.

Vesting. Participants are immediately and fully vested in their salary deferral contributions and earnings thereon. The vested balance of the employer match and employer profit sharing contributions, if any, and earnings thereon, is based on years of vesting service completed, in accordance with the following:

<u>Years of Vesting Service Completed</u>	<u>Percentage Vested</u>
Fewer than 2 years	0%
2 years	20%
3 years	40%
4 years	60%

6 years or more	100%

A year of service is any calendar year in which the employee performs 1,000 hours or more of service. Amounts not vested at the time a participant terminates service are forfeited.

Participant Accounts. Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution and Plan earnings and may be charged with an allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Forfeited Accounts. The forfeited nonvested accounts totaled \$29,946 and \$5,198 as of December 31, 2024, and 2023, respectively. These accounts may be used to pay certain Plan expenses or may reduce Employer Matching Contributions.

Payment of Benefits. Upon termination of employment, a participant may elect to receive the value of the vested interest in his or her account in either a lump-sum distribution or substantially equal installments.

A. Description of the Plan (continued)

The Plan does not permit distributions prior to termination of service except for participants who have attained age 59½ or for hardship withdrawals in the event of immediate and heavy financial need for the purchase of a principal residence, the payment of medical expenses, payment of post-secondary education, payment of burial or funeral expenses, or payment for the cost of preventing eviction from or foreclosure on the mortgage of a principal residence.

Notes Receivables from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000, or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates.

Principal and interest are repaid ratably through payroll deductions over a period not to exceed five years, except in the case of a loan used to acquire a principal residence in which case the period shall not exceed ten years. Interest earnings on loans are allocated to the participant's account. Refer to the Plan's Loan Policy for additional detail.

Expenses of the Plan. Expenses incurred in the administration and operation of the Plan may be paid from the Plan. If not paid by the Plan, the expenses are paid by the Company. Expenses incurred by the Plan for the year ended December 31, 2024, were \$16,628. The Company pays certain other expenses incurred in the administration and operation of the Plan.

B. Summary of Significant Accounting Policies

Basis of Accounting. The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition. The Plan's investments, other than guaranteed investment funds, which are stated at contract value, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D. for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits. Benefits are recorded when paid.

B. Summary of Significant Accounting Policies (continued)

Use of Estimates. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Contributions. Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which participant compensation is earned.

Recent Accounting Pronouncements. The company reviewed all other recently issued accounting pronouncements and concluded that they were not applicable or not expected to have a significant impact on the financial statements.

Subsequent Events. The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

C. Certified Investments

Certain information in the accompanying financial statements related to certain investments held as of December 31, 2024, and 2023, totaling \$9,057,913 and \$7,414,720, respectively, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, totaling \$1,129,921 was obtained by management agreed to or derived from information certified as complete and accurate by Standard Insurance Company, Plan custodian.

D. Fair Value Measurements

The framework to measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques and used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;

D. Fair Value Measurements (continued)

- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

There have been no changes in the methodologies used at December 31, 2024, and 2023.

Pooled separate accounts: The units of pooled separate accounts are stated at fair value as determined by the issuer of the account based on the fair value of the underlying investments. Individual participant accounts invested in the pooled separate accounts are maintained on a unit value basis. Therefore, we believe they should be classified as Level 2 investments.

Guaranteed investment funds: Guaranteed investment funds are valued at contract value, which approximates fair value.

E. Investment Contract

The plan offers, as an investment option, The Standard Stable Asset D. This is available through a rider to Standard Insurance Company's group annuity contract. Contract value approximates fair value.

In addition, contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited. Any net deposits invested in the Standard Stable Asset D become part of Standard Insurance Company's general account. Also, there are no particular segregated or identifiable assets ascribed to the Plan's investment. Net deposits and interest credited become liabilities against Standard Insurance Company on the Plan's behalf. Daily liquidity is available for participant contributions and withdrawals at contract value regardless of market conditions.

Crediting rates for The Standard Stable Asset D are set by Standard Insurance Company using a process similar to that used by banks or other insurance companies for similar products. The Standard quarterly declares a crediting rate for all assets in the fund during the coming quarter. The crediting rate is declared in advance and is reset quarterly. The Standard Stable Asset D's declared crediting rate will never be below 1 percent annually.

F. Participant Directed Investments

The Plan permits participants to invest their account balance and contributions in investment accounts offered by The Standard.

G. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are invested in guaranteed investment funds managed by The Standard. The Standard is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Participant loans also qualify as party-in-interest transactions. These transactions are exempt from the prohibited transactions rules.

H. Reconciliation of Financial Statements to Form 5500

I. Tax Status

The IRS has determined and informed the Company by a letter dated March 31, 2014, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

J. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market fluctuations, and credit risks.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

K. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and distributions will be made as soon as administratively practicable after the Plan terminates.
