## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

General – The Plan is a defined contribution plan, covering substantially all employees of Golden Arch Development, LLC and Arcos Dorados Puerto Rico, Inc. (collectively "the Plan Sponsor"). The Plan was established on April 1, 1996 and it has been subsequently amended. The Plan qualifies under section 1081.01 of the Puerto Rico Internal Revenue Code of 2011, as amended (the "Code") and it is subject to the provisions of the Employee Income Security Act of 1974 ("ERISA"). Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively "Empower") is the custodian of the Plan.

Eligibility – Each employee is eligible to participate on the first entry date after the completion of 1<sup>st</sup> of year of continuous service.

Participant accounts – Participant recordkeeping is performed by Empower. Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Plan Sponsor's contributions, and an allocation of investment earnings, and it is charged with withdrawals, an allocation of investment losses and its share of any expenses of the Plan. Transaction fees charged for distributions are allocated directly to that participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Contributions – Pre-tax contributions are limited to \$15,000. Participants may contribute to the Savings Feature (after-tax) or the Deferred Feature (before-tax) of their Plan accounts. Participants may also contribute eligible rollovers from other qualified defined benefit or contribution plans and individual retirement accounts. The Plan Sponsor will make annual matching contributions to the Plan up to a maximum of 50% of the first 6% of eligible compensation. Additional profit-sharing amounts may be contributed at the option of the Plan Sponsor's board of directors. Total annual contributions made by the Plan Sponsor and participants are limited to the lesser of \$69,000, or the total compensation paid by the Plan Sponsor to a participant during the plan year, as provided by the Code, Section 1081.01(a)(11)(B)(i).

Catch-up contributions – Plan participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions to the Plan up to \$1,500 in excess of the annual \$15,000 of the eligible compensation limitation. However, these catch-up contributions will not be eligible for matching contributions by the Plan Sponsor.

Vesting – Participants are vested immediately in all of their contributions, employer match contributions and actual earnings thereon.

Benefit payments – Participant accounts are distributable upon termination of service retirement, death, disability or separation of service, a participant (or participant's beneficiary in the event of death) may elect to receive the participant's vested account balance in a lump-sum distribution, purchase of a single premium life annuity contract as defined in the Plan agreement, or elect an installment form of payment (monthly, quarterly, semi-annual or annual). In addition, participant accounts can be rolled over into an individual retirement account ("IRA") or another qualified plan.

Administrative expenses – Investment management fees and other fees related to investments of the Plan are paid from the earnings of the Plan's investments. Audit fees, legal fees, and other fees related to the administration of the Plan may be paid directly from the Plan. Other administrative expenses and some professional fees are paid by the Plan Sponsor and are not reflected within these financial statements.

Forfeited accounts – As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,739 and \$6,633 respectively. These accounts are used to pay administrative expenses, and any remaining part, to reduce employer matching contributions.

### 2) Summary of significant accounting policies:

Basis of accounting – The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates – The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition – The Plan’s investments are stated at fair value, except for the fully benefit responsive investment contract which is reported at contract value. Fair value is the price that would be received on the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

For investments in mutual funds that are registered with the Securities and Exchange Commission, fair value is determined using net asset values (“NAV”). The NAV per share of the registered investment companies is published daily and is calculated by each fund based on the market value of the underlying securities within each fund. The reported values for fully benefit-responsive investment contracts are reported at contract value.

Collective trust funds are valued based on NAV and thus are not categorized within the fair value hierarchy.

The Plan has a group annuity contract with Empower that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Net appreciation in the fair value of investments includes the Plan’s realized gains or losses and the unrealized appreciation (depreciation) on those investments. Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recognized when earned.

Payment of benefits – Benefit payments are recorded when paid.

Contributions – Participant contributions are recorded in the Plan year in which the Employer makes the payroll deductions.

### 3) Information certified by Empower (Custodian):

The following is a summary of the Plan’s assets information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan’s financial statements and supplemental schedule, that was prepared by or derived from information provided by the custodian and furnished to the plan administrator.

The custodian also certified the completeness and accuracy of \$774,942 of net appreciation in fair value of investments and \$590,467 of interest and dividends related to the aforementioned assets for the year ended December 31, 2024.

#### 4) Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The valuation techniques are based upon observable or unobservable inputs. Observable inputs reflect market data obtained from independent sources, while unobservable inputs reflect the Plan's market assumptions. These two types of inputs create the following fair value hierarchy:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the NAV of shares held by the Plan at year end. The NAV is a quoted price in an active market.

Common collective trust funds: Valued using the market approach at a net asset value per share ("NAV" as a practical expedient) determined by the portfolio's sponsor based on the fair value of underlying investments held by the fund on the last business day of the Plan's year. These are not classified in the fair value hierarchy table. The fair values are included in the table to allow reconciliation of the fair value hierarchy to the fair value of investments per the statement of net assets available for benefits.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5) Group annuity contract:

The Plan entered into a Group Annuity Contract with Empower, through a Key Guaranteed Portfolio Fund, a general account product of Empower that meets the fully benefit-responsive investment contract criteria, and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

The contract value, as reported to the Plan by Empower represents (a) contributions made under the contract plus earnings; less (b) the sum of any amounts distributed and administrative fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Based on Empower excessive trading policy, participant transfers may be restricted for up to 30 days in the event of excessive participant trading. Transactions are processed as soon as practicable after resolution of closed or disrupted financial exchanges or markets.

The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest credit rate is reset quarterly.

There is no guaranteed interest rate under this contract; however, such rate will never be less than 0%. The actual average yield earned by the Plan at December 31, 2024 and 2023 was 1.60% and 1.40%, respectively.

The Plan's ability to receive amounts due is dependent on Empower's ability to meet its financial obligations. Empower's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with Empower. Such events include (1) a complete or partial Plan termination or merger with another plan, (2) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures) that cause a significant withdrawal from the Plan, or (3) premature termination of the contract, among others. The Administrator believes no events are probable of occurring that might limit the ability of the Plan to transact at contract value with Empower and that also would limit the ability of the plan to transact at contract value with the participants.

Either the Plan or Empower may terminate the Group Annuity Contract (other than Plan termination), with advance written notice to the other party. The contract termination date shall be the seventy-fifth (75th) day, or the next Business Day, after the date written notice is received in the Empower's administrative offices, unless, prior to the contract termination date, the Plan and Empower agree to an alternate contract termination date. The Group Annuity Contract does not provide for specific events that would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value.

Upon termination of the group annuity contract, the Plan may choose one of the following options:

- Receive the payout of the fund in a lump sum at book value. If this option is selected, Empower may defer payment to a date no longer than 12 months in the future.
- Mutually agree in writing to any other payout option allowable under applicable law.

### 6) Party-in-Interest Transactions:

The Employer, Empower, Marsh Saldaña Inc., and Independent Financial Group LLC, the Plan's investment advisor, are parties-in-interest as defined by ERISA.

For the year ended December 31, 2024, the Plan maintained a spending account used to pay eligible Plan expenses. This account was funded through revenue sharing arrangements, whereby certain mutual funds provided rebates based on the Plan's investment in those funds. These rebates, which are embedded within the funds' expense ratios, are first received by the record keeper, who retains a portion as compensation for hosting the funds on its platform. The remaining amounts are credited to the plan expense account. During the year ended December 31, 2024, the Plan incurred in administrative expenses of \$73,360, reduced by \$44,878 representing revenue sharing credited to the Plan's expense account. The net administrative expenses amounted to \$28,482, as included in the Plan's Statement of Changes in Net Assets Available for Benefits.

The Key Guaranteed Portfolio (Portfolio) is managed by the custodian, who is the record keeper of the Plan. Transactions in the Portfolio are considered to be party-in-interest investments and any purchases and sales of these investments are open market transactions at fair market value.

There were no prohibited party-in-interest transactions during the year ended December 31, 2024.

### 7) Tax status:

The Plan is intended to be a tax qualified arrangement that complies with the provisions of the Employee Retirement Income Security Act of 1974, as amended, and with the Code. The latest determination letter received from the Puerto Rico Treasury Department was dated January 23, 2017, covering amendments up to October 1, 2015. The Plan Administrator and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan Administrator evaluated the tax positions taken by the Plan and concluded that as of December 31, 2024 and 2023, the Plan had maintained its tax exempt status and had taken no uncertain tax positions that would require adjustment or disclosures to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements.

### 8) Risks and uncertainties:

The Plan's investments are exposed to several risks, such as interest rate fluctuations, market volatility and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the Plan's account balances and the amounts reported in the accompanying statements of net assets available for benefits.

### **9) Plan termination:**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **10) Subsequent events:**

The Plan Administrator is not aware of any subsequent events which would require recognition and/or disclosure in the financial statements. The Plan Administrator has evaluated subsequent events through October 8, 2025, the date on which the financial statements were available to be issued.
