NOTE 1 • DESCRIPTION OF THE PLAN

The following description of the Canopy Children's Solutions Retirement Plan [formerly 403(b) Thrift Plan for Mississippi Children's Home Services, Inc.] (hereafter referred to as the "Plan") is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Plan, a single employer plan, was established on January 1, 2009 (the effective date) for the benefit of eligible employees of Canopy Children's Solutions (the "Company" or "Plan Sponsor"), which serves as the Plan Administrator. Voya Retirement Insurance and Annuity Company served as Trustee of the Plan for 2024.

The Company is a nonprofit comprehensive multi-service child and family service agency committed to developing, implementing and evaluating programs that respond to actual needs in the community throughout Mississippi.

Participation

Employees are immediately eligible to participate in the Plan as a contributing participant upon commencement of employment with the Company.

Contributions

The Plan permits eligible employees to make annual contributions of up to the maximum allowable by the Internal Revenue Service ("IRS") through a salary deferral election. All employees, both full-time and part-time, are eligible to participate in the plan and to receive employer match contributions. Employees are automatically enrolled in the Plan at a deferral rate of 3 percent of compensation unless the participant has made an affirmative election otherwise. Effective January 1, 2024, the Plan was amended to allow default 1 percent annual increases in deferral percentage up to 10 percent. Per the amendment, the plan sponsor matches one-half of each deferral percentage up to a 5 percent match.

Contributions (continued)

The Company may also elect to make an additional discretionary contribution, which is allocated to participants based on their salary deferral as a percentage of total deferrals. Participants must satisfy the same requirement noted above in order to be eligible for discretionary contributions.

There were no discretionary contributions made for the years ended December 31, 2024 and 2023.

The Plan also allows Roth 403(b) after-tax contributions. In addition, participants who are age 50 years or older are able to make catch-up contributions to the Plan. Catch-up contributions represent employee compensation deferrals in excess of otherwise stated Internal Revenue Service annual deferral limits. The IRS annual deferral limits and annual catch-up contribution limits are indicated in the following schedule:

The Plan does not allow participants to make voluntary after-tax contributions other than Roth 401(k) after-tax contributions.

Employee Transfers and Rollovers

Participants may transfer certain vested account balances from (to) certain other qualified benefit plans, subject to certain uniform nondiscriminatory rules adopted by the Plan Administrator. Rollovers represent transfers from other outside qualified benefit plans.

Participant Investment Account Options

Investment account options available include pooled separate accounts and general accounts. Each participant has the option of directing contributions into any of the investment account options selected by the Plan Administrator and may change the allocation at any time.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their employee contributions and earnings thereon. For employee's hired on or after January 1, 2024, vesting in the Plan Sponsor's portion of their contributions of their accounts plus earnings thereon is based on years of continuous service (defined as 1,000 hours or more in a plan year), as follows.

Benefits

Participants may receive all or a portion of their account balance upon termination of employment. Benefits may be paid in the form of a single lump sum or installments over a

fixed reasonable period of time. Participants may take in-service distributions from their vested balance once they have attained age 59 ½, become disabled due to a disability defined by the Plan Document or become entitled to a hardship withdrawal, as defined by the Plan Document.

Forfeited Accounts

At December 31, 2024 and 2023, there were forfeited nonvested account balances in the amount of \$41,409 and \$15,796 as of December 31, 2024 and 2023, respectively. Forfeited accounts may be used to reduce future employer contributions. For the years ended December 31, 2024 and 2023, forfeitures used to reduce Company contributions totaled \$5,861 and \$14,251, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would become 100 percent vested in their employer contributions.

NOTE 2 • SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value and any unrealized appreciation or depreciation for the year is reflected in the statements of changes in net assets available for benefits. Quoted market prices, if available, are used to value investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Transactions are accounted for on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains (losses) on investments bought and sold, as well as held, during the year.

Significant Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes therein and disclosure of contingent assets and liabilities. Significant estimates include the fair value measurement of investments. It is at least reasonably possible that the fair market value measurement of investments will change within the next year.

Risks and Uncertainties

The Plan's investments include funds which invest in various types of investment securities and in various companies within various markets. Investment securities are exposed to several risks, such as interest rate and market risks. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Plan's financial statements and supplemental schedule.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company or by use of forfeitures. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Subsequent events were evaluated by the Plan through October 8, 2025, which is the date the financial statements were available to be issued.

NOTE 3 • INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Pursuant to the provisions of 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan's independent accountants did not perform any auditing procedures with respect to the information certified by Voya Retirement Insurance and Annuity Company, the Trustee of the Plan, except for comparing the information to

NOTE 4 • FAIR VALUE MEASUREMENTS

Accounting Standards Codification Topic 820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan could access.
- Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the pooled separate accounts and general account represents the redemption values of the investments as determined by the Trustee. Net asset value is a readily determinable fair value and is the basis for current transactions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation

methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value of the Plan's investments is monitored to assess the appropriate classification of investments within the fair value hierarchy. Changes in economic conditions may require the transfer of Plan assets from one fair value level to another. The significance of transfers between levels was evaluated based upon the nature of the Plan's investments and size of the transfer relative to total net assets available for benefits. There were no significant transfers in or out of Level 1, 2 or 3 during the years ended December 31, 2024 and 2023.

NOTE 5 • RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

Certain plan investments are invested in the pooled separate accounts and general accounts managed by Voya Retirement Insurance and Annuity Company, trustee of the Plan. Fees paid by the Plan for the investment management services totaled \$71,367 and \$5,620 during 2024 and 2023, respectively.

The Company provides certain administrative services at no cost to the Plan.

NOTE 6 • INCOME TAX STATUS

In a determination letter dated March 31, 2017, the Internal Revenue Service held that the Plan, as amended, is exempt from federal income taxes. The Company and the Plan Administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 • SECURE 2.0 ACT

On December 29, 2022, the Securing a Strong Retirement Act of 2022 ("SECURE 2.0") was signed into law. Some of the retirement plan changes in SECURE 2.0 that may/will affect the Plan include:

- changes to required minimum distribution age and penalties;
- higher catch up contributions;
- emergency withdrawal flexibility; and
- matching of student loan payments.
