NOTE 1 - Description of the Plan

The following description of the The Retirement Advantage, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of The Retirement Advantage, Inc. (Company or Employer), who have completed thirty days of service and are age twenty-one or older. Eligible participants can enter the Plan on a monthly basis. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may contribute pretax elective deferrals and Roth elective deferrals to the Plan. The combined pretax and Roth elective deferrals are subject to the annual Internal Revenue Service limit. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also includes a provision for automatic pretax elective deferral contributions. The automatic deferral is 6% of compensation and applies when an employee first becomes eligible to make elective deferral contributions. Employees have the right to change their deferral percentage or elect not to make contributions. The Plan also has an escalation provision to its automatic contribution arrangement. Every January 1, eligible employees' contributions will be increased by 1% each year up to a maximum of 10%.

The Company makes a safe harbor matching contribution equal to 100% of participant contributions up to 4% of participant compensation. The Company may also make a discretionary matching contribution and a discretionary nonelective contribution. During the years ended December 31, 2024 and 2023 there were no discretionary match or nonelective contributions made.

Transfers from Qualified Plans (Rollovers)

At the discretion of the plan administrator, participants may be permitted to deposit distributions received from other qualified plans into the Plan. Such a deposit is referred to as a "rollover". Participants are always 100% vested in their "rollover" account.

Participant Accounts

Participant accounts are allocated to the various investment options offered by the Plan as directed by the participants.

Each participant's account is credited with the participant's contribution, along with an allocation of the Company discretionary matching contribution, discretionary nonelective contribution, and Plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary match contributions is based on years of service. Participants become 20% vested after completing two years of service and are vested at an additional 20% for each year of additional service up to six years of service, at which time participants are fully vested. However, upon the participant's death or disability, all amounts are immediately vested.

NOTE 1 - Description of the Plan (cont.)

Payment of Benefits

Plan benefits are available at retirement, death, disability, financial hardship, and termination of employment with vested interests. Benefits are paid using one of several available benefit distribution methods. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms generally range from one to five years. The loans are secured by the vested balance in the participant's account and bear interest at a commercially reasonable rate of interest. Principal and interest is paid ratably through semi-monthly payroll deductions.

Forfeited Accounts

Forfeited nonvested accounts are to be used to reduce Company contributions. For the years ended December 31, 2024 and 2023, forfeitures of \$53,988 and \$48,517, respectively, were used to reduce Company matching contributions.

NOTE 2 - Significant Accounting Policies

Accounting Method

The Plan's financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for further discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought, sold and held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are reclassified as benefits paid to participants based on the terms of the Plan document.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 8, 2025, the date on which the financial statements were available to be issued.

NOTE 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the quoted daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Valued based on the quoted market prices of the equity security asset holdings within the individual brokerage accounts. All equity security assets held within the individual brokerage accounts are actively traded within major U.S. stock exchanges, which are required to report their quoted closing market price on a daily basis.

Pooled separate accounts: Valued at the NAV of units of an insurance company pooled separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

Common/collective trust funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 5 - Tax Status

The Company adopted a volume submitter profit sharing plan with cash or deferral arrangement which received a favorable opinion letter dated March 31, 2014, stating that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

NOTE 6 - Information Certified by Custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's custodian, Principal Financial Group, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- 1) The investments and notes receivable from participants as reported in the Statements of Net Assets Available for Benefits.
- 2) The investment income and interest income on notes receivable from participants as shown in the Statement of Changes in Net Assets Available for Benefits.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related amounts included in the financial statements and supplemental schedule.

NOTE 7 - Transactions with Parties-In-Interest

Certain administrative expenses relating to the Plan are paid by the Company.

Certain plan investments are shares of pooled separate accounts and an investment contract managed by Principal Financial Group. Principal Financial Group is the custodian for the Plan. Fees paid by the Plan to the custodian for administrative expenses amounted to \$30,375 and \$27,859 for the years ended December 31, 2024 and 2023, respectively.

These transactions qualify as party-in-interest transactions.

NOTE 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Benefits.

As of December 31, 2024, there was one investment which individually represented greater than 10% of investment assets held. There were no investments which individually represented greater than 10% of investments held at December 31, 2023.
