## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of  
UAW-FCA-Ford-General Motors Legal Services Plan

### **Opinion**

We have audited the accompanying financial statements of UAW-FCA-Ford-General Motors Legal Services Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits – modified cash basis for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits – modified cash basis of UAW-FCA-Ford-General Motors Legal Services Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits – modified cash basis for the years then ended, in accordance with the modified cash basis of accounting described in Note 2.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. **NOTE 1 – Description of Plan**

General

The UAW-FCA-Ford-General Motors Legal Services Plan (the Plan) is a defined contribution employee welfare benefit plan that was established pursuant to an agreement between FCA US LLC (FCA), Ford Motor Company (Ford), General Motors LLC (GM) (collectively the Companies), and the International Union, United Automobile, Aerospace, and Agricultural Implement Workers of America (the UAW). The Plan provides legal services as a benefit under the 2023 national contract between the UAW, FCA, Ford, and GM. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan agreement, the trust agreement, and the rules, regulations and arrangements prescribed by the Plan’s Board of Trustees form the basis on which the legal services program is administered.

The goal of the Plan is to provide, or make available, high-quality personal legal services to eligible FCA, Ford, and GM employees, retirees, and dependents.

Eligibility

In general, GM, Ford, and FCA full-time hourly employees represented by the UAW, certain retirees, spouses, and surviving spouses who receive a pension are eligible for Plan benefits. Participants may vary based on each employer’s collective bargaining provisions.

Benefits

The Plan provides legal service benefits (office work benefit, low-cost referral to a cooperating attorney at a reduced rate, and social security disability services) to eligible participants.

Contributions

Annual contributions are made by the UAW and the Companies in accordance with the Plan agreement, which is effective through 2024. Contributions made during the years ended December 31, 2024 and 2023 are as follows:

**NOTE 2 – Summary of Significant Accounting Policies**

Basis of Accounting

In accordance with the trust agreement, the financial statements of the Plan are prepared on a modified cash basis of accounting which is a basis of accounting other than accounting principles generally accepted in the United States of America (GAAP). The modified cash basis of accounting differs from GAAP primarily because employer contributions and interest income are recorded when cash is received rather than when earned, while benefit payments and administrative expenses are recorded when cash is disbursed rather than when incurred. The modified cash basis of accounting also differs from GAAP related to the treatment of operating leases such that right of use assets or operating lease liabilities are not recorded. The financial statements therefore present cash and cash equivalents and changes therein in the form of cash receipts and disbursements. Investments are recognized at fair value, which is consistent with a GAAP basis of accounting.

**NOTE 2 – Summary of Significant Accounting Policies (continued)**

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, as well as disclosure of contingent assets and liabilities, at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Investments

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). Investments in money market funds are valued at quoted market prices, which represent the net asset value of units held by the Plan as of the end of the year. Purchases and sales of securities are recorded on a trade-date basis.

Fixed Assets

Fixed assets are recorded at cost or, if donated, at fair value on the date of the donation. Depreciation and amortization are computed on the straight-line basis over the estimated useful lives of the related assets or, for leasehold improvements, over the life of the related lease agreements, which range from three to five years. The Plan's policy is to capitalize acquisitions of \$500 or more.

Concentration of Credit Risk

Financial instruments which potentially subject the Plan to concentrations of credit risk consist principally of cash and money market funds.

The Plan maintains its cash balances and investments at one financial institution. The balances are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 in any one bank. At times during the year, balances on deposit in any one bank may exceed the insured amount. There were no uninsured balances as of December 31, 2024 and 2023. The Plan has not experienced any losses with respect to uninsured cash balances. The Plan's money market fund balance is invested with one fund.

Legal Service Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

Costs and expenses of the Plan are paid by the Plan.

Subsequent Events

Subsequent events were evaluated through the date of the auditor's report, which is the date the financial statements were available to be issued.

**NOTE 3 – Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The 3 levels of the fair value hierarchy are as follows:

Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that a reporting entity has the ability to access at the measurement date or published net asset value for alternative investments with characteristics similar to a mutual fund.

Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3 inputs are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Mutual funds:* Valued at a unit price calculated daily based on the closing price reported on the active market on which the individual funds are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realized value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 7 – Pension Plans**

The Plan operates two defined contribution pension plans under section 401(k) of the Internal Revenue Code (the “Code”), one for the benefit of its union employees and one for the benefit of its non-union employees. Under these 401(k) plans, eligible employees are allowed to contribute up to a percentage of their compensation up to the maximum allowed by federal law, while the Plan contributes a percentage of employees’ compensation authorized by the Board of Trustees. Catch-up provisions also apply to these plans. The Plan’s contributions to these 401(k) plans totaled \$431,428 and \$422,501 for the years ended December 31, 2024 and 2023, respectively.

**NOTE 8 – Income Tax Status**

The trust funding of the Plan has received an exemption letter from the Internal Revenue Service dated September 28, 2017 stating that the trust is tax-exempt under the provisions of section 501(c)(9) of the Code as a Voluntary Employee Beneficiary Association. The Plan and the trust are required to operate in conformity with the Code to maintain the tax-exempt status of the trust. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, the trust is tax-exempt. In addition, the Plan administrator is not aware of any uncertain tax positions or unrecognized tax benefits as of December 31, 2024 or 2023. No provision for income taxes has been included in the Plan’s financial statements.

**NOTE 9 – Termination**

The Plan may be terminated at any time in writing by the trustees with a copy of such written instrument to be provided to the trustee. Upon termination of the Plan, the assets of the Plan shall be paid out at the direction of the trustees in the following order of priority: (a) the payment of reasonable and necessary administrative expenses (including taxes); (b) the payment of benefits to participants entitled to payments for claims arising prior to such termination; and (c) at the discretion of the trustees, used in accordance with Section 501(c)(9) of the Internal Revenue Code and ERISA, for the benefit of participants in such fashion as the trustees determines.

**NOTE 10 – Reconciliation of Financial Statements to Form 5500**

Net assets available for benefits reported in the financial statements and the amounts reported on Form 5500 are the same as of December 31, 2024.

The net increase in assets reported in the financial statements and the amounts reported on Form 5500 are the same as of December 31, 2024.
